Detroit Steelheaders to Partner with the CPMR

The Coalition to Protect Michigan Resources, by unanimous vote of it's Board of Directors, has ratified the Detroit Area Steelheaders as an associate 'Class B' member. The DAS joins the ranks of member organizations currently represented by the Coalition. Our acceptance was based on previous contributions we have made supporting Consent Decree negotiations. The CPMR has been working intensely for almost two years with the State and other parties, negotiating the successor to the 2000 Consent Decree. Successful negotiations will ensure a fair and workable outcome of results for Michigan sportsmen. For the past 20 plus years, the current agreement protected state and tribal fisheries, and eliminated most gear conflicts in the 1836 Treaty Waters. Nearly one half of Lakes Michigan, Huron and Superior fall under this jurisdiction.

In negotiations the CPMR is represented by attorneys Steve Schultz and Christopher Patterson. Their legal expertise on this issue, and their extensive knowledge in negotiating, is highly regarded. DAS members might recall the presentation Chris made at one of our membership meetings. Chris and Steve have an unprecedented involvement and grasp of issues at stake in these negotiations. Steve Schultz's involvement in the issue goes all the way back to the Judge Fox Decision in 1979. Both attorneys understand the issues that must be incorporated into the new agreement that will allow sport fishing men and women to continue enjoying Great Lakes fishing that supports businesses throughout the state.

Because of the nearly countless meetings and the apparent long process ahead, the Coalition to Protect Michigan Resources cannot complete this challenge alone. Tony Radjenovich, the CPMR President says "We need not only the expertise and input from organizations like yours, but also from the sport fishing men and women of Michigan, and related businesses. We all need to come together to fund this effort. CPMR is willing and able to work with your organization on any type of fundraising event, Zoom meeting or conference call to raise funds, inform your members and answer their questions. If the CPMR is left on the wayside because of lack of funding, the sport fishing community will no longer have a voice in the management and sharing of the Great Lakes fisheries."

The DAS board believes the future of the great lakes recreational sport fishery is intertwined with a successful outcome to the Consent Decree negotiations, and has made a sizable commitment to that end. We are proud to have been recognized for our role. DAS members Mark Williams and Blaise Pewinski will represent the DAS at CPMR meetings. While their roles are limited, we will be provided updates of the negotiation's. A background of the negotiations appears on page three of this issue.

Consent Decree Negotiations with Michigan's Tribes - Some Background

This is the first in a series of updates that we will be posting to let those interested in the sport and commercial fisheries of the Great Lakes know what is happening in the negotiation of a new agreement between the State, the Federal government and the five Michigan tribes holding a Treaty right to fish in the Michigan portion of the Great Lakes. This update is presented by the Coalition to Protect Michigan Resources, an association of sportfishing and natural resource organizations that is participating in the negotiations.

Many are aware of the effects of the Treaty of 1836 and the right to fish the Great Lakes that it grants to five Michigan Tribes. For the uninitiated, though, this first update will give you a very brief background on how we got to where we are today. This background will be brief because the issues we currently face have been around for more than 50 years and books have been written that tell the history of the current issues.

Today, several facts are established regarding Tribal fishing in the Great Lakes: First, for almost 40 years, the law has been established that treaties negotiated between Michigan's tribes and the Federal government reserved to five Michigan Tribes, the right to fish commercially with whatever gear they wished in the waters of the Great Lakes from Grand Haven north in Like Michigan, from roughly Alpena north in Lake Huron and from roughly Munising east in Lake Superior.

Second, the Tribes' right to fish is not unlimited. At a minimum, conservation needs limit tribal fishing activity. In addition, since 1985, there have been two agreements between the State, the Federal government and the five Tribes that set forth limits on all users of the Lakes, including limitations on the amount of catch, and the kinds of fishing gear and the areas where particular gear can be used. These agreements also provide for communication between the parties on a regular basis, coordination of law enforcement and the exchange of information. The first agreement was negotiated and became effective in 1985. It had a 15 year term. The second became effective in 2000 and had a 20 year term. The second agreement has been extended by the Federal Court to June 30, 2021 while the parties try to negotiate a new agreement.

Third, no one can deny that the fishery resources in the Great Lakes have been changing in the past few years. These changes have many possible causes, but the fact is that the Lakes' fishery stocks are not what they were 10 years ago.

Against this background, the parties have been in negotiations toward a new agreement to share the Lakes' fishery since last September. Due to the Covid pandemic, however, those negotiations have been conducted via Zoom and phone conversations. This has greatly affected the effectiveness of what negotiations we have had. You should also be aware that all parties, including the Coalition, have agreed to not to "disclose any proposal, response to a proposal, or the substance of any discussion [among the Parties]" Thus, we are somewhat limited in what we can share publicly.

Though we cannot discuss with you the Parties' discussions or proposals, a look at the agreement that has governed the relationship of State licensed and Tribal fishers for the last 20 years can give you a good idea of the things that are at issue now. Those include agreements on the areas of the Great Lakes where gill nets and trap nets can be fished by the Tribes, the species of fish that may be commercially targeted, and the limits on the catch of various species such as whitefish, salmon, lake trout and walleye, among others. A review of the Table of Contents of the "2000 Consent Decree" gives a good outline of the issues and complexity of the fishery and the Treaty right. The event concluded with a shore lunch of coney dogs, salty pretzel's, and cookies followed by the event prize of ice fishing rod/reel combo won by Nate Case Jr. The 2021 AOTY leaders after the first outing are Gapare Aragona with one point, Nate Case with two points and Mark Piasecki with three points. We have twelve more AOTY outings before we wind up the season in Caseville in December so its far from over. The next opportunity is this Saturday February 6 at 7:00 am at the Selfridge DRN ramp fishing out on Anchor Bay in Lake St. Clair. Come out and join us on February 6.

Tips n' Tricks - Trailer Boat Toolkit

Having a few tools on the boat can salvage a day on the water. Start with the basic essentials. By Mark Corke

When your boat breaks down, having a basic toolkit on board could make the difference between a minor irritation and pulling the plug on the day and calling BoatU.S. for a tow. Although it's difficult to plan for every eventuality, being ready with some basic tools could make you a hero. Most boaters will likely have a few ideas of their own, so use this list as a starting point and build from there. This is not a comprehensive tool kit (feel free to add your own widgets), but simply a basic compendium of tools for first aid maintenance.

Mirror on a stick

Enables you look into places that would otherwise be inaccessible to the naked eye.

Pliers

Perfect for tasks such as removing cotter pins from the propeller nut, and for other times that require a firm grip. Also add needle nose, water pump, and vice-grip pliers.

Fuel filter

So it's not really a tool, but its vital to the health and well being of your boat engine, and you should always have at least one spare handy. You might want to include an onboard engine prefilter and water separator filter if these are fitted to your boat.

Hacksaw

Not just for cutting metal, it can also saw through wood and fiberglass in a pinch.

Caulking

Great for temporary fixes of leaking deck fittings. Can be purchased in an assortment of colors, so pick one to suit your boat finish. Some cure underwater.

Multi-tool

Rags

If you carry only one tool, then a good multi-tool should be it. Includes pliers, file, screwdrivers, knife, small saw, and seemingly a tool for every problem.

You'll never regret keeping a selection of rags on board to make cleaning up messes a snap. Microfiber cloths are the perfect choice for wiping down chartplotters and instrument displays without damage.

Oil-absorbent pads

Helps prevent oil and fuel spills from finding their way into the bilge, or the water.

Spray lubricant

Can be used for everything from freeing corroded fasteners to spraying a protective film on the engine. Follow manufacturer recommendations.

Wire strippers/crimping tool

Hopefully you won't be doing any heavy-duty wiring jobs offshore, but a set of wire cutters with a built-in crimping tool and a few spare crimp connectors means you can always make lasting connections.

Flachlight

Essential for finding that errant nut and washer that you just dropped into the bilge.

Wrenches

At the very least, stash the wrenches that came with the motor onboard. You might want to add a couple of other frequently used sizes. An adjustable wrench is handy, too, but can be a tight fit in many places.

Allen wrenches

These come in both metric and standard sizes. Choose the type that fits your engine.

Hose clamps

Again, not really a tool, but they take up so little space in the toolbox that it seems silly not to have a few, and they could save your day if one fails. Bonus: A large hose clamp tightened around a spin-on filter can provide extra grip, but don't cut your hands.

Adhesive tape

There are literally thousands of uses for tape. I once sailed all the way across the Atlantic with the head held in position with duct tape!

Fuses

A blown engine fuse could be all that's preventing your engine from cranking over or your VHF from turning on. Make sure you carry a selection of sizes. Check your owner's manual; you may require a size or type that's particular to your engine. Blown fuses may mean an electrical problem, so address it when back at the dock. And never use a fuse with a higher rating than what you're replacing because it could damage the circuit.

Marker

Good for a myriad of uses, from marking the change date on fuel filters, to permanently labeling cables.

Screwdrivers

Carry a mix of sizes in both flathead and Phillips style. Don't forget stubby ones for confined areas.

Toolbox

The extra money spent for a good waterproof toolbox is never wasted. It'll keep your valuable tools dry, in one place, and prevent them from corroding.

Nut drivers

This screwdriver-type of tool is designed for tightening nuts and bolts without a ratchet. Carry some of the most-used sizes in both standard and metric.

Multimeter

Indispensable for tracking down electrical faults, tracing live circuits, and testing the state of charge of the battery.

Hammer

A small ball-peen hammer takes up little room in the toolbox. Good for everything from getting an ornery fastener to move to cracking lunchtime walnuts.

Magnetic retriever

Drop a screw or other fastener in the bilge, and you'll be glad that you included this in the toolbox.

Disposable gloves

Keep grease and dirt off your hands, then just peel them off your clean hands.

TIP To keep tools and prevent them from going rusty, spray them with a little WD-40 and store in an airtight box.
