Subject: 2026-2027 Registration

It is our policy to give preference to our present 3's classes when registering for the next school year. To ensure your enrollment for next year, <u>please complete the attached registration form and return it with a \$125 non-refundable registration and activity fee to the Triple C office at your earliest convenience.</u>

There are 2 options for our 4's program next year!

We will have 1 class that will run normal time 9:15- 11:45 Mon, Wed & Fri. **OR** 3 classes will have extended hours. 9:15- 1:00 Mon, Wed & Fri.

2026-2027 tuition payments will be made in 10 installments beginning August 1st.

4's annual tuition = \$2,300 Payable in 10 monthly installments = \$230.00 4's Extended annual tuition = \$3,050 Payable in 10 monthly installments = \$305.00

Children who will be 5 by November 30th *may* be eligible for our Pre-K Enrichment class which meets Mon-Fri from 9:15am-1:00pm.

Pre-K annual tuition = \$4,850 Payable in 10 installments = \$485

**Director/ teacher approval is required prior to registration.

If you have *another* child to sign up for Triple C next year, call or email us so that we can register you early.

3's annual tuition = \$1,650 Payable in 10 monthly installments = \$165.00 On My Own annual tuition = \$1,300 Payable in 10 monthly installments = \$130.00
