
Self-guided hike through Hisey and Caesar Creek Gorge where we provided trail maps and marked the course.

# 2024 Naturalist Report

Our biggest announcement of 2024 is that we hired a second part-time naturalist, **Lauren Asquith**, to help support our growing nature programming efforts. Lauren comes to us with over ten years of experience as a professional naturalist at Five Rivers Metroparks and she has brought fresh ideas and new energy to our team. We are so excited to have her on board!

The creation of a **Strategic Plan** is our second big announcement this year. Under the leadership of CEO Matt Latham, and with input from hundreds of patrons, park staff, focus groups, and a steering committee made up of community leaders, we now have a clear plan for the future of WCPD, with themes of **Conservation, Recreation, Education, and Operation.** This Strategic Plan will help shape our park district over the next five to ten years and will provide invaluable roadmap for how to achieve our goals.

Finally, as a capstone to 2024, WCPD just successfully launched a **NEW Park District Website!** This digital transformation marks a major leap forward for the Park District in delivering timely, user-friendly information for nature lovers in the region. Highlights of the New Website include an Interactive Park Map, Event Calendar, and Mobile-Friendly Design. Start planning your next experience in the great outdoors at www.WarrenCountyParks.com.



In 2024, we hosted **83 programs/events**, and had **8,299 in-person interactions** with the public! In addition to programming at WCPD locations, one of our long-term goals is to reach areas of the county that we currently do not have WCPD properties, so this year we expanded our partner programming to include on-site events at the Warren County Fairgrounds, Deerfield Township's Kingswood Park, Miller Ecological Park in Lebanon, and the City of Franklin! Naturalist Lauren also began doing children's programs at libraries across Warren County and introduced "Toddler Treks" to our list of offerings.

It would be impossible to achieve so much without our dedicated supporters. Ohio Certified Volunteer Naturalist Kathie Bowers helped us expand our invasive species removal efforts and native sapling plantings. She also led a series of Winter Workshops at Armco Park and a "walk and learn" spring hike series at Hisey Park, as well as a series of Winter Workshops at Armco Park. OCVNs and Friends of WCPD were instrumental in helping us pull off our annual Cops & Bobbers Fishing Derby, our ever-popular Tech-Free Tuesday programs, and Hisey Fall Festival! Thank you to the Friends of Warren County Park District for supporting these activities through your contributions and volunteering!

74% of our programs and events were held in coordination with **community partners**, and 37% of our outreach efforts were assisted by **volunteers**. Our volunteers tallied over 580 hours this year, and this does NOT include self-led efforts of Eagle Scout projects, the Cincinnati Off-Road Alliance (CORA), Warren County Astronomical Society, or the behind-the-scenes work of the Friends of Warren County Park District. We are so grateful for your assistance in sharing our wonderful Park District with the public!



Coming in 2025: Our nature programs continue to be a highlight of the Park District, and they are growing more every year. In 2025 we hope to introduce additional programming as well as opportunities to participate in new adventures with community partners!
