Firearms Act 1968

It is an offence for a person who is prohibited by Section 21 of the Firearms Act 1968 to have a firearm or ammunition in his/her possession at any time. This includes air rifles and air pistols. Section 21 applies to any person who has been sentenced to imprisonment or to youth custody or detention in any young offenders institution for three months or more. This includes a suspended sentence. A person sentenced to a period between 3 months and 3 years is prohibited for 5 years from the date of release. A person sentenced to 3 years or more is prohibited for life. It is an offence for a person to transfer, let, hire, or lend a firearm or ammunition to someone whom he or she knows or has reasonable grounds for believing to be a prohibited person.

- I am not a prohibited person in regard to Section 21 of the Firearms Act 1968 as detailed above
- I am of sound mind and health and know of no medical reason that would make me unfit to use a firearm.
- I agree to abide by the club's rules and to pay the annual subs as due within the specified time. The amount and period will be made known at the time they are due.

Important: General Data Protection Regulation (GDPR)

Ledbury Rifle and Pistol Club needs to hold some personal details on their members for efficient running of the club. The information we hold is kept to an absolute minimum. All of the information that we hold is given by each member by the application forms, club or competition, attendance records and updated from email or verbally. This information is currently held on two databases. One is for membership the other for those who participate in competitions. The information collected and used is but not limited to:

Contact information such as Names, Addresses, DoB, means of contact, whether you hold an FAC and its issuing authority. We are also obliged by the Home Office and West Mercia Police to hold attendance records. We also collect and hold data on subscriptions as in who has paid what and when. In addition, we collect and hold data on competitions such as results and fees paid.

The personal information that the club hold on you will be maintained by the members of the club's committee. This information is stored electronically on a PC and on a backup media held securely. Information may be shared within club members for club use only. The information will also be passed to the Police as we have an obligation to inform them of details of all club members, we are also obliged to inform them when you leave the club. Some information is passed to competition bodies for the administration of those competitions. We also pass this information to our affiliates the NRA, NSRA & UKPSA who provide our insurance and other benefits for the club member. Other than these your information will not be passed to any other entity without your prior permission. The information you provided will be deleted within 3 months of you leaving the club. You are entitled to see any information kept on you by applying, in writing, including email, to the membership secretary.

On 30th April each year, all memberships expire and new subs are **due with 1 calendar month of being requested.** This is usually in May, after our AGM, but may change depending on club circumstances. Failure to pay on time revokes full membership, Application process starts again. You will go to the bottom of the waiting list. The police are informed and this may affect your Firearms Certificate.
