



**TROOP #126 RELEASE AND HOLD HARMLESS AGREEMENT (Revised 2021)**

I understand that participation in Scouting activities involves a certain degree of risk and can be physically, mentally, and emotionally demanding. I have carefully considered the risk involved and have given consent for myself or my child to participate in weekly scouting, camping and other activities for the year 2021. I also understand that participation is entirely voluntary and requires participants to abide by applicable rules and standards of conduct. I release Paul Fowler, Scout Master and NRA Training Counselor, Troop #126, and its committee members, the activity coordinators, volunteers, including other organizations associated with the activities from all claims or liability arising out of participation in scouting and related activities.

In case of emergency involving MY CHILD, I understand every effort will be made to contact me. If I cannot be reached, I hereby give my permission to the medical provider selected by the adult leader in charge for treatment, including hospitalization, anesthesia, surgery, or injections of medication for my child. Medical providers are authorized to disclose to the adult in charge examination findings, test results, and treatment provided for purposes of medical evaluation of the participant, follow-up and communication with the participant's parents or guardian, and or determination of the participant's ability to continue program activities.

Permission is granted for my son to participate in Summer camp, shooting sports, water sports, horseback riding, hiking, canoeing, cycling, camping, cooking, fire building, using knives, axes, and other activities related to scouting and summer Camp, for the year 2021 and forward, until this letter is revoked and rescinded in writing.

Recipient waives, releases and forever discharges all claims against any of the RELEASED PARTIES for any injuries, damages, losses or claims, whether known and unknown, which arise during or result from any activity of or services provided by any of the RELEASED PARTIES under or in connection with the scouting program, summer camp or traveling to or from said activities, including but not limited to any such injury, damage, loss, or claim arising from any scouting or any other services provided.

Recipient agrees to indemnify and hold the RELEASED PARTIES harmless from all losses, liabilities, damages, costs or expenses (including but not limited to reasonable attorneys' fees and other litigation costs and expenses) incurred by any of the Released Parties as a result of any claims or suits that Recipient, anyone claiming by, under or through Recipient, or any third party, may bring against any of the RELEASED PARTIES to recover any losses, liabilities, costs, damages, or expenses which arise during or resulting from the participation by, or services supplied by, any of the RELEASED PARTIES in Tremonton Troop #126, its leaders, and its committee members, except only to the extent caused by the gross negligence or other fault of any of the RELEASED PARTIES.

Recipient acknowledges having carefully read and reviewed this Waiver, Release and Hold Harmless Agreement, and recipient represents that it fully understands and voluntarily executes the same.
