Roll Call: Vonda, Kathy, Ricky, James, Michael, Brandie, Jacqi, Ivorie and Jenny present on call. Eddie, Mary, and Jennifer not on the call.

Board Reports:

- Treasury Report: Bank Balances: Total \$133,733.12 (\$106,484 in the Chapter Account and \$27,249.12 in the Conference Account). Flowers were sent to Manatee County 911 for the loss of PST Karen Kraus and Rockledge PD for the loss of PST Michael Dillon.
- Secretary Report: Current Membership is 3167, 30 new members since August 1, 2021.
 - o Updates from Trae and Brandie. Both are doing well and progressing through their RPL courses.

Committee Reports:

- ProCHRT: Vonda reported that there was a lot of discussion about reclassification at the conference in Texas.
- Training: James advised they have a meeting next week. Nothing current to report.
- TERT: Ivorie provided an update on the dispatchers that responded to assist in Louisiana. Vonda reported that she would like to recognize the 10 Florida TERT members for their service and hard work during their recent deployment. She is working with NENA leadership to share costs for this. Each participate will be receiving a certificate, chapter coin and shirt. Ricky will order the shirts.
