  - c) HEREBY RELEASE WAIVE, DISCHARGE AND CONVENANT NOT TO SUE THE HEART OF TEXAS KART CLUB as an association including its corporate, elected and appointed officials, all members of communities, referees, and inspectors, its individual members, its members clubs agencies of government which control essential lend sites, financiers and firms which render essential service gratis, including all officers, agents, and employees the foregoing volunteer workers assisting in sanctioned Heart of Texas Kart Club race and time trial activities, all hereinafter referred to as "Releasees" from or for any and all liability to me, my personal representatives, heirs, next of kin, successors and assigns, for all loss or damage for bodily injury, death or damage to property of the undersigned which in any way grows out of or results from any Heart of Texas Kart Club race or time trial activity or part thereof, during the actual sanction period and whether any such claim may be based upon alleged active or passive negligence whether caused by the release or otherwise, or participation in duty the wrong, or upon any alleged breech of any statutory or obligation, and
  - d) HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releasees or otherwise.
  - e) HEREBY ASSUME FULL RESPONSIBILITY OR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE due to the negligence of releasees or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for, or for any purpose participating in the event.
