MAGA Membership fee:

- New this year
- \$50 fee
- Gives you access to insight for the year
- Will need to be paid before you have access to insight
- Next year will need to be paid before September 1st

Trusted Coaches:

- Need to upload certificates to insight for any coach on the competition floor
- If you do not have certificate and compete there will be fines for both offender and hosting team
- The meet will be invalid
- First offense is \$100, Second is \$200, 3rd you are banned from competing for the remainder of the year

Meet Genie:

- Available on insight to help manage meets and fees
- Create a meet and invite teams
- Transactions for meet fees done right through meet Genie

- Justin collects fees and pays the hosting gym directly

Meet Standard:

- Meets should be on insight 1 month in advance of meet date
- Teams must pull out at least 2 weeks in advance or responsible for the meet fees

Hall of Fame Committee: (looking for others that would like to be on the committee)

- Make nominations by Jan 15th
- Judges must have 15 years' experience
- Coaches must have 15 years' experience
- Also, and non-judge/coach option
- Banquet is held in May

Registration deadlines:

- October 1st registration opens
- October 15th first day allowed to compete
- November 30th last day to register without late fee
- Dec 15th last day to register for the season
- You may petition to register after that date on a gym-to-gym basis, must be a valid reason to be this late
- Late fees for registering after November 30th is \$10/gymnast, \$20/team
- February 21st last day to host meet that count toward end of season averages
- March 5th-26th weekends are division dates
