  - c. Motion: Any club with a Gymnast in violation of DUAL COMPETITION RULE will be fined
    \$1,000 each occurrence and will be put on probation for two years. No team or athlete from

- violating club will be permitted to compete in MAGA until fine is paid (Handled through INSIGHT). A club on probation found in violation of this rule will be additionally fined for each occurrence and suspended from all MAGA competition for the remainder of the season.
