

Entry Rules and Conditions

1. All entries must include: A completed form with your preferred email address, a non-refundable fee of **\$30** for up to 3 entries payable to the Downtown Art Place.
2. Artist's name and title of work must be securely attached to the back of the artwork.
3. Work will be judged from jpeg images (300 dpi) on CDs, USB drives or digitally submitted only. Digital files must be labeled with the artist's name, title of work and dimensions. The DAP is not responsible for damaged CDs or USBs.
4. All artwork accepted must be ready to hang. Art work should be framed using screw eyes and wire. No sawtooth hangers, clips or brackets will be accepted. Works bigger than 16" x 20" should have plexiglas. Maximum frame size is "40 x 40".
5. Artwork accepted by the juror must be delivered to the DAP by **July 1-3, 12:00-4:00 p.m.**
6. Work may be picked up **August 20-25, 2019**. If this is not possible, please make arrangements with the Downtown Art Place.
7. Entry of artwork into this exhibit implies an agreement on the part of the artist to comply with all the conditions stated on this prospectus.
8. The Downtown Art Place is not responsible for Packing materials left after delivery.
9. Incomplete and/or incorrect entries will not be considered.

Awards and Sales

All awards will be announced by email. If artwork is sold, it must remain in the show until **August 18, 2019**. The DAP will take a 30% commission on all sales.
