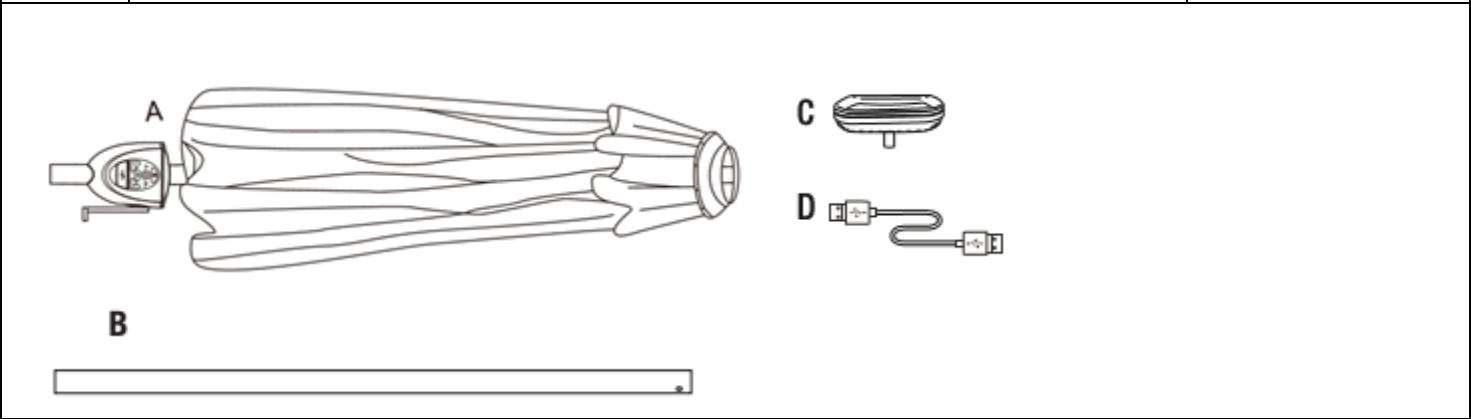
Pre-Assembly

PLANNING ASSEMBLY

To prevent damage, place all parts on a soft surface during assembly:
Do not leave it unattended if not fully assembled even if bolted to the ground.

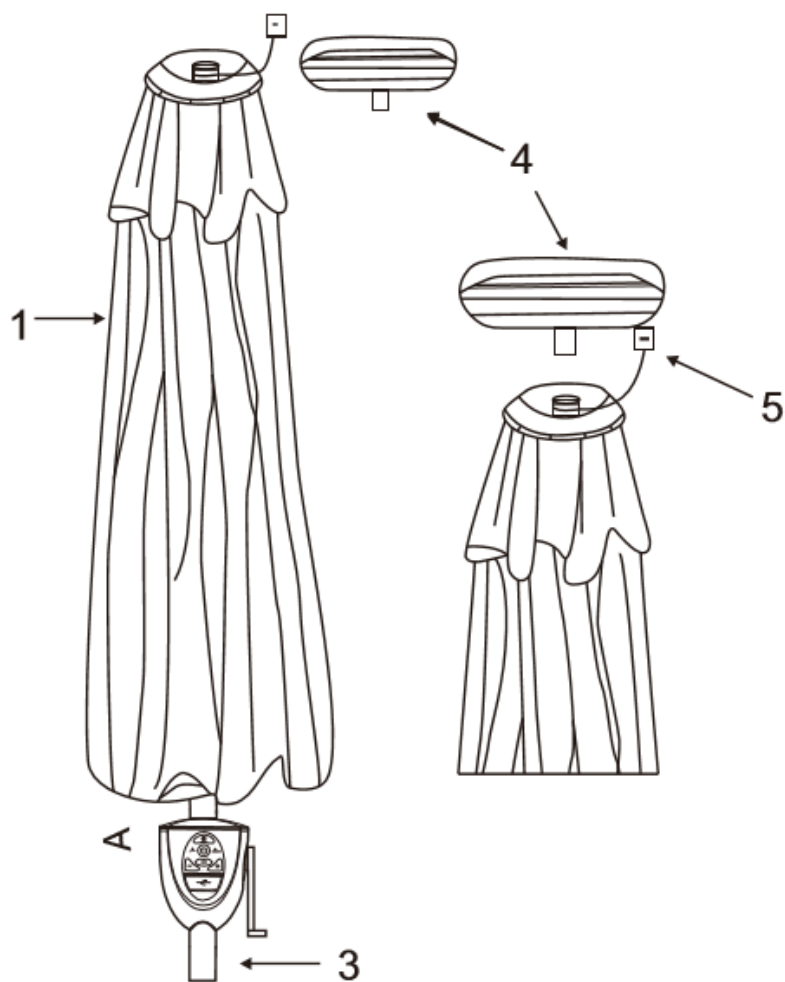

Assembly instructions

1 Assembling the Umbrella

- ☐ Take out the bottom tube (2) and the umbrella body(1) from the bag
- ☐ Twist the lower umbrella pole (2) into umbrella (3)
- ☐ If your model shipped with the solar panel (4) packed separately (not attached to the umbrella), match the electronic connector from the solar panel with the electronic connector located at the top of the umbrella (5). Then insert and twist the solar panel into the top cap to lock.
- ☐ Place the umbrella upright in a heavy weighted stand (not included), and table capable of firmly securing the Umbrella.

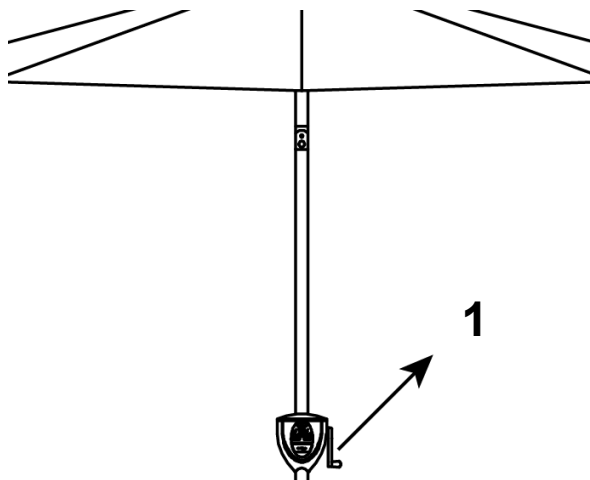


CAUTION: Do not insert the end of the umbrella pole into the ground. The solar umbrella is designed to be used with an umbrella stand (not included).

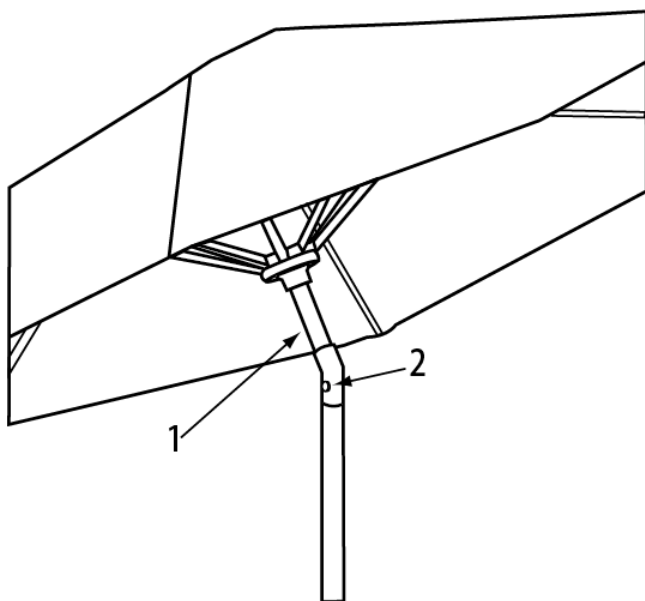
2 Adjusting the Umbrella Up & Down

- ☐ Using the crank handle (1), raise the umbrella to desired height. Turn the crank handle (1) clockwise to open the umbrella.



3 Adjusting the Umbrella Tilt

- ☐ Hold the umbrella pole (1) above the tilt button, and press the tilt button (2) inward.
- ☐ With the tilt button pushed inward, move the umbrella to the desired position, then release the button to lock in place.



Assembly instructions

4 Charging the Battery using the USB Power Adapter

- ☐ Connect the micro USB cable to the charging port on the Speaker.
- ☐ Connect the USB plug end of the cable to a powered USB port on a computer or other USB charging device (not included) or AC power adapter then to an electrical socket directly. A steady Red light (c) indicates the battery is charging and steady Green light when unit is fully.



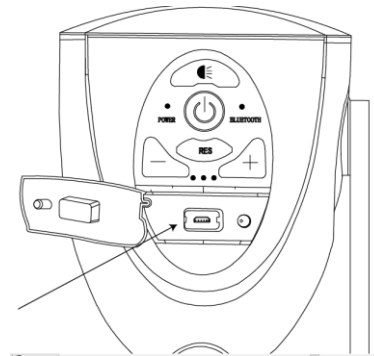
WARNING: Use product with supplied 3.2v - 3.7v / 4000mAh LiFePo battery pack only. Use of any other batteries may create a risk of fire.



Note: For first time use, charge unit for about 8 hours. USB charging device (power adapter) with a rated output of between 1 – 7.5 Watts is recommended. The lower the output the longer it will take to charge battery.



Note: Before operating, the batteries need to be fully charged. The batteries may require up to 8-hours of full sunlight and AC adapter(not included, only provide USB charging cable.)



5 Charging the Battery using the Solar Panel

- ☐ Place the fully assembled solar umbrella in full sun where it will receive direct sunlight for at least 8 hours per day



Note: The number of hours of LED light output and sound output is directly proportional to the number of hours of sunlight it receives. The solar panels cannot recharge the batteries if light is obstructed.



Note: Can use about 4 hours for music play and LED lights when fully charged. If out of power, use the solar panel to charge the batteries for about 1 hour then open the LED lights and music.

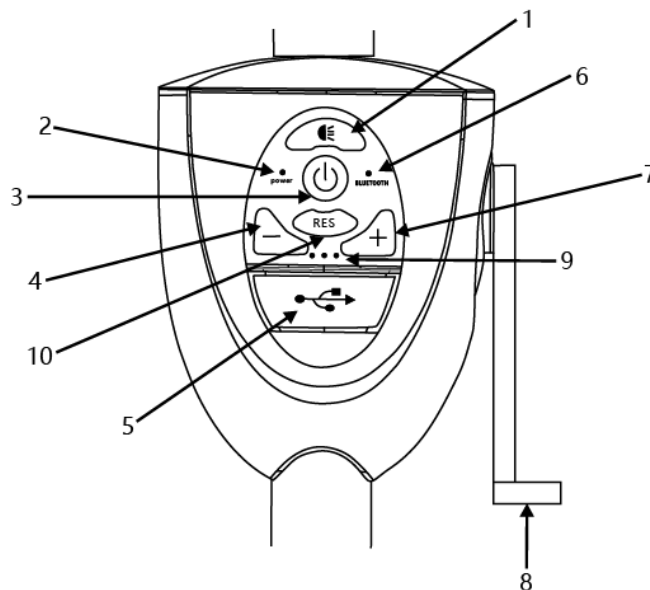


Operation

1 Using the Controls

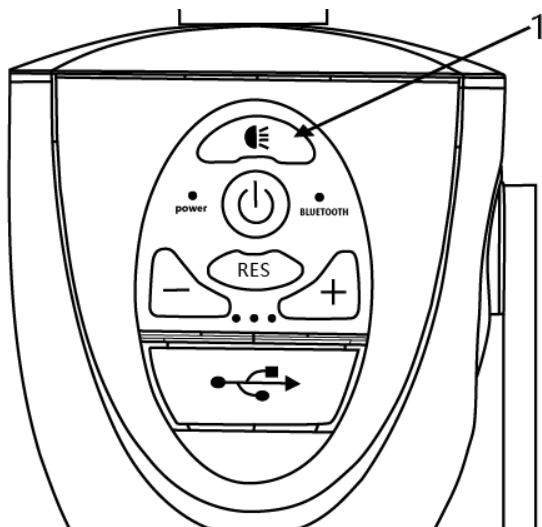
Function of the buttons on the crank housing:

1. LED Lights “On/Off”
2. Power Indicator Light
3. Bluetooth® “On/Off”
4. Volume Down (-) Button
5. USB 5v DC Power Port
(for charging portable device – electrical power only – no data transfer)
6. Bluetooth® indicator light
7. Volume Up (+) Button
8. Canopy Crank Handle
9. Battery indicator
10. Reset Button



2 Turning the LED Lights On/Off

- ☐ Press the LED lights “On/Off” button (1) to activate the LED’s. Lights will toggle On/Off each time the button is pressed.



3 Using the Bluetooth® Audio Speaker

This product is designed to provide high quality wireless sound for your iPad, iPhone, iPod, computer, PDA or other Bluetooth® audio device.

Pairing a Bluetooth® Device with Your Speaker

- ☐ Press the Bluetooth® On/Off button (3) to turn on the speaker. The Power indicator light (2) will illuminate. Bluetooth® indicator light (6) will start blinking slowly. You are ready to pair your device. Battery indicator (9) will change colors when charging:

Indicator Color	Battery Charge Status
Red	< 20% charging immediately
Yellow	20% – 60% charge
Green	Above 60% charge

- ☐ Go to the Bluetooth® Manager of your Bluetooth® device. Search Bluetooth® devices and select “Music Umbrella” to start connecting.
- ☐ Enter “1234” if your device asks for the Password code.
- ☐ Once paired, the unit will beep and the Blue LED light will turn on steadily.
- ☐ To turn Off the Bluetooth® speaker, press and hold the On/Off button (3) for approximately 5 seconds

Operation (continued)

4 Using the Bluetooth® Audio Speaker

Connecting a Paired Bluetooth® Device

- ☐ You should only need to pair your Bluetooth® device with your speaker one time.
- ☐ The next time your Bluetooth® device and the speaker are in range of each other, and the Bluetooth® feature is turned on, they should automatically connect.
- ☐ The unit will only automatically connect to the last Bluetooth® device it was connected to.
- ☐ If your paired device does not automatically connect, navigate to the Bluetooth® menu on your device and select “Music Umbrella” from the list.
- ☐ Press the RST button (10) for 3 seconds to cut off current Bluetooth® connect.

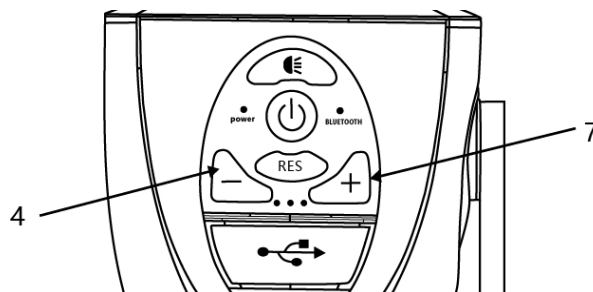


Note: RST can clear original saved data to enhance Bluetooth® connect sensitivity.

5 Using the Bluetooth® Audio Speaker

Playing Audio from Your Bluetooth® Device

- ☐ Once your media device is paired with the speaker, simply start playing music, a movie or game and all the audio will automatically be played through the speaker.
- ☐ Press Volume Up + (7) or Down – (4) on to adjust the volume level of the speaker.



Note: The volume controls on your media device work separately from the volume controls the speaker

6 Using the Bluetooth® Audio Speaker

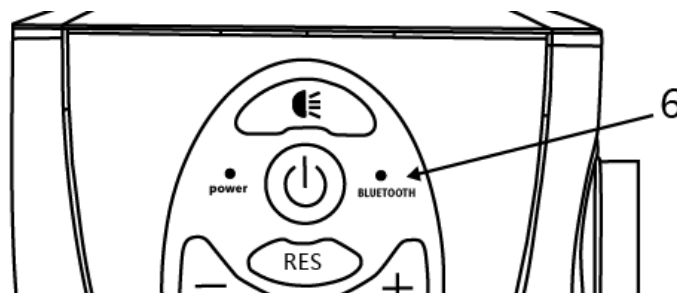
Reconnecting Your Device

- ☐ If you move out of range or turn off the Bluetooth® feature on your device, the speaker will disconnect from your device. To reconnect, simply access the Bluetooth® Manager on your device and select “Music Umbrella”

7 Using the Bluetooth® Audio Speaker

Out of Range or Lost Signal

- ☐ If your device is out of range (beyond 30 ft.) of the speaker or if the Bluetooth® signal is lost, the indicator light (6) will flash slowly to indicate that the Bluetooth® connection has been lost.



Care & Maintenance

1 Cleaning the Solar Panel and LED's

- ☐ Gently clean the solar panels and LED's with a soft cloth. Do not use abrasives or chemicals to clean the solar panels.
- ☐ Remove dust and debris using a soft cloth or duster.

2 Cleaning the Canopy and Frame

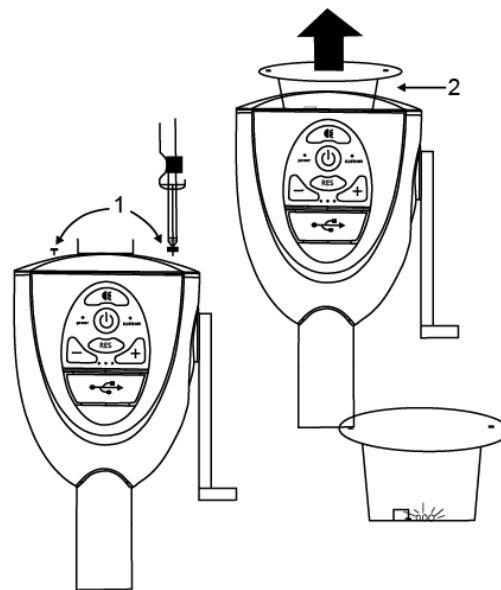
- ☐ Rinse the umbrella with clear, clean water . if necessary , use a gentle fabric cleaner, rated safe for polyester fabrics. Clean the umbrella canopy with a soft brush and mild detergent..
- ☐ DO NOT machine wash.
- ☐ DO NOT iron.
- ☐ Air dry the canopy thoroughly in an open position before storing for extended periods of time.
- ☐ Make sure the canopy is completely open during the drying process to prevent shrinkage.

3 Replacing the Umbrella Battery



WARNING: Use product with supplied 3.2v - 3.7v / 4000maH LiFePo battery pack only. Use of any other batteries may create a risk of fire.

- ☐ Remove screws (1) securing the battery pack (2) to the crank housing.
- ☐ Carefully lift the battery pack from the crank housing compartment.
- ☐ Replace with genuine battery pack ONLY.
- ☐ Re-assemble in reverse order.
- ☐ Refer to "Battery Charging" section.
