Barbados Ice Skating Association Inc (BSA) ("we", "us" or "our") respects your privacy in accordance with this Privacy Policy. By accessing or using the BSA website or any BSA website service, you acknowledge and represent that you have read and understood this Privacy Policy and any updates thereto posted on the BSA website, and you represent, warrant and agree that you are bound by all of the terms and conditions of this Privacy Policy. Your continued use of the BSA website constitutes your binding acceptance of any update to this Privacy Policy.

SUMMARY

COLLECTION OF INFORMATION

All transactions and registrations are connected to the respective registrant, purchaser or user account profiles. organizers will have visibility of the registrant and purchaser user account profiles for the registrations and purchases made to their organization. The registrant profile data might include any of the following details if applicable; name, email address, date of birth, nationality, gender, address.

We collect information about you when you:

- Create an account or use the platform
- Visit our website
- Communicate with us

We also collect information by using cookies, server logs and similar technologies such as usage statistics.

USE OF INFORMATION

We use information about your use of the platform and collected freely from you to:

- Operate, improve and protect our websites
- Personalize content
- Communicate with you regarding your transaction(s)

SHARING OF INFORMATION

We do not, and never have, sell or otherwise pass on your information, except to the event/membership organizer for the purpose of delivering the service or product you have entered into. We do not, and never have, sent spam mail or other promoting our services-we dislike spam as much as you. We only communicate with you in relation to the transaction you have or are trying to do with the event/membership organizer. If applicable, we strongly suggest you review the privacy policy and user agreement of the event organizer, membership body, charity or other which you are using our services to conduct a transaction with, prior to completing your transaction on BSA.



We reserve the right to share de-identified or aggregated information. For example, to analyse trends in sports, demographics and other.

YOUR CHOICES

You can

- Object to our use of your information, but this may impact your ability to register for an event, membership body or other that you are trying to do a transaction with
- In some cases, you may ask us to stop accessing, storing, using or otherwise processing your
 information should you believe we do not have the appropriate rights to do so. An example of
 this would be if you believe an account or registration was set up for you without your
 permission. In some situations, we may need time to investigate.

YOUR PRIVACY

- BSA does not sell or rent your personal information to third parties for marketing purposes-this has been our policy since we started.
- BSA does not knowingly permit spam to be disseminated by or through the BSA Website.
- BSA does not knowingly collect information from anyone under the age of 13, and removes any posting or bid BSA discovers was submitted by someone under 13.
- The BSA Website password, if applicable, protects your user account. Keep your password safe and do not share it. Our team cannot see or access your password.

PERSONAL INFORMATION COLLECTION AND STORAGE

BSA collects and stores information that you freely provide to us, whether via the website over the phone or other communication such as email, with the exception of credit card payment information.

When you create a user account, if applicable, you will be asked to create your profile to include at least your name, and e-mail address. You may update or correct your profile or terminate your user account at any time.

To buy items/services using the BSA website services, you may be asked to provide information such as your, date of birth, age, sex, billing or mailing address telephone number and other details required for a specific registration or purchase. This information is used by the event organizer to coordinate the event, membership or for mailing/registering of purchased items/services. BSA does not store your credit card information. Instead, BSA uses a secure connection to pass your credit card information to a third party payment processing service provider, using client-side encryption to ensure the highest levels of security and PCI compliance.

BSA collects and stores communications made through the BSA website, for assisting with customer support.

BSA may produce statistical data and may disclose to third parties aggregate statistics that exclude personally identifiable information.



BSA is committed to complying with all regulatory requirements around privacy, including Anti-Spam Legislation, if applicable. We dislike spam as much as the next person.

BSA automatically collects telecommunications information such your Internet Protocol (IP) address when you visit the BSA website. BSA may also log the BSA Website pages you access and your browser type. In addition, we collect information about the computer or mobile device you are using to access our platforms, including hardware model, operation system and version, unique device identifiers and mobile network information. We may collection information about the location of your device each time you visit our websites.

BSA stores collected information via Google Analytics. BSA will endeavor to securely store collected information, but cannot guarantee complete security.

USES OF PERSONAL INFORMATION

BSA uses collected personal information to:

- provide and adapt the BSA website services.
- customize, improve or modify the BSA website.
- statistically analyze site usage for marketing the BSA website and its services.
- solve technical problems.
- communicate with users.
- respond to complaints and resolve disputes.
- collect fees and prevent credit card misuse.
- comply with applicable law.

This includes passing on donor and/or registrant information (including address, donation amount, name and other relevant details) to sponsors/charities, event organizers and applicable governing bodies to facilitate tax receipt generation, if applicable, and applying for applicable tax credits. Information collected for an event, charity or other will be passed to the event organizer/charity for their purposes of organizing the event/providing services for that you have purchased using the BSA website. BSA accepts no liability for the misuse of this information which is securely accessed by the event organizer/charity. If you are an individual in the European Economic Area ('EEA'), we collect and process information about you, when we have a legal basis to do so, in accordance with applicable European Union laws. What this means is that we collect and use your information only where:

- You have given us specific consent to do so for a specified purpose such as registering for an event, making a donation, joining a club or other membership body
- We need to process your data for a specific legal obligation
- There is a legitimate interest, not overridden by your data protection interests, such as improving features we offer to you during your registration process and to protect our legal rights and interests
- We need the data to provide you with the services/products you wish to purchase, including Customer Support and personalized features and to protect the safety and security of the services



Where you have consented to our use of information we have collected from you, you have the right to change your mind at any time, but this will not affect any processing that has already taken place (e.g. prior registration transactions). Where we are using your information because we have a legitimate interest in doing so, you have the right at any time to object, but that may mean you may no longer to be able to use our platforms.

DISCLOSURE OF PERSONAL INFORMATION

All transactions and registrations on BSA are connected to the respective registrant, purchaser or user account profiles. BSA organizers will have visibility of the registrant and purchaser user account profiles for the registrations and purchases made to their organization on BSA. The registrant profile data might include any of the following details if applicable; name, email address, date of birth, nationality, gender, address.

BSA may release collected personal information to third party contractors and service providers under agreements that limit their use of such personal information. BSA does not sell or rent your personal information to third parties for marketing purposes. BSA does release relevant registration and transaction information to the relevant organizer to assist them with providing the service/product you have purchased.

COOKIES

BSA creates cookies that are stored on the hard drives of computers you use to access the BSA website. Cookies are small data files stored on your hard drive or in device memory that help us improve our websites and your experience, and track usage of our platforms. Cookies created by BSA store information to maintain your session with the BSA website, and may store information to customize the appearance of the BSA website pages on your computer. Your browser may permit you to decline cookies from BSA, although declining cookies from BSA may interfere with your use of the BSA website. You can delete cookies stored by BSA from your computer's hard drive.
