February 9, 2026

Called to order at 7:00 p.m. by President Mark

Secretary's Report: Motion to accept by Rick, 2nd by Ryan, motion passed.

DNR Report Keri Hull: Snowmobile revenue graphs presented. Mark will scan and send out. Registrations look good up to Feb. 1. Will process benchmarks # 2 and #3. #4 looks likely but not sure yet. Mark added that there are new rules for FRTP grants so be aware if applying. Barb asked Kerri about Volunteer Instructor newsletter-never anything about snowmobile safety training. Kerri will look into it. Baxter has been notified they are up for fiscal review this year. Trails have been gone through and look good. Dani is doing well and will be back to work soon.

Crow Wing County Tom Strack: Second benchmarks have been submitted to the DNR to be paid out in March. Please know the DOT is not out to ruin the trails. Their primary responsibility is safety of the roads. There is new leadership at the Highway department, and they and Tom are working on a communication method to better collaborate.

MnUSA: Winter Rendezvous is this weekend. Garrison, Ponto, and Fort Ripley are planning to attend. Discussion regarding getting a bus to attend Legislative Reception March 9 4:30-7:30 p.m. (March meeting night). Decision not to get a bus after discussion of items on the table.
