MONTHLY SUBSCRIPTION AGREEMENT FOR DOMESTIC HOUSE MAINTENANCE SERVICES

1. Services Provided

- Plumbing System Servicing and Fixes: Regular checks, repairs, and maintenance of plumbing systems, including but not limited to leaks, clogs, and fixture installations.

- This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, whether written or oral, relating to the subject matter herein.
