## **Letter From Commission**

When we joined the Roseland Community Medical District Commission (RCMDC) in 2011, and beyond, we knew RCMDC had tremendous potential to be the economic anchor that would improve the neighborhood of Roseland in Chicago, despite the chronic conditions that has plagued the community for decades due to purposeful disinvestment. Yet, RCMD has existing neighborhood assets and recent developments, both in and surrounding the district, that provided a foundation to once again bring Roseland toward its fullest potential.

Nearly nine years later, we reflect on what has been accomplished and look to the future as we, along with our partners, continue to transform RCMD into a medical district model, which will be recognize nationally for addressing the healthcare and socioeconomic needs of the community and the surrounding region that has been ravished by poverty, racial inequity, social despair, and crime and safety concerns.

With a trade area surrounding the district that consist of 14,000 jobs, we know RCMD will be a catalyst for innovation around the delivery of healthcare services for our seniors, mentally disabled, veterans, prenatal care, and youth. RCMD will be a leader and developer of infrastructure improvements that will attract talent and investments, including healthcare and research facilities; educational institutions of higher learning; industry-specific jobs in manufacturing, distribution, and logistics; public utilities; and housing development.

Thanks to the political and business leadership represented on the Commission and through partnerships, RCMDC received a \$25 million investment from the State of Illinois' Build Illinois Bond Fund as seed funding to be leveraged for private and public investments. Additionally, the City of Chicago's Department of Planning and Development awarded RCMDC \$300,000 toward the development of RCMD Comprehensive Master Plan.

Lastly, RCMDC raised \$400,000 from The Chicago Community Trust Foundation for internal operations to hire staff, a strategic plan for internal operations, and a new office and equipment.

We recognize the district is at a critical juncture and there is so much more work to be done. Our commitment to this end is unwavering, and we are grateful for our stakeholders and supporters for their contribution to these achievements.




























# RMD Biennial Report 2023/2024

# **About The District**

The Roseland Community Medical District Commission (RCMDC), an intergovernmental agency, was signed into law by the State of Illinois in 2011 by Governor Patrick Quinn. The District is created to attract and retain academic centers of excellence, viable health care facilities, medical research facilities, emerging high technology enterprises, and other facilities and uses as permitted by this Act. RCMDC acts as an independent third-party convenor and facilitator that brings institutions and individuals together around common themes and goals.

Governed by the Commission, the Roseland Community Medical District (RCMD) is a 95-acre district whose general purpose: (1) maintain the proper surroundings for a medical center and a related technology center in order to attract, stabilize, and retain within the District hospitals, clinics, research facilities, educational facilities, or other facilities permitted under this Act; and (2) provide for the orderly creation, maintenance, development, and expansion of (i) health care facilities and other ancillary or related facilities that the Commission may from time to time determine are established and operated (A) for any aspect of the carrying out of the Commission's purposes as set forth in this Act, (B) for the study, diagnosis, and treatment of human ailments and injuries, whether physical or mental, or (C) to promote medical, surgical, and scientific research and knowledge as permitted under this Act; and (ii) medical research and high technology parks, together with the necessary lands, buildings, facilities, equipment, and personal property for those parks.

#### **Development Structure:**

This Roseland Community Medical
District Master Plan sets forth the vision,
physical framework, development
strategy and design guidelines for the
planning, design, construction and
operation of a mixed-use campus focused
on high quality patient care, outpatient
services and related investment to
address longstanding community needs.

Implementation of this master plan is targeted for a 10-year timeframe:

Years 1-3, the Medical District
Commission will assemble and prepare
land for outpatient facilities, conduct
Solicitations of Interest (SOIs) and
Requests for Proposals (RFPs) to engage
outpatient project partners, secure
partners and finalize agreements, and
support land planning, design, entitlement
and preparation activities. All work will be
closely coordinated with the hospital.

# **Master Plan Update – Commission Progress**



#### **Master Plan Completion Celebration**

The Roseland Community Medical District Master Plan was completed and adopted by the Chicago Plan Commission in November 2022. The Commissioners organized a community celebration with residents, community stakeholders, and local political leaders highlighting the goals of the Master Plan and next steps at Lavizzo Elementary School on Chicago's far south side during 2023 Black History Month.

#### **Outstanding Community Plan Award – Chicago Community Trust**

The Chicago Community Trust Outstanding Community Plan Award was given to the Roseland Community Medical District for its successful development and completion of the Roseland Community Medical District's Master Plan. The Master Plan was a community-led, place-based initiative to transform underinvested areas in the Roseland community by addressing racial and ethnic wealth disparities, inequity in health outcomes, and outlining short-and-long-term strategies and impact for existing residents and businesses and creating a new destination for potential residents and businesses.

# **Roseland Community Hospital's Transformation Plan Update**



#### **New Mobile Mammogram Unit Help Detect Breast Cancer Early**

Roseland Community Hospital is launching a "mobile mammogram unit" to help with early detection and provide greater access to preventative care. Roseland Community Hospital said this unit is their new warrior to take on the fight of breast cancer, especially when it comes to underserved communities. Breast cancer is the second-leading cause of death for women. But it's the No. 1 cause of death for Black women. That is why the new \$550,000 mammography mobile unit program is imperative to the community. "They listen to us. They've heard your cries for enhanced medical services," said Tina Sanders, Phalanx Family Services CEO and Roseland Community Medical District Commissioner.

#### \$40 Million Transformation Grant from the State of Illinois

In October 2024, the State of Illinois Department of Public Health (IDPH) granted the Roseland Community Hospital their requested \$40 million Transformation Plan grant to modernize behavioral health services, OB/GYN Family Birth Facilities, and new surgery center. Additionally, the grant supports the network of providers servicing disinvested and underinvested communities on Chicago's far south side with the neighborhood of Roseland as the anchor for the region.


## CTA Red Line Extension Update

#### Federal Transit Authority (FTA) signs Red Line Extension (RLE) \$1.97 Billion Grant Agreement - 2024



Nearly \$2 billion in federal money needed to build the long-awaited Red Line Extension (RLE) to Chicago's southern border was promised in writing Friday, ensuring the grant cannot be taken back by the incoming Administration.

Chicago Transit Authority (CTA) President Dorval Carter Jr. heralded the funding agreement as the last critical step to begin construction this year of the \$5.7 billion rail extension from 95<sup>th</sup> Street to 130<sup>th</sup> Street.







# CTA Red Line Extension – Transit Supportive Development Plan

Transit-supportive development (TSD) is based on an ETOD framework, but it takes a broader approach to planning beyond the areas immediately adjacent to transit stations. The RLE TSD Plan is a comprehensive effort for 1/2 mile station areas surrounding each station. The increased density in station areas not only supports transit but also helps accomplish other goals, including reducing urban sprawl, reducing congestion, and increasing pedestrian activity.



The information on this summary page shows that this project will create robust economic development opportunities and be catalytic for economic growth. The new retail square footage and housing unit estimates were calculated using development projections based on vacant land and building data from the City of Chicago, Cook County Land Bank Authority, and surveying.



TSD Map



# **Invest South/West – Roseland: Gately People's Store**





The Gateway @ Gately's is a refreshing, vibrant locale with high-quality, affordable housing options to lease or to own. The Gateway is an assortment of 75 units that include multi-family living, 2-, 3- and 6-flats, and accessory dwelling units (ADUs) that offer residents a wide variety of options to choose from. This exciting project not only provides beautifully designed homes, but it also offers a direct pipeline to homeownership for those needing additional resources to become homeowners. Other amenities at this site include a 1,600 square foot community space, magnificently landscaped outdoor areas, and over 7,000 square feet of ground floor retail and office space that pay tribute to the history of this site as a shopping and gathering place in Roseland.

The Roseland Theater was designed by Henry L. Newhouse and originally built in 1914. The new design comprises of four "acts":

Act 1: The Head of House – Retail Incubator

Act 2: The Front Porch – Pop-Up Programming

Act 3: The Lawn – Outdoor Community Space

Act 4: The Theater – Community Performance









# Invest South/West - Roseland: 1 Fifteen @ Michigan Station







Adjacent to the proposed 115<sup>th</sup> & Michigan Red Line Extension Station, 1 Fifteen at Michigan Station will serve as a commuter-centric community gathering place and connector bringing citizens together and linking people to new opportunities. Phase I of this development includes 58 affordable and market-rate rental homes, small commercial spaces, dining, and an 8,000 square foot market hall adjoined with a 23,000 square foot locally owned grocer. The outdoor plaza with elevated terraces overlooking the corridor will be a new, vibrant outdoor amenity for the community and residents to gather and enjoy.













# History Of The District

The August 5, 2011 signing of the bill by Gov. Pat Quinn created the Roseland Community Medical District. The legislation will help the far south side of Chicago attract high-tech and medical research investments.

Sponsored by Rep. Bob Rita (D-Blue Island) and Sen. Emil Jones III (D-Chicago), House Bill 1888 establishes the Roseland Community Medical District (RCMD). It also creates a commission that will generate a comprehensive economic development plan with the goal of attracting academic institutions, medical research facilities and high-tech businesses to the area.

"We need to use everything in our toolbox to grow our economy and create jobs," Governor Quinn said. "Keys to our future prosperity are in the high-tech and medical fields, where revolutionary advancements are made every day. This legislation will help ensure that more of those breakthroughs are made in Illinois." – William Leonard Public Library
