They understand poor management and what it has cost them, so it is easy to explain that their new landlord can be Jesus, if they choose to follow Him.

Thanks for every dime invested in these "lost souls," or should I more accurately say the sons of mothers who have prayed for years for her child to be saved! Just think, you are part of an answered prayer every time you give; and I thank you for that gift.
