Financial Report

A financial report was presented and adopted.

School Support Program For 2023-24 (\$6500)

The Executive Committee provided the following vision for the Association's School Assistance Program which was approved by the General Body.

GMMAA Education Enhancement Initiative

Implement a comprehensive education enrichment program at Tubman-Gray School to ensure it's students achieve the highest academic standard in the Republic of Liberia.

Strategy

Primary focus is to begin at the elementary level (focus on early childhood education) starting with Grades 1-3 and build a base of high achieving students by developing a system that will rival that of top performing schools worldwide. We will start by providing books, teacher support and other essential educational tools/needs as identified by the Education and Research Committee.

- Provide two 12th Grade Scholarships and Books \$800
- Teacher Salary Supplement for Larry Mulbah, Phonics teacher- \$250 (\$25 a month)
- Provide Books Grades 1-3 \$4500
 - o Grade 3 15 students = \$1185
 - o Grade 2 15 Students = 1260
 - Grade 1 25 Students = \$2055
- Provide Scholarships for Grade 1 in an attempt to create a base of 25 students. Grade 1 normally has 8-15 students. \$1900

Going Forward

- Approval given for \$6500 to be given to the school on an as the need arises, it will not be a lump sum distribution.
- Funds are for the first semester Books, Registration Fees, and firt semester tuition and ½ year salary supplement for Larry Mulbah. An additional \$1000 will be needed for the second semester for tuition.

- Concerns about funding were addressed. Executive Committee indicated a fund raising effort will start in the current year and that based on last years data we shold be able to raise enough funds to replenish what we use. The financial systems have been upgraded to allow dues to be paid on a year-round basis and they intend to start that soon.
- The General Body made several other suggestions for fund raising that will be addressed and incorporated into this initiative. They included raising funds locally, encouraging outsiders to donate to the scholarships, paying dues early (Executive Committee committed to pay theirs prior to the end of the year)

Appeal to Register & Use Website

Registering on the website gives us and indication of interest in the Association and provides us a means of communicating with you through text messaging. All of your date is confidential and will not be shared.

- Attendees were asked to reach out to friends and classmates and ask them to register on the
 website. Registration has increased from 26 the week of August 21 to 42 as of August 31 with most
 of those occurring this past week.
- Since the incept of the website there have been over 2800 visits to the site but very few registrations.
- Attendees were encouraged to visit the website as ther is a wealth of information on it and that the Executive Committee intends to keep it, WhataApp, Mesenger and Facebook updated.
