Chicago 2016 (or "the Organization") is a 501(c)(3) corporation whose mission is to seek the privilege of hosting the 2016 Olympic and Paralympic Games in Chicago.

Chicago 2016 completed and submitted the Candidature File to the International Olympic Committee ("IOC") in February, 2009. The Candidature File allowed the IOC to review the bid proposals of the four candidate cities.

The IOC Evaluation Commission conducted a site inspection of Chicago's plans in April, 2009. In October, 2009, the IOC selected Rio de Janeiro as the host city for the 2016 Olympic and Paralympic Games.
