

Patrick Ryan*	Chairman & CEO/No salary	Today worth \$9 billion, in 2009 Ryan had retired as head of Aon Insurance. From 1997 to 2008 Ryan donated \$529,243 to IL politicians, including \$100,000 to Daley in 2006.
Bob Ctvrtlik	VP, International Relations	Mens's Volleyball Gold Medal winner (1988), Appointed to IOC in 1999, by 2009 no longer member.
Michael Kontos	Special Advisor	SVP, Hill & Knowlton –H&K had given 4 campaign contributions to Daly totaling \$3,250. H&K would become the pr agency for the 2016 Committee
Alison Kutler	Director International Relations	Was a partner at Sonnenschein Nath & Rosenthal at time of appointment, remained at firm while serving the bid. Held several positions in the Clinton Administration from 1993 to 1996, including serving as assistant to U.S. Secretary of Commerce Ron Brown.
Mike Roberts	VP, Marketing	Fonder, Chair of Westside Holdings, former President & COO of McDonald's.
Lori Healey*	President/\$250,000	Former Chief of Staff to Mayor, former Commissioner of the Department of Planning & Development, former principal at Perkins & Will Chicago office. She donated \$500 to the Mayor in 2003.
Robert Accarino	VP, Environment	At time was Senior Director of Global Energy Strategies for Abbott Laboratories. Abbott's PAC gave the Mayor \$10,000 in 2007.
Miles White	VP, Venues, Vice Chair of 2016 Board	Was Chairman, CEO of Abbott Lab, one of the most powerful and influential businessmen in Chicago – named one of

		Chicago's Power 50 by Chicago Magazine. Donated \$100,000 to Daley in 2007. Abbott donated \$10,000 in 2007.
Cassandra Francis	Director, Olympic Village Development/\$175,000	Had been Senior VP at U.S. Equities Realty, 1995-2007. U.S. Equities had donated \$1,500 to the Mayor.
Kira Freelon	Manager, Education & Culture	Had been a reporter for the Hyde Park Herald. Went on to become a marketing consultant for the Rio 2016 Organizing Committee.
David Bolger*	Chief Operating Officer/\$483,000	Had been CFO of the Aon Corporation 2003-2008.
John Murray	Chief Bid Officer/\$364,000	Had been a consultant for McKinsey & Company. Became Board Member of World Sport Chicago (the successor to the 2016 Committee), Co-founder of Chicago Sports Commission in 2011.
Bill Scherr	Director of Sport/No salary	Earned Bronze medal as wrestler in 1988 Games. Was President of World Sport Chicago, designed to promote sports events. Twin brother Jim was CEO of the U.S. Olympic Committee.
Richard Ludwig*	Chief Financial Officer/\$342,000	Ludwig had been the Budget Director for the Atlanta Games form 1990-1997 and then Manager of Financial Planning for the Sydney 2000 Games. He also served as Senior Advisor fo Games Finance & Operations to the IOC from 2001-2013.
Kevann Cooke	Chief Governance Officer/\$209,000	Had been a Senior VP at Aon where he managed their foundation.
Linda Mastandrea*	VP Sport, Director of Paraolympic Sport/\$75,000	Former Paraolympic medalist.
Doug Arnot	Sr. VP Venues & Operations/\$373,000	Had been Exec VP World Cup USA, Managing Director of Venues for Atlanta Games, Managing Director Event Operations for Salt Lake Games, would become Exec VP Games Operations for London Games (2009-2012).
Valerie Waller	Marketing & Communications/\$226,000	Had been VP of Marketing & PR at Museum of Science & Industry (1999-2008). Currently Senior VP and CMO of YMC. of the USA (2016-present) based in Chicago.
Chip Hardt	Director of Development	Had been a principal at McKinsey & Company (1994-2008)
Pete Halpin	Government Relations	Had been Director of the City of Chicago Washington DC Office (2004-2007)
Deb Fiddelke	Senior Manager, International Relations/\$150,000	Had been Deputy Assistant to the President for Legislative Affairs 2006-2008. Went on to become Executive VP for Edelman (a major vendor to the 2016 Committee).
Patricia Rios	Director of Administration/\$135,000	Former Chief of Staff for the Metropolitan Pier & Exposition Authority.
Gyata Kimmons	Director of Community Relations	Former member Office Intergovernmental Relations, Office of the Mayor.
Jessica Fairchild	General Counsel	Was attorney at Sidley & Austin at the time.
Mark Mitten	Chief Brand Officer	Had been a Principle at McKinsey & Company. In 2004 he was a Producer for "The Apprentice."
Lori Igleski	Director, Events, Volunteers & Accommodations	Had been a Managing Director at JP Morgan Chase (1987- 2007). Became board member of the Civic Federation (2014 2022).
Patrick Sandusky	Chief Communications Officer, Official Spokesperson	Had been VP, Hill & Knowlton Strategies (a major 2016 Committee vendor). Went on to become Chief External Affairs Officer, U.S. Olympic Committee (2009-2019)
George Hirthler	Senior International Advisor	Writer & designer whose work is credited with winning Atlanta the 1996 Games. In 2022 IOC awarded him the Pierr de Coubertin Medal for his decades-long devotion to and writing about Baron de Coubertin

Joe Ahern	Special Advisor	Was President & General Manager of CBS 2 Chicago (2002- 2008).
Deborah DeHaas*	Director of the Committee/No \$	At the time was Deloitte Chicago Office Managing Partner. Donated \$3,150 to Daley 2003-07.
John Rogers, Jr.*	Director of the Committee/No \$	CEO of Ariel Capital Management. Was Co-Chair of President Obama 2009 Inauguration Committee, serves on multiple corporate boards. Donated \$132,000 to Daley from 2001- 2007.
Christopher Sullivan*	Director of the Committee/No \$	On staff at the U.S. Olympic Committee since 1997, served as the USOC's Chief Bid Officer for the 2016 Committee
Ron Huberman*	Director of the Committee/No \$	Former Chief if Staff to Daley, former President of the CTA, former CEO of the Chicago Public Schools.
