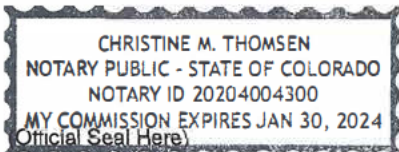

She had shut the garage door before getting out of her car, definitely making sure she was avoiding any interaction.
