Schedule 14.1 Mandatory Water Conservation

A APPLICABILITY

- 1. This schedule applies to all water customers served under all tariff rate schedules authorized by the Commission. It is effective only in times of mandatory rationing, as required by Rule 14.1, and only for the period noted in the Special Conditions sections below.
- This schedule shall remain dormant until specifically activated by Commission authorization of a Tier 2 advice letter.
- 3. When mandatory conservation is activated, The Penngrove water Company shall file an updated tariff which shall remain in effect until the utility files a Tier 1 advice letter to deactivate mandatory water rationing and such is authorized by the Commission.

B. TERRITORY

This schedule is applicable within the Penngrove Town District and the Canon Manor District, of the Penngrove Water Company, Sonoma County.

C. WATER USE VIOLATION FINE

When the mandatory conservation has been activated by Commission authorization, the water use restrictions of the voluntary conservation Rule No. 14.1, section C become mandatory. If a customer is seen violating water usage restrictions as outlined in Rule No. 14.1 and in the special conditions below, the customer will be subject to the following fine structure:

- a. First offense: Written warning, including an explanation of penalty for subsequent offense.
- b. Second offense (of same restriction):\$100.00 fine and written warning, including explanation of penalty for subsequent offense.
- Third offense (of same restriction)
 Installation of flow restrictor, and written warning, including an explanation of penalty for subsequent offense.

D. FLOW RESTRICTOR REMOVAL CHARGE

The charge for removal of a flow restricting device and/or reconnecting water service shall be:

E. SPECIAL CONDITIONS

1. The Tier 2 advice letter requesting activation of Schedule 14.1 shall include documentation of water shortage justifying activation.

E. SPECIAL CONDITIONS (Continued)

- 2. This tariff shall remain in effect until the utility files a Tier 1 advice letter to deactivate mandatory conservation and such is authorized by the Commission.
- 3. Water use violation fines must be separately identified on each bill.
- 4. All bills are subject to the reimbursement fee set forth in Schedule No. UF.
- 5. All monies collected by the utility through water use violation fines shall be accounted for as income. all expenses incurred by the utility to implement Rule No. 14.1 and Schedule No. 14.1 that have not been considered in a General Rate C, shall be recoverable by the utility if determined to be reasonable by the Commission. These monies shall be accumulated by the utility in a separate memorandum account for disposition as directed and authorized by the Commission.
- 6. No customer shall use utility supplied water during mandatory rationing for non-essential or unauthorized uses, including but not limited to those in voluntary conservation Rule 14.1 Section C, and the following:
 - a. Filing or refilling ornamental lakes or ponds is prohibited.
 - b. Re-filing and initial filing of residential swimming pools or outdoor spas is prohibited except to maintain required operating levels of existing pools and spas.
