

The patrons of KAVMS met in the year 2015 under the Chairmanship of Sri. D. H. Shankar Murthy, the then Chairman, Karnataka Legislative Council, along with Sri. R. P. Ravishanker, President KAVMS and Sri. G. V. Gopala Rao, IRS, the then Commissioner of Income Tax, Bangalore, deliberated upon the need for a separate institution for exclusively imparting coaching for the Civil Services Exams, KAS exams and other Competitive exams to the poor and talented students. Accordingly, they decided and established Vasavi Academy as a separate Branch of KAVMS. In the initial years, Vasavi Academy sponsored the talented students selected through the screening test by reimbursing the fees (borne by them in other Institutes) due to the lack of infrastructure in the old premises of KAVMS.

The Vasavi Academy started functioning effectively in the new premises of KAVMS, Seshadhri Road, Gandhinagar, Bengaluru and commenced coaching for the first batch on regular basis from 2019 with all facilities including an in-house library and hostel.
