#### **Taylor Canyon Fire Station Proposed**

According to an article in the April 22, 2021, edition of the Gunnison Country Times, construction of a new fire substation is under consideration.

"The building would be a substation of the Gunnison Fire Protection District (GFPD) located on a parcel in the Wilder on the Taylor Development. It would be sited on the north side of County Road 742. The station would be a short distance away from the Jacks' Cabin cutoff road, Harmel's Ranch Resort, Eleven's Taylor River Lodge, and homes along Crystal and Spring creeks."

This new station could potentially make a difference in fire insurance rates for homeowners in Taylor Park. Insurance carriers typically have different rates and rules. However, at this point, the new station is only proposed – a decision to build has not yet been made.

The TCCA Board sent a letter to the GFPD, and voiced support for the proposed new station.

# **Cemetery Guidelines – Reminder**

In order for anyone to place the cremated remains and/or memorial stone in the Tin Cup Cemetery, the Tin Cup Cemetery Committee must approve your request. Only locations approved and marked will be honored. The deceased or immediate family needs to own property in Tin Cup or Taylor Park. The Guidelines and the Burial Request Form are located under the Document Section of the Tin Cup Civic Association website, or an application can be requested from Terri Harris, the Cemetery Chairperson. Should you need any questions answered, email her at trrharris@live.com Please note that the \$300.00 fee to the TCCA will be used for cemetery maintenance and improvements. Full body burial is not permitted. All Taylor Park residents that have secured a spot in the Tin Cup Cemetery need to maintain their individual area. Any glass or plastic, other than flower vases, will be disposed of at the end of the season.

# **COVID-19 Update**

The Office of the Public Health Director in Gunnison County can be reached at 970 641-0209.

To find the latest information on COVID19 in Gunnison County, go to https://covid19.gunnisoncounty.org. The latest Public Health Order limits gatherings indoors to 50 people and outdoors to 250 people. All retail, restaurants, lodging, personal services, and schools are open. Masks are required indoors and when 6-foot social distancing cannot be followed. Cleaning of high-touch surfaces, employee screening for COVID19, and isolation when sick or exposed are also required.

Unless a new Public Health Order is issued, all requirements will expire at midnight on July 1.



# Update on Tin Cup Town Hall Accessibility

At last year's meeting, we discussed options for making the Town Hall more accessible to those folks not comfortable using the stairs to gain entry to the building. We looked at 3 separate scenarios...a ramp running along the west side and tying into the stoop at the rear door...a switchback ramp on the north end, again tying into the existing stoop and a third option of a portable / temporary ramp at the front entry that would only be in place for meetings and events.

A fourth option was explored, and the members voted on it believing it is the one that best suits our needs. This one is a deck or porch that runs the full width of the building and has a ramp built into it not visible from the front. This preserves the integrity of the symmetrical front view of the building that is so important to all of us. Additionally, as seen in old photos, the building originally had a porch and steps across the entire front as we have now designed. So, in reality, the new porch will provide wheelchair access to the front entry, provide a gathering place for meet and greet chats, a group photo spot and will also be historically correct.

The cost and timing of the project is another story. As some of you have noticed, the cost of all building materials has risen approximately 300% in the past year...blame it on COVID19! We will obtain cost estimates for all the lumber and concrete to be used for the construction of the porch project and then decide the timing. Most of the labor will be volunteer so if we move forward with construction this year we'll be looking for a few good folks who like to hammer nails.

# Proposed Voting Change for TCCA Members

At last year's 2020 Annual Meeting of the TCCA, members voted to accept the One person/One vote approach in our meetings. The By-Laws have been changed to reflect this:

#### **ARTICLE III**

Voting, Elections and Proxies

**SECTION 1.** Voting entitlement. Except as the article or an amendment, or amendments thereto otherwise provided, each member shall, at every meeting of the members, be entitled to one vote in person or by proxy.

At the meeting the members also voted that we should have some limit on the number of votes owners of a property may have. In discussing this, the Board is suggesting making the limit 6. This is generous and allows families that put a large number of family on a deed to have a number of votes but does put a cap on it so it does not unduly influence a vote. We proposed we vote on making this this limit.

Please come to the meeting prepared to vote on this issue.
