



TIN CUP CEMETERY APPLICATION For Memorial or plot

Tin Cup Civic Association **3/1/2025**

Thank you for your interest in the Tin Cup Cemetery. This application is to request a 6 ft by 6 ft plot within the Cemetery to place a memorial or cremation remains or to request a memorial for an existing approved plot. The application will be reviewed by the TCCA Cemetery Committee to ensure compliance with guidelines. The Committee is responsible for maintaining the historic nature of the Cemetery. New grave markers, gravestones, memorials etc. will be required to be consistent with and complimentary to the original historical nature of the Cemetery.

To apply, please complete the following application and submit it to the Cemetery Committee Chairperson (Sally Kuisle), along with a Memorial Fee of \$300, if you have not already paid. Once approved, the Fee holds a 6 ft x 6 ft plot in the applicant's name and allows for use of the plot to place cremation remains and a grave marker, gravestone, memorials etc.

Please note: FULL BODY BURIAL IS NOT PERMITTED IN THE TIN CUP CEMETERY. ONLY PLOTS APPROVED AND MARKED BY THE TIN CUP CIVIC ASSOCIATION CEMETERY COMMITTEE WILL BE ALLOWED FOR USE.

Installation of lighting is not permitted. Placing plastic or artificial decorations is discouraged. If placed, please remove them before winter.

The Committee will review the application and issue a decision promptly. If the application is approved, the Fee will be processed. If the application is not approved, you may request a review by the TCCA Board of Directors.

- 3. Have you previously arranged a plot location with the TCCA in the Tin Cup Cemetery?**

- 4. If not, where in the Tin Cup Cemetery would you like the location of the memorial be placed?**

MEMORIAL SPECIFICATIONS

MEMORIAL (Headstones)

SIZE – not to exceed 30” H x 48” W (H - 2 ½ feet x W - 4 feet)

MATERIALS – granite, marble, or other natural stone / wood / bronze plaques

STYLE – consistent with and complimentary to the original historic nature of the cemetery.

BENCH (located on or directly adjacent to your approved 6’ x 6’ plot)

SIZE (includes a back, if desired) – not to exceed 36” H x 48” W x 12” D (H - 3 feet x W - 4 feet x D – 1 foot)

NATURAL MATERIALS – granite, marble, or other natural stone / wood / bronze plaques

STYLE – consistent with and complimentary to the original historic tone and atmosphere of cemetery.

CONCRETE BASES - These are acceptable for the base of the memorial stone and/ or for benches. Size is to be determined depending on the dimension of the memorial stone being placed, allowing a reasonable margin for support of the stone marker.

FENCES - If fences are desired, approval of the proposed material, color, and height is needed.
