It is undisputed that Mason Classical Academy (MCA) is academically one of the most successful schools in the State of Florida. Since its founding in 2014, MCA has garnered respect and accolades for its great curriculum, caring faculty, staff and superior results. Every year since opening, MCA has received an "A" rating, and we understand that MCA is: (i) currently ranked in the top 2% of all schools in the state, and (ii) the highest-rated elementary, middle and high school in Collier County. In addition to its academics, we understand that MCA has passed its rigorous independent audit from McCrady and Associates and is focused on its finances, oversight and policies and procedures. We further understand that each of MCA's annual audits were sent to the District, and we are not aware of any questions or concerns with the auditor's findings.

On June 3, 2019, Mr. Fishbane published a "dossier" containing certain factual and legal allegations pertaining to MCA and his yearlong investigation into MCA. In addition, and based on his "dossier", Mr. Fishbane recommended that MCA Board members resign such that control of MCA would be placed, by the District, into the hands of a new Board majority.

However, according to an explosive investigative report<sup>1</sup>, released on November 5, 2019 by the highly regarded, Martindale AV rated and Florida Super Lawyer and Best Lawyers in America rated J. Michael Coleman (Coleman Investigation), see, Exhibit "B" attached hereto, <u>MCA has been exonerated and cleared of the material allegations levied by Mr. Fishbane in his "dossier".</u> In fact, Mr. Coleman concluded that his firm "found no basis for Mr. Fishbane's recommendation that Mrs. Lichter and Ms. Miller need to be removed as members of the MCA Board." Further, Mr. Coleman concludes that there is "no provision in either Florida Law or the Charter Contract that provides for such a recommendation." Mr. Coleman also confirms that Mr. Fishbane's recommendations pertaining to unlawfully taking control of the MCA Board are "far outside the power of the District ...".

According to Mr. Coleman, during his yearlong "investigation" into MCA, Mr. Fishbane failed to interview any Board member, current MCA staff member or parent of MCA students having positive experiences with MCA. Understandably, we find it deeply concerning that Mr. Coleman also concluded that the Fishbane "dossier" was "stridently one-sided regarding the persons interviewed and documents collected". Further, we observe that material, factual and legal errors and omissions tied to Mr. Fishbane are clearly documented in the Coleman Investigation with respect to: (i) Mr. Fishbane's yearlong MCA investigation, (ii) Mr. Fishbane's June 3, 2019 publication of his erroneous "dossier" pertaining to MCA, and (iii) and the resulting District actions, all at an anticipated/expected cost to taxpayers of hundreds of thousands of dollars and all without any record of formal School Board approval of the same.

Additionally, Mr. Coleman concludes and describes in great factual and legal detail how Mr. Fishbane and the District denied MCA due process and violated both the MCA contract and the Florida Charter Statute during Mr. Fishbane's yearlong investigation into MCA and also when the District posted the agenda item this year to discuss MCA's termination.

Based on the attached, we believe that Mr. Fishbane acted improperly, and further, we believe that Mr. Mr. Fishbane lied to the

parents of MCA and the larger community. We also believe, based on the attached Coleman investigation, that MCA was treated unfairly by Mr. Fishbane, and that his actions pertaining to MCA, as described in the Coleman Investigation, damaged MCA and her students.

As parents and stakeholders, we are deeply concerned by Mr. Coleman's findings pertaining to Mr. Fishbane's conduct. As such, we are hereby exercising our fundamental right to petition the School Board for redress, and we look forward to a formal, written response from Mrs. Lucarelli, as Board Chair, pursuant to District Policy/Procedures.

What actions do you believe should be taken to resolve your complaint?

We demand that the School Board immediately turn this complaint over to FDOE or the appropriate oversight agency/body so that an <u>outside and independent authority</u> can: (i) meet with Mr. Coleman, (ii) review the Coleman Investigation (and all underlying documents related thereto), (iii) ensure that all necessary discipline action is commenced against Mr. Fishbane (and all other persons with in the District who authorized Mr. Fishbane's actions), and (iv) ensure that all necessary actions are immediately taken by the District help repair/mitigate the damage to MCA (and its parents and her students) as caused by Mr. Fishbane (as documented in the Coleman Investigation).

It is undisputed that Mason Classical Academy (MCA) is academically one of the most successful schools in the State of Florida. Since its founding in 2014, MCA has garnered respect and accolades for its great curriculum, caring faculty, staff and superior results. Every year since opening, MCA has received an "A" rating, and we understand that MCA is: (i) currently ranked in the top 2% of all schools in the state, and (ii) the highest-rated elementary, middle and high school in Collier County. In addition to its academics, we understand that MCA has passed its rigorous independent audit from McCrady and Associates and is focused on its finances, oversight and policies and procedures. We further understand that each of MCA's annual audits were sent to the District, and we are not aware of any questions or concerns with the auditor's findings.

On June 3, 2019, Mr. Fishbane published a "dossier" containing certain factual and legal allegations pertaining to MCA and his yearlong investigation into MCA. In addition, and based on his "dossier", Mr. Fishbane recommended that MCA Board members resign such that control of MCA would be placed, by the District, into the hands of a new Board majority.

However, according to an explosive investigative report1, released on November 5, 2019 by the highly regarded, Martindale AV rated and Florida Super Lawyer and Best Lawyers in America rated J. Michael Coleman (Coleman Investigation), see, Exhibit "B" attached hereto, <u>MCA has been exonerated and cleared of the material allegations levied by Mr. Fishbane in his "dossier"</u>. In fact, Mr. Coleman concluded that his firm "found no basis for Mr. Fishbane's recommendation that Mrs. Lichter and Ms. Miller need to be removed as members of the MCA Board." Further, Mr. Coleman concludes that there is "no provision in either Florida Law or the Charter Contract that provides for such a recommendation." Mr. Coleman also confirms that Mr. Fishbane's recommendations pertaining to unlawfully taking control of the MCA Board are "far outside the power of the District ...".

According to Mr. Coleman, during his yearlong "investigation" into MCA, Mr. Fishbane failed to interview any Board member, current MCA staff member or parent of MCA students having positive experiences with MCA. Understandably, we find it deeply concerning that Mr. Coleman also concluded that the Fishbane "dossier" was "stridently one-sided regarding the persons interviewed and documents collected". Further, we observe that material, factual and legal errors and omissions tied to Mr. Fishbane are clearly documented in the Coleman Investigation with respect to: (i) Mr. Fishbane's yearlong MCA investigation, (ii) Mr. Fishbane's June 3, 2019 publication of his erroneous "dossier" pertaining to MCA, and (iii) and the resulting District actions, all at an anticipated/expected cost to taxpayers of hundreds of thousands of dollars and all without any record of formal School Board approval of the same.

Additionally, Mr. Coleman concludes and describes in great factual and legal detail how Mr. Fishbane and the District denied MCA due process and violated both the MCA contract and the Florida Charter Statute during Mr. Fishbane's yearlong investigation into MCA and also when the District posted the agenda item this year to discuss MCA's termination.
