• Provide the Commissioner of Education with the authority to remove a Charter School Board Member where there has been a finding of misfeasance or malfeasance by such a member and require charter schools to establish and maintain a School Advisory Council, per Florida statute 1001.452, to ensure employees, parents, and community members are involved in decision making
