

AWGA General Meeting

Minutes – March 15, 2022

Call to order 1:14pm

President's Remarks / Opening – Charlotte McFarlin

- After Play discussion of the Tee It Forward Tees at Tierra Verde
 - Charlotte/Lynda reminded people to enter their scores manually with 69.5/120 for Tierra Verde. Members stated that they enjoyed the new tees moved forward. It was suggested that the #2 tees be moved slightly to the right.

- Maggie Williams announced that the Auto Play list is now updated weekly.

- Jane Wilson reminded members to please remember to sign in on the Sign In Sheets – And Post your scores AFTER play.
 - Jane Reviewed the Proper way to complete and Attest Score Cards and made members aware that any discrepancies will result in disqualification
 - Many members have broken 80 and 90 using the Tee it Forward Tee Boxes. The Birdie/Putts and Chip In Sheet includes a place at the bottom to enter your name if you break 100, 90, or 80 for the FIRST time.

- Lynda Duvall made sure members understood how to sign up to Receive REMIND text messages for last minute notifications. (A handout was provided for members to use to set up the “Remind” on their text messages).

- Lynda Duvall passed around a paper for members to provide Emergency Contact Info in the event of an emergency on the course. It was also suggested to add the PRO Shop numbers of each course in your phones

- Shirley Addison went over the Upcoming Tournament Schedule as follows:

 - AWGA 70th Anniversary Tournament – Sept 6, 2022 at TR. Members are encouraged to reach out to older members who may know bits of history about our organization to attend and speak if willing.
 - 2022 Club Championship – Day 1 Oct 31, 2022 at LA, and Day 2 Nov 8, 2022 at TV with lunch to follow at TV on Day 2. It will be a Low Gross and Low Net Tournament
 - Christmas luncheon date TBD. It was decided that the Christmas luncheon would only include Awards, Introduction of the New Board and Fun. No General

Meeting will be held at the luncheon. The General Meeting will be held earlier in the month, so as not to lengthen the time of the Christmas luncheon or interfere with a festive day of fun.

- Shirley is putting together some new member packets and bags. The bags will contain goodies and some handouts specific to AWGA. The bags will be free to new members. She will order several extras. Existing members may purchase one for \$5.00.
- Pam Bean reported we have 10 new members. She requested to be notified if you know of any member who has an illness etc., so she can send a card.

New Business –

- Lynda Duvall is going to try to include a “Rule” in her e-mail communications, possibly monthly. The purpose is to make members aware of a PGA Rule they may not be familiar with and/or review for many of us.

Reminder that we have a League Rule of “Lift/Clean/and Place”, one grip length that can be used anytime, EXCEPT the Club Championship and ACE of ACES tournaments. Remember: The local league rule is NOT intended to improve your lie.

Several of our members have been with organizations that participated in Suburban and stated how much fun it is and a great way to meet other lady golfers. Dues are \$16.00 a year. Play Days are approx. \$35.00 without lunch. (If a club hosts and provides lunch it may run approx. \$50.00).

After discussion, Lynda Duvall made the motion to start the discussion with the Suburban organization to add to our organization.
