RULES OF OPERATION AND CONDUCT

\_\_\_\_\_ Only persons with a valid driver's license can drive the golf cart.

\_\_\_\_\_ All State laws apply while operating a golf cart, including on the beach, which is a public street.

Drive on roadways only

No reckless driving (speeding, donuts, driving in sand dunes, etc.) If a cart is tipped on its side a fee of \$1,000 to \$2,000 will be charged to cover damages.

\_\_\_\_\_ Do not drive a golf cart on HIGHWAY 361, south of intersection with Avenue G.

\_\_\_\_\_ Do not drive golf cart in the water. Charges of \$1,000 up to \$6,000 could be assessed for repairs.

\_\_\_\_\_ Do not drive the golf cart past Mile Marker 45 on the beach.
