Presidents Message

Greetings everyone,

Wow! March already, one more month to get our fishing selections in for the monthly fishing contest. First meeting in April is the deadline for all entries. Get your form in this month's newsletter. On the fishing front, Mickey Sherry has been busy as a beaver attending many fishing council meetings this winter and has been voting in our name on some of the upcoming fishing regulations. In fact, he wanted me to add this to my message:

2023 FLUKE REGS FINALIZED

Much to the dismay of most fluke fishermen in our state, we are being forced by NOAA/ASMFC/MAFMC to have the exact <u>same fluke regs as last year</u>. This includes the season, bag, and size limits. Therefore, our season will run from **May 2**nd through **September 27**th with a limit of just one fish 18" or greater and 2 fish from 17-17.99". The special regulations for Delaware Bay, 3 fish 17" or greater and Island Beach State Park, 2 fish at 16" or greater remain the same. There is nothing at all our state can do about it. The NJBMF was all set to consider other options, but they cannot do it. This applies to all states, not just New Jersey.

What happened was that for 2023, a new model was used. Initially data was plugged in from last year which showed that we could have a 10% liberalization. A week or so later they decided to use data from the last 5 years rather than just one year. That would have resulted in us having to take a 10% reduction. Many people were very upset about that and the ASMFC and MAFMC then agreed that we should have status quo measures, but it was unclear if conservation equivalency could be used. Apparently, NOAA then approved status quo measures provided that each state maintains the exact same regulations that they had in 2022.

Looks like NOAA/ASMFC/MAFMC doesn't have the balls to make any changes and again the recreational fishermen must take it up the ____! Thanks Mickey, right on target as usual. I wonder how many pirates will be fishing this year???? Don't forget the flea mkt is on the 4th at the Elks, and Rich is going to need some help setting up tables Fri night. He will confirm the time at the meeting. Last time I spoke to him, all the vender tables were sold. Great job Rich! Wish the following Happy Birthday this month, Kenn Seefelt 7th, Rich Greger 11th, Dawn Itjen 12th, Walt Bohn 15th, Rich Newmark 15th, Bill Grochowicz 18th, and Mike Knoblock 18th. It was great to hear from Capt. Joe Gallinoto about boating safety last month, and I'm looking forward to meeting and hearing about the police regulations associated with boating from our guest speaker Sgt. Dale Pearse from the Point Pleasant Beach police dept. Sgt Pearse patrols the waters from Point Pleasant to Cape May. 2023 FISHING CONTEST RULES AND CHANGES

1-Monthly Fishing Contest:

You must enter the contest by submitting this form and paying the entrance fee of **\$2.00 per fish per month or you can go all-in for all species for all months that are denoted by an X (100 Mos.) for a \$100 buy-in. The Monthly Contest Form must be submitted no later than our April Members Club meeting. The Monthly Contest begins on the Friday after the April Club Meeting.** Phone-ins are no longer accepted, (Hard Copy Only). Example: \$20.00 is received for a specific fish ie. Bluefish, 3 blues were caught and entered (weighed in). The total money in this category is \$20.00. 1st place 50% or \$10.00, 2nd place 30% or \$6.00, 3rd place 20% or \$4.00. NOTE: For the Monthly Fishing Contest and Tournament Days, Bluefish <u>MUST WEIGH</u> a minimum of 2 lbs. <u>NOW:</u> If only one fish is weighed in, ALL the money collected (100%) goes to the 1st place fish. If there is only a 1st and 2nd place fish entered, the split is 60-40. Winners for both the Monthly Fishing Contest and Tournament Days can only win one place in each category. **2-Each month** our chairperson or designee for the Fishing Contest will inform the club members of the winners for the monthly contest and tournament days.

3-Bonus Money: For the 9 contest months (April-December), an additional \$25.00 (cash bonus) will be awarded each month to just **ONE** of the 1st place monthly contest winners for that month. **All 13 species are eligible**. The 1st place winner that is drawn at the meeting will receive \$25.00 (cash). **NOTE: All fish species listed on the front side of this form that are entered in the monthly contest for that month are eligible for a chance to win the \$25 cash bonus.**

4-Tournament Days have a \$30 ENTRY FEE: This fee enters you into 1 - 16 Tournament days and makes you eligible for the LARGEST FISH OF THE YEAR for the six species listed on front with an asterisk (*****). The Contest Days Form for Tournament Days must be submitted no later than our April Members Club Meeting. Cash payouts are as follows 1st (\$25), 2nd (\$15), and 3rd (\$10) NOTE: For Tournament Days and the Monthly Fishing Contest, Bluefish <u>MUST WEIGH</u> a minimum of 2 lbs. 5 – Club Fishing Trips Tournament Days:

All club organized Fishing Trips held on a Head Boat for club Members will be considered a <u>FREE TOURNAMENT DAY</u>. Only members who participate in these club trips will be eligible for the <u>FREE TOURNAMENT DAY PAYOUTS</u>. There are 6 species eligible for tournament day payouts, as noted on the front side by an asterisk (*****). All fish will be weighed while on board the boat and the tournament winners will be announced at that time. Note: If you are also entered in the monthly contest and want your fish to qualify for the monthly contest, you must weigh in your fish at one of the club's official weigh stations. 6-THE LARGEST FISH OF THE YEAR for the following six species, WEAKFISH, BLUEFISH, STRIPED BASS, FLUKE, SEA BASS and BLACKFISH, winners will be presented with a customized bronze name plate plus \$75 (cash) at our annual AWARDS BANQUET. Note: You must be entered in the Tournament Days contest to be eligible for the largest fish of the year. Weigh-in Station Procedures The official club weigh-in stations are *Creek Side Outfitters, Grizz's Forked River Bait, & Tackle, Grumpy's, Fisherman's Den & Lacey Marine*. It is the Angler's responsibility, when weighing in a fish, to verify that all the information on the weigh-in sheet is accurate i.e., NAME, DATE, SPECIES and WEIGHT. The angler will initial the weigh-in sheet verifying that all the information is correct. If you are weighing a fish in for another angler, the same rules apply. <u>ONCE INITIALED, THE WEIGH-IN IS FINAL!</u> All fish caught from Ports & Beaches in New Jersey must be weighed in at one of the above stations. NOTE! ONLY FISH CAUGHT IN WATERS ADJACENT TO NEW JERSEY ARE ELIGIBLE FOR THE MONTHLY CONTEST, TOURNAMENT DAYS AND LARGEST FISH OF THE YEAR.

Club Record

A fish submitted for a club record may be taken from any location, there are no geographical limitations. For fish caught out of state you must submit a weigh-in slip including species name, length and weight on letterhead, or business card or invoice from that station signed by the weigh master, tournament chairman, or Captain of the vessel. A Club Record Form must be submitted to Ken Rylak and attached to the weigh-in slip from one of our official stations or other documentation as described above. The BOD shall approve all records before becoming official. Here are the guidelines for all "Catch & Release" Club Record submissions. Measurement formula for (ALL SPECIES) as follows: Length X Girth squared divided by 800. Example: Length 60" X 25" Girth squared = 37,500 Divided by 800 = 46.875 Lbs. Please Note: LENGTH is measured from the tip of the lower jaw to the fork of the tail and GIRTH is measured (circumference) at the widest part of the fish, usually behind the gill plate.

One final note: Perhaps this rule has not been properly communicated in the past, but **you personally** must catch the fish you enter in all these contests/tournaments and not enter a fish caught by someone else on your boat. This is an **individual** contest and besides we are all friends and family, and we expect **GOOD SPORTSMENSHIP**. Thank you, Good Fishing and be Safe out there.




