**1. PERMISSION TO PARTICIPATE** I/we parent(s)/guardian(s) of the above named participant hereby give my/our approval for participation in any and all of the activities of the North Creek Junior Football Association (hereby known as "NCJFA") during the current season. I/we assume all risks and hazards incidental to the conduct of any of the activities, including transportation to and from such activities. I/we do further release, absolve, indemnify and hold harmless the NCJFA, its organizers, sponsors, directors and supervisors, any and all of them. In case of injury to my/our child, I/we hereby waive all claims against the organizers, sponsors, directors or any of the supervisors appointed by them. I/we likewise waive, to the extent not covered by liability insurance, any claim against any persons transporting my/our child to and from activities.. I understand, hereby give my approval for, and assume any and all risk of my child's use of various playing surfaces and conditions, including, but not limited to, dry and wet natural and artificial grass, hard dirt, and/or mud and I hereby acknowledge and understand that said surfaces may be regular or very irregular.

**2. INTENT TO INFORM:** I/we acknowledge that I/we are fully aware of the potential dangers of participation in any sport and fully understand that participation in football and/or cheerleading may result in serious injuries, paralysis, permanent disability and/or death. Furthermore, I/we fully acknowledge and understand that protective equipment does not prevent all participant injuries, and therefore I/we do hereby waive, release, absolve, indemnify, and agree to hold harmless the coaches, NCJFA, the league, including owners of fields & facilities utilized for the program and any and all organizers, sponsors, supervisors, participants, and persons transporting the above named participant to and from activities, from any claim, whether the result of negligence or for any other cause, on or behalf of the registrant as a result of the registrant's participation in the program and/or being transported to or from the same, which transportation I hereby authorize.

**3. EMERGENCY MEDICAL AUTHORIZATION:** I/we hereby authorize any representative of NCJFA to seek any and all emergency medical/dental treatment and/or first aid to be administered to my/our child/participant, including authorizing any medical treatment facility/hospital to administer emergency treatment, for any illness/injury/accident resulting from participation in any and all NCJFA activities. If transportation to a hospital is deemed necessary by medical personnel, I/we hereby grant my permission for my child/participant to be transported. If medical aid is needed at such hospital, due to a life-threatening situation, I/we hereby authorize permission for such treatment and accept financial responsibility for such treatment. It is understood that efforts shall be made to contact the undersigned or other emergency contact person as indicated above prior to rendering treatment to the injured participant. This authorization shall expire on December 31st of the current season.

**4. EQUIPMENT RESPONSIBILITY:** I/we agree to assume the cost of damaged/altered football gear issued to my/our child and for NCJFA to deduct the amount of the repair/replacement from my/our equipment deposit. I/we further agree that is issued equipment is not returned in good, clean and dry condition, subject to normal wear and tear, by December 1st following the end of the current season, that I/we forfeit our equipment deposit.

**5. INSURANCE DISCLOSURE:** I/We am/are aware that NCJFA carries group accident insurance which is considered secondary or excess for medical purposes to any and all valid insurance I/we possess which is considered primary insurance. Furthermore, I/we agree to notify in writing my head coach and NCJFA of any medical claim as a result of participation in NCJFA as soon as reasonably possible. I/We understand that any registration fee paid does not constitute a direct premium for insurance and that a deductible(s) may apply.

**6. SCHOLASTIC VERIFICATION:** I/we understand that NCJFA is a scholastic program and agree to furnish an end of year report card (covering the full previous school year). I/We understand that failure to provide a full report card could result in lost practice and play time for my participant. until a full report card is furnished.

**7. FINANCIAL RESPONSIBILITY:** I/We hereby stipulate that I/we have been advised by NCJFA of my rights, if any, to a refund in accordance with the organization policies, and I/we have also been advised of my fundraising obligations for the entire season and agree to fully comply with those obligations.

**8. COMMUNICATION AND PROMOTIONAL CONSENT:** As a condition to my/our child's participation, I/we hereby consent to receive communications via email and mail from NCJFA and its partners. I/We understand that NCJFA does not sell its contact lists and communications. Furthermore, I/we hereby grant to NCJFA the absolute right and permission to make, reproduce, broadcast or otherwise use participant's name and likeness, any photograph, films, videos, recordings, or other depictions or images in whatever form or media in connection with participation in NCJFA throughout the universe in perpetuity and in any and all advertising and promotion materials, in any manner or media whatsoever for purposes of art, advertising, editorial, trade or promotion or any other purpose whatsoever. To the extent that any benefit accrues or may accrue to NCJFA, I/we hereby and forever waive any interest in or claim to such benefits and acknowledge that NCJFA is under no obligation to exercise any rights granted herein.

**9. ADULT CODE OF CONDUCT: 1:** In order to uphold the goals of NCJFA and ensure that all participants have the benefit of a safe and fun learning environment, all parents, guardians and other adults and attendees of NCJFA events, including but not limited to practices, games, competitions, and banquets, must behave accordingly in a respectful, courteous and sportsmanlike manner at all times. **2:** Any adult who is using alcohol, tobacco or non-prescription drugs and/or appears intoxicated at a NCJFA event, and/or who is flagrantly rude, attempts to intimidate, verbally abuse, heckles, taunts, ridicules, boos, throws objects and/or uses vulgarity or profane language/gestures with an official, coach, volunteer, staff member, participant or other event attendee, must receive a verbal warning and/or be asked to leave a North NCJFA event. NCJFA may also provide a written warning to the individual regarding the misbehavior. The adult's children may also be removed from the event. Any adult who commits one of the above stated offenses a second time, will be banned from any and all NCJFA events for a period of one year from the date of the second offense, and their children may also be removed from the program(s) for that time period. **3:** Any adult who physically assaults an official, coach, volunteer, staff member or participant or threatens grave bodily harm may be banned from any and all NCJFA events for one year from the date of the offense, and their children may also be removed from any and all NCJFA programs for that same period of time. After the ban has expired, if the individual commits another offense of the adult code of conduct, the individual will be permanently banned from any and all NCJFA events and the individual's children may also be permanently removed from any and all NCJFA programs.

**10. ADHERENCE TO NORTH CREEK JUNIOR FOOTBALL ASSOCIATION (NCJFA) RULES AND PROCEDURES:** I/We hereby understand and acknowledge that as a parent/guardian of a NCJFA participant it's my responsibility to comply with all rules and regulations stipulated, adopted or recognized by NCJFA and the Northwest Junior Football League (NJFL), or any of its member organizations and understand that any non-compliance with any and all rules and regulations may be cause for discipline and/or dismissal of the participant, myself, and/or any spectators or other persons affiliated with the undersigned and the above named participant. I/We further understand that the participant must meet NCJFA age and/or weight requirements on their official certification date as established by NCJFA without exception and that the decision of the weigh master is final. I/We agree to furnish an authentic certified copy of a birth certificate of the above-named participant to NCJFA and understand that valid proof of age, a current year's signed medical release, full end of year report card, and this form must be presented by the first day of practice in order to participate further in NCJFA activities. I/We hereby hold NCJFA harmless of any financial loss as the result of any disciplinary action.
