VILLAGE GREEN HOMEOWNERS RULES AND REGULATIONS

In order to create a congenial and dignified residential atmosphere, the VILLAGE GREEN ASSOCIATION (VGCHOA) has adopted the amended rules and regulations for the guidance of all

owners, their families, guests and tenants. Please note that violators will be fined for infractions as

indicated below.

FINES

- 1. **PETS** Pets are allowed, but you will be fined if you do not clean up after your pet. **FINE \$25**
- TRASH- All trash must be placed in the green dumpster in trash bags and tied before placing in the dumpster. UNDER NO CIRCUMSTANCES may trash be left on the patio. FINE \$25
- PATIOS- Clothing, trash and other items must not be hung from the decks or porches or from clothesline on deck. No hammocks attached to walls or rafters. Only patio furniture. FINE: \$25
- **4. NOISE** All parties and gatherings must be confined to the inside of the hosts' apartment NO UNIT OWNER, nor his family, guests, invitees, or tenants, shall make or permit any disturbing noises in the Buildings, permit conduct by such person that will interfere with the rights, quiet enjoyment or convenience of other residents. **FINE: \$100**
- 5. **GRILLS** grills other than gas or electric on patio is strictly prohibited. Place in rear of the unit for use not in front of the unit **FINE: \$50**
- 6. **KEGS** NO KEGS ON PREMISES **FINE: \$200**

GENERAL INFORMATION

- 1. **PARKING AND VEHICLES:** Parking in the fire lanes, No parking Zones, and in landscaping is prohibited. No vehicle, which cannot operate on its own, powerboats, jet, skis or unlicensed vehicles shall be permitted to park at VILLAGE GREEN. Repairing and washing of vehicles is prohibited. Vehicles violating this paragraph shall be removed at the owner's expense, without notice.
- 2. **SOLICITATION:** There shall be no solicitation by any person anywhere in the Condominiums for any cause, charity or any purpose.
- 3. **COMPLIANCE:** Every unit owner and occupant shall comply with these Rules and Regulations and revisions here to which from time to time may be adopted. Failure of a Unit owner or occupant to so comply shall be grounds for action, which may include, without limitation, an action to recover sums due for damages, injunction relief, or any combination thereof.
- 4. **FACILITIES** No guests of any owner or tenant other than a houseguest will be permit to use the swimming pool unless accompanied by a resident member of the family or tenant.

- 5. *POOL PARTIES* Tenants wishing to host a pool party may do so by notifying Carolina Real Estate, in writing, 48 hours prior to the date of the party. For additional information, i.e., fees, etc., please contact CRE (654-9552).
- 6. **SWIMMING POOL** Swimming in the pool is permitted between 8:00 a.m. and 12:00 midnight. Persons using this facility do so at their own risk. Children under 14 years of age must be accompanied by a responsible adult at all times. Running in the pool area is not permitted. NO glass containers or bottles are allowed in the pool area. No diving is allowed in the pool. No floats and chairs are allowed in the pool.
- 7. **SECURITY:** Promptly notify VGHOA 654-9552 of any suspicious people or unusual activity or after hours notify Clemson Police Department (dial 911)
- 8. **FIRE PROCEDURES:** If you discover a fire in your unit, please do the following:
 - a. Call the fire department immediately (land line 911 or from your cell phone 864-656-2222) and tell the dispatcher your apartment number,
 - b. Also notify CRE and your managing company.
 - c. Without delay leave your apartment and be sure to close the door behind you. Leaving it Unlocked. Alert others in the building immediately.

NO BASKETBALL, BASEBALL, OR ANY GAMES PLAYED IN THE PARKING LOT OF VILLAGE GREEN AFTER 11 :00 PM.

THESE RULES AND REGULATIONS ARE PROPOSED FOR THE GOOD OF ALL, IN THE HOPE THAT THEY WILL MAKE LIVING AT VILLAGE GREEN BOTH PLEASANT AND COMFORTABLE FOR YOU AND YOUR NEIGHBORS.
