

GDPR Policy for Little Bees Tutoring

1. Introduction

Little Bees Tutoring, operated by Laura Day, is committed to protecting the privacy and data of its clients and visitors. This GDPR (General Data Protection Regulation) policy outlines how we collect, use, disclose, and safeguard your personal data. It also explains your rights and choices regarding your data.

2. Data Controller

The data controller for Little Bees Tutoring is Laura Day, who is responsible for ensuring the protection and proper use of your personal information. The online booking system and payment processor 'Stripe' are also considered data processors.

3. Data Collection

We collect personal data to provide tutoring services. This data may include:

- Contact Information: Name, address, email address, and phone number.
- Student Information: Age, school, year group, learning needs, and progress reports.
- Communication: Correspondence between you and Little Bees Tutoring.
- Session Information: Records of face-to-face tutoring sessions.

4. Data Usage

We use your data for the following purposes:

- Payment Processing: With third-party payment processors, such as 'Stripe,' to facilitate billing through the online booking system.
- Legal Obligations: To comply with legal requirements or court orders.
- Consent: With your explicit consent for other purposes.

6. Payment Information and Processing

7. Data Security

We take appropriate measures to protect your data from unauthorised access, disclosure, alteration, or destruction. This includes using secure data storage and transmission methods.

8. Data Retention

We retain your data only as long as necessary to fulfil the purposes outlined in this policy or as required by law. You may request the deletion of your data at any time, subject to legal and contractual obligations.

9. Your Rights

You have the following rights regarding your personal data:

- Access: You can request access to your personal data.
- Rectification: You can request the correction of inaccurate data.
- Erasure: You can request the deletion of your data, subject to legal requirements.
- Restriction: You can request the restriction of data processing under certain conditions.
- Data Portability: You can request the transfer of your data to another party.
- Objection: You can object to the processing of your data in specific situations.
