I was held without bail for 19 months and went through 2 Federal trials. I was acquitted by a jury. I not only believe the second amendment was meant to protect our ability to stand in defense of our rights I defended the notion with my life on the line in a courtroom. I faced over 100 years in federal prison. I could have taken a plea for 10 but instead, I faced the jury and the DOJ's 97% conviction rate. I stood on my constitutional right to self-defense and the defense of others.

I believe we have to do 3 things to uphold our natural rights.

Claim them, use them, and defend them.

If we don't do those three things they are nothing but good ideas.
