We are open daily for congregate lunch at the Fritz Hendrix Memorial Building Monday – Thursday 11:00 a.m. to 1:00 p.m. and on Fridays, we serve brunch from 9:30 a.m. – 11:00 a.m. The Gracemont Congregate is located at the Assembly of God dining hall in Gracemont, OK. They are open Monday - Thursday 11:00 a.m. to 1 p.m. We encourage our Elders to come by and pick up a menu and/or check it out on our Caddo Nation AoA FB page.

Menu: Our menu items are selected by suggestions from our current participants at both Congregates and our deliveries. Suggestions are taken throughout the month and the menu is ready by the last Monday prior to the $\mathbf{1}^{\mathrm{st}}$ of the month. Each day is planned according to the food pyramid for elderly adults and liberalized diets for the general elder population. (Condiments are available and some are high in sodium and contain sugar.) We will be continuing with comfort foods to keep everyone nice and full for the remaining winter months.

Our meals are made "from scratch" and this takes a lot of time and preparation, but we believe the outcome is worth it; I applaud my staff for getting the meals out in a timely manner. The compliments I receive on the taste and appearance speak for themselves. We try new menu suggestions as well as toss in some good comfort foods.

Funding: Our program continues to operate off of grants awarded through ACL; our FY 2025 began today April 1, 2025. ACL grants are Title VI - Part A, Title VI - Part C, NSIP and MIPPA. The Gracemont Congragate is supplemented by a grant awarded by Pathways which is through the Oklahoma Health Care Authority.

AARP SCSEP: Caddo Nation of Oklahoma had partnered with AARP to become a host agency who will train low income or unemployed elders, 55 and older, new skills that will assist them with making their way back in to the work setting through a training program. We here at AoA will assist elders in filling out the application for SCSEP and they can work here at the Caddo Nation of Oklahoma, if there are any available positions. In the occurance that there is not any available positions, we can assist with trying to find placemen in other host agencies in the area. Please apply if interested, they are part time positions at minimum wage

Our program continues to wor with the CHR and Social Services program on various tasks. If we receive a call regarding an elder, thour team goes out and assesses them as needed and refers them to the appropriate people.	
GENERAL ELDER ASSISTANCE	We have aided 14 participants this quarter with lending closet items and have given away PPE to 4 participants. I have aided 9 elders in completing paperwork/applications and have assisted 5 with putting a Will in place through the American Indian Wills Clinic event held with the Wichita's, typed up simple things for 4 elders. Elders come in to the office for this type of assistance; 2 elders has come in regularly and worked on their items themselves in the Elder's activity room for computer services. Two elder has brought in clothing items so that I could make alterations to assist with fall prevention.

Report from Caddo Nation CHR/Diabetes Program:

The Caddo Nation's Community Health Program is funded by Indian Health Services on a yearly basis to assist Caddo Tribal Members with their health needs. The CHR Program's purpose is to assist eligible Native American individuals and families within our service area to gain access to comprehensive health care services.

All CHR staff members are trained in CPR, First Aid and EMS First Responder.

The CHR Program is often a vital link to health care services for our Native people in rural areas. Our work includes making and rescheduling appointments for clients, pick and delivery of medications, home visits, case screening and management, monitoring patients and health education.

The Caddo Nation Special Diabetes Program assists all Diabetic Tribal members with diabetic assistance. We have a Podiatry Clinic twice (2) a month. We provide diabetic (wellness shoes) once per year. We also provide diabetic supplies, medical assistance.

Since its establishment, the Caddo Nation Environmental Protection (CNEP) program has secured several grants through the Environmental Protection Agency (EPA), including the General Assistance Program (GAP), Clean Water Act Section 106 (CWA), and Clean Air Act Section 103 (CAA). Additionally, CNEP has received funding from the Bureau of Indian Affairs (BIA) to support climate resiliency initiatives, natural resource education, and invasive species management within the Caddo Nation's jurisdiction. These funds enable CNEP to take proactive steps toward protecting our Tribal lands against the growing impacts of climate change. In the coming quarters, CNEP plans to apply for additional grants through both the EPA and BIA to expand its programs and enhance services for the Caddo Nation.

April is consistently a busy and productive month for CNEP, as it includes our annual observance of Earth Day—a global event aimed at raising awareness of environmental issues and promoting sustainability. The Caddo Nation's Earth Day celebration takes place every April, and this year's activities included a roadside cleanup along our stretch of Highway 281. Participants collected 16 bags of trash, each holding 40 gallons, demonstrating how small efforts can collectively contribute to the beautification of our lands and properties. In addition to hosting our own event, CNEP attended the Comanche Nation's Earth Day celebration, where we engaged with community members about shared environmental concerns and the interconnectedness of environmental issues. Also in April, CNEP participated in the EPA Region 6 Tribal Caucus and the Regional Tribal Operations Committee (RTOC) quarterly meetings. While this quarter's sessions were held virtually, in-person meetings are scheduled for July in New Mexico. CNEP proudly represents our region on the RTOC.

In May, Environmental Specialist Brandon Worcester and Conservation Field Technician Kolby Williams represented CNEP at the National Tribal Forum on Air Quality (NTF) in California. The NTF is an annual event that brings together Tribal environmental professionals, EPA officials, and other stakeholders to exchange insights on air quality management in Tribal communities. Air quality remains a top priority for CNEP, and we continue to work diligently to protect the health and well-being of our Tribal members. June brought two exciting opportunities for CNEP. First, in partnership with Northern Arizona University, we welcomed an air quality intern, Rebecca Zewdie. A junior at American University in Washington, DC, Rebecca is committed to deepening her understanding of the environmental challenges faced by Indigenous communities. Also in June, CNEP partnered with the Comanche Nation to host the 2nd Annual Wildlife Explorers Environmental Camp. The camp, designed for children aged 9–14, featured interactive stations that provided environmental education and cultural enrichment. The camp's mission is to inspire the next generation by fostering a deeper connection to the environment and tribal heritage.

During the third quarter (April–June 2025), the Caddo Nation Environmental Protection Program (CNEP) provided Roll-Off Dumpster Services to six Tribal members. This service assists community members with the proper disposal of large volumes of waste, helping to maintain cleaner homes and properties across the Caddo Nation jurisdiction.

To ensure equitable access to this limited-capacity service, the following policy is in place:

"If you have received service within the same EPA calendar year (October – September), you will be placed on a waitlist until the next funding period."

This approach allows more Tribal members the opportunity to benefit from the program. Roll-off services are offered on a first-come, first-served basis, with availability three times per quarter. Service is scheduled according to the following calendar:

- 1st Quarter: October – December - 2nd Quarter: January - March - 4th Ouarter: July - September - 3rd Quarter: April – June

CNEP also offers in-home mold inspection services to Tribal members. All CNEP staff are certified mold inspectors and provide the following:

- On-site inspections and environmental assessments
- Air or surface mold sampling (as needed)
- Education on mold prevention and safe remediation practices

Our services are aimed at promoting healthier indoor/outdoor environments by identifying and addressing potential hazardous and mold-related health risks. For further information on any services provided or information on the CNEP programs, please contact us.

George's Department Store Report

As of today July 21, 2025, George's Department Store is located 124 W. Broadway in Anadarko. We are open Monday-Saturday 10am-6pm and closed every Sunday. Raven Cook is the current store manager and has been since December of 2023.

George's currently has four employees: Elizabeth Clark full time since 2024 and Calin Tillis part time since May 2025. We are currently welcoming two new employees this month: Kareriss Williams and Paige McCullough for part time. They will complete our team and give us the extra hands we need as we prepare to get back into setting up at pop-up events, as well as prepare for the back to school and the holiday season.

George's are still currently growing and learning what our community needs are and what they want to see being added to the store. We know we are a work in progress, and we take customer feedback seriously.

As of right now we currently have continuous partnerships with Caddo Nation CHR, Apache Tribal CHR, Kiowa Tribe CHR, and the Wichita CHR programs. Where we provide diabetic shoes for their tribal members. We also have a partnership with the Kiowa, Apache, and Wichita workforce programs, we provide work clothes and shoes for their members.

We have a great partnership with Caddo Nation Child Care. They ordered 920 backpacks from us this year. We just finished getting all the bags in and we delivered them to Child Care. Child Care also bought kids shoes from us back in April and we assisted them in handing the shoes out to Caddo members at the last membership meeting. CNCC has also given us the opportunity to provide work clothes to their Native Summer Learning Camp staff, and we are preparing to host 40 of the Native Summer Learning Camp children on Friday July 25th for a

back-to-school shopping experience that CNCC has given them for a camp incentive for attending camp regularly.

We have also helped many departments within Caddo Nation to help bring uniforms to Caddo Nation Employees. We greatly appreciate our partnership, and they are our focus as it helps to grow George's Department Store. In the months to follow we are going to be reaching out to more businesses and more local tribal departments to help bring even partnerships to George's as well as getting back into the communities and setting up our merchandise at pop-up events around Anadarko.

George's Department Store will continue to work to provide the Anadarko community with affordable quality items for everyone.

The Caddo Nation Human Resources Department is responsible for:

- Helping employees with the onboarding process
- Addressing employee questions and concerns
- Maintaining employee policies and procedures
- Communicating and implementing tribal administration and departmental changes
- Conducting disciplinary actions
- Processing terminated and retiring employees
- Maintaining employee benefits
- Processing employee payroll along with finance department

Caddo Nation has grown so much. As of 7/21/25, we currently have 97 employees; there are 87 full-time and 10 part-time employees within 26 departments and stores.

We've had 14 new employees hired in this quarter. We've had 7 voluntary terminations and 4 involuntary terminations.

Lita Smith, Human Resources Assistant, has earned the Tribal Human Resources Professional II Certification at a Native American Human Resources (NNAHRA) Training in Indiana in June 2025.

We enjoy working for Caddo Nation and look forward to helping continue to grow along with the Nation. Thank you for the opportunity to do so!

The Caddo Nation Pathways Program continues to operate under the Pathways to Community Living Grant from The Oklahoma Healthcare Authority. The grant was awarded and started October 15th, 2024. The Pathways Program provides a comprehensive holistic quality service that is unique to the Caddo Nation tribal members, other tribal affiliation members, or community members that are Medicaid recipients. Pathways provides services to enable Elders to maintain in their home, assist in transitioning from hospitals and skilled nursing facilities back to their place of residence, and enrolling those who qualify into Medicaid. Members do not need to reside within the Caddo Nation jurisdiction.

Services include but are not limited to overall health assessment, assistance with distribution of medication, wound care, routine hygiene, light house duty, meals, transportation to and from doctor visits or to a Caddo Nation facility for use of Telehealth, and errand running.

Telehealth is available at two locations: the Caddo Nation AOA in Binger, OK and the Community Health Building in Anadarko, OK.

Pathways also allows members to have additional support for the families by providing monthly and/or individualized training necessary for ease and continuation of care.

The funding provided by the grant allows the purchase of durable medical equipment for Pathways recipients. DME includes but is not limited to first aid/emergency response, cleaning supplies, wheelchairs, walkers/rollators, crutches, ramps, shower chairs, semi-electric hospital beds, body/fall alarms, heating aids, CPAP machines & supplies, Oxygen concentrators & tubing, nebulizers, diabetic supplies, wound care supplies, and incontinence supplies, etc.

The Caddo Nation Pathways Program works in cooperation with Caddo Nation CHR, AOA, and Social Services/ICW departments.

Of the AOA and Social Services/ICW departments, Pathways is able to provide the salaries for the SS/ICW Case Manager, AOA Cook(s), Cook Assistant(s), and two meal delivery drivers.

Pathways supplements the AOA program by funding the meals served at AOA in Binger, Congregate held at Gracemont Assembly of God, and meals delivered to those who are serviced by the AOA.

Caddo Nation Pathways Program and AOA are in negotiations with Fort Cobb Senior Center to obtain a budget to provide the food for their center and meal deliveries. Fort Cobb is home to many Caddo members along with other tribal affiliated members.

The fiscal year for Pathways to Community Living Grant ended June 30th, 2025. Since the time of Caddo Nation being awarded the grant in October 2024, the Pathways program has acquired 25 members, and assisted members of the Caddo Nation CHR, AOA, and Social Services/ICW departments. Out of the 25 members, few have been on referral from the Bureau of Indian Affairs and other tribes in the area.

From March to June, Pathways care team had 474 transports and 160 home visits.

We are continuously working on ways to reach out to the community to advertise the benefits of our program, along with networking with other tribes and nations across the state and country to improve our program.

APRIL 2025- The security department for the month of april 2025 took a total of (6) incident reports. The departments mileage for the month was (13,143) driven while on patrol "noting" there are (4) vehicles assigned to the security department. The miles reflected above are the total miles driven between (4) vehicles.

MAY 2025- The security department for the month of may 2025 took a total of (3) incident reports. The reports consisted of 1.work related injury 2.public disturbance 3.vehicle damage. The departments mileage for the month was (12,077) driven while on patrol "noting" there are (4) vehicles assigned to the security department. The miles reflected above are the total miles driven between (4) vehicles.

JUNE 2025- The security department for the month of june 2025 took a total of (3) incident reports. The reports consisted of 1.inappropiate physical contact 2.public disturbance 3.person falling(injured). The departments mileage for the month was (10,921) driven while on patrol "noting" there are (4) vehicles assigned to the security department. The miles reflected above are the total miles driven between (4) vehicles.

The caddo nation security department consist of a chief of security and a asst.chief along with (5) security guards which (4) are cleet certified and (1) is currently in training. Bringing the total staff employed with the security department to (7) employees. The department continues to protect and secure all assets owned by the caddo nation. All patrols are daily thru (3) shifts this includes the tribal complex, the town of gracemont which consists of the housing authority and the caddo travel plaza and a church which sits right next to the travel plaza. Patrols also go to the town of Anadarko these patrols along with the building checks include mckee's indian store, georges department store, the newly acquired redskin theater, the chr/social service offices. The other building included in the patrols is shamrock financial which the tribe owns the building not the business. Also regency oaks elder apartments and activity building. The security dept continues to patrol to the town of hinton for the child care center which is currently under construction. Also located north east of hinton on Methodist road a newly acquired property with buildings for future tribal operations.

The Caddo Nation Social Services- Indian Child Welfare Program is responsible for monitoring children who are placed in guardianships (permanent/temporary), have an active state child welfare investigation, Family Centered Service Plan, or is in an out of home placement in foster care. These children can be in the State of Oklahoma or any other part of the United States. We also are involved with adults due to their age or disability that are unable to care for themselves or do not have an appropriate care giver. The Social Services Indian Child Welfare program is responsible for the intake and process of Crisis and Li-heap applications, and to oversee IIM accounts when needed. The Social Service department has been approved to aide families with weatherization units if they are home owners

Child Welfare State Custody

There is a total of 31 Children who are members or eligible membership with the Caddo Nation.

These children have multiple case plans from reunification to adoption.

Child Welfare State Investigations/Tribal Verification

Caddo Nation ICW receives multiple notifications of Tribal verification of Child Welfare investigations of possible eligible or enrolled Caddo Nation children. (Not all children are eligible for enrollment with the Caddo Nation, enrollment verification is verified through the Caddo Nation Enrollment office.)

The Caddo Nation SS ICW have participated in has participated in in person and virtual court hearings in Oklahoma, Caddo, Comanche, Grady. Cleveland, Kay, and Garfield Counties in the state of Oklahoma. ICW has participated in virtual court in the states of, Colorado, Kentucky, Texas, Iowa, California and Arkansas.

The Caddo Nation SS ICW program sees children in Oklahoma State custody in person at a minimum of every 45 days. The ICW program completed the worker visits in the areas of OKC, Shawnee, Lawton, Sapulpa, and Purcell. The ICW program speaks with placement providers, permanency workers, service providers, and the court. Children who are out of state the Caddo Nation ICW monitors the cases by completing virtual home visits, and speaking with placement providers, permanency workers, service providers, and the courts.

Guardianship

There are 30 Caddo Nation children placed in guardianships through the Southern Plains Court of Indian Offences, 1 child in the Seminole Court, and 2 in State Guardianships. The Caddo Nation has 1 adult in a permanent co guardianship,

The Caddo Nation are required to complete worker visits for children and families in guardianships with the BIA who have had recent court hearings, and to work with the children

and families to help preserve the family unit if requested by the guardian or bio parent. These children that are in out of home care are in homes all over the state of Oklahoma.

Social Services

The Caddo Nation is involved with helping families ensure the elderly and disabled are receiving the care that is needed for their health and well-being. The Caddo Nation SS works cooperatively with the Caddo Nation Nurse and CNA, Administration on Aging, Caddo Housing, CHR programs, and other outside resources to ensure the needs of the individual are met.

Trainings and Meetings

Caddo Nation SSICW Participates in meetings and trainings with the Southern Plains Child Protection Team, Oklahoma Indian Child welfare Association, the National Indian Child Welfare Association, and QIC-EY.

The Caddo Nation has a parent child visitation center available for families at the Anadarko Office at 211 West Main. The visitation room has the ability to have recorded sessions.

The Caddo Nation Social Services office at 211 West main will be providing community events in regard to parenting classes, UAs for families we are working with, cultural activities, and family fun nights. The Social Services Department is working on getting state certification for all services.

April 2025 – The SORNA Department for the month of April, the SORNA Department had 1 offender come in for registration. The offender filled out the necessary paperwork, the Registry Coordinator notified of their next registration. Updated offender information on TTSORS Website. The SORNA Department continued operations out of the security building and are continuing SORNA education on online training.

May 2025 – The SORNA Department for the month of May, The SORNA Department did not have any offenders come in for registration. The SORNA Department continued training of SORNA online to better help operations of the SORNA Department.

June 2025 – The SORNA Department for the month of June, the SORNA Department had one offender come in to register for their annual registration. With the offender coming to register they filled out the necessary paperwork for the registration. After they filled out the paperwork, the Registry Coordinator would notify them of their next registration appointment. Then the Registry Coordinator took the paperwork for the registration, and entered and updated the offenders profile to keep up to date on the TTSORS website.

The SORNA Department currently has 2 employees under the SORNA Grant.

Nyles Parton is the SORNA Grant Supervisor, which oversees the Grant and the work completed by the SORNA Registry Coordinator. Baylen Bullcoming is the SORNA Registry Coordinator, which enters the sex offenders' information and registration into TTSORS every time they come in to register. This includes criminal history, physical descriptions, driver's license employment history, employer address, and etc. The 2 SORNA employees are taking online training and classes for the SORNA Grant. The Registry Coordinator is in charge of keeping the sex offenders records up to date, if anything changes with the sex offenders. The SORNA Department has 2 sex offenders. 1 offender is currently incarcerated, and the other sex offender comes in regularly for registration. Depending on the sex offenders offense, the sex offender will have to register annually for 15 years, every 6 months for 25 years, and or every 3 months for life.
