- Biden Administration and Trump Administration Executive Orders
- On January 30, the seven tribal leaders of western Oklahoma will meet at Susan Peters Gallery in Anadarko to discuss the implications of the recent Trump Administration Executive Orders.

### **Caddo Nation Constitution Reform Update by Stacey Halfmoon:**

- Ad Hoc Committee has been meeting, researching, and formed recommendations that were submitted to the Tribal Council on January 23. Ad Hoc committee members: Dr. Lindsay Robertson (OU College of Law), Stephen Ward (Connors and Winters), and Jonathan Rohrer (Caddo Nation THPO)
- Shared Phase 1 activities: historical research, researched other tribal constitutions, interviews with various tribal leaders and tribal court experts.

- Moving into Phase 2: On January 23, Tribal Council passed Resolution 01-2025-06 to establish Caddo Nation Constitutional Commission composed of 8 community members to be nominated by Tribal Council.
