We are open daily for congregate lunch at the Fritz Hendrix Memorial Building Monday – Thursday 11:00 a.m. to 1:00 p.m. and on Fridays, we serve brunch from 9:30 a.m. – 11:00 a.m. The Gracemont Congregate is located at the Assembly of God dining hall in Gracemont, OK. They are open Monday – Thursday 11:00 a.m. to 1 p.m. We encourage our Elders to come by and pick up a menu and/or check it out on our Caddo Nation AoA FB page.

Menu: Our menu items are selected by suggestions from our current participants at both Congregates and our deliveries. Suggestions are taken throughout the month and the menu is ready by the last Monday prior to the $\mathbf{1}^{\text{st}}$ of the month. Each day is planned according to the food pyramid for elderly adults and liberalized diets for the general elder population. (Condiments are available and some are high in sodium and contain sugar.) At this time, a majority of our elders have stated they prefer and enjoy the summer type meals such as: sandwiches (which come with lettuce, tomatoes, onions, pickles), salads (potato, pea, macaroni, pasta, green), and other menu items that aren't so heavy.

Yearly report: We have just recently submitted our final FY23 report to ACL. A brief summary: Congregate meals served 1388 with 134 eligible non-duplicated participants, home delivered meals served 5423 with 47 eligible non-duplicated participants. Nutrition education – 12, nutrition counseling – 27; with 14 hours of nutrition counseling. Number of contacts of information/assistance – 512, outreach activities – 16, unduplicated number of persons receiving case management (total number of house of case management 61), unduplicated number of persons receiving transportation – 59, total one-way trips of transportation – 203. Unduplicated number of persons receiving homemaker services – 9 with 18 AoA hours of homemaker services (not contracted). Unduplicated number of persons receiving personal care/home health aide services – 11 with total number of hours being 424. Unduplicated number of persons receiving chore services – 17 with 288 hours. Number of contacts visiting 429, numbers of contacts telephoning 481. Number of social events held – 32. Number of persons receiving health promotions and wellness activities - 294. Number of visits to persons in nursing facilities/homes or residential care communities – 6.

<u>Activities:</u> We are currently in the planning stages of our fall activities. We schedule these activities with other Elder participants from the CHR program. Currently on the agenda is the State Fair of Oklahoma trip which is Wednesday, September 18, 2024. If you are interested in attending, please notify Mrs. Sharla Moore or myself.

Funding: Our program operates off of grants awarded through ACL. Those are Title VI – Part A, Title VI – Part C & NSIP (we recently received and have just submitted the budget for), and MIPPA. The Gracemont Congragate and our program is supplemented by a grant awarded by the Caddo Nation. We are pleased that we will be able to better assist our participants with assistance through the Caddo Nation Pathways Program that is granted by the OHCA (Oklahoma Health Care Authority). That program will require Medicaid participation. Staff will be able to assist Native Americans with assistance in filling out an application for Medicaid. Our program is also able to use elder workers part time through AARP; please apply if interested, they are part time positions, M - F, 4 hours a day at minimum wage.

GENERAL NOTES	Congregate is open, we are having more elders dine, and we are averaging 6 – 8 daily, Gracemont Congregate averaging 16 – 20 and we currently have 25 deliveries. We welcome anyone enrolled Native American 55 and over to come and dine with us.

	TITLE VI Part C – CAREGIVER
LENDING CLOSET	The following items are in stock and are available: wheelchairs, walkers, motorized scooter, elevated raised toilet, shower chair, bed side commode, inflatable ring, walking canes, crutches, briefs, binders, back support, hand brace, and wound care supplies. The lending closet items are available for elder use through our Caregiver program. You may sign any of these items out if needed. *Currently out of coccyx cushions, wheelchair cushions and bariatric supplies: wheelchairs & walkers. <i>Must be in AoA service area.</i>
RESPITE PROGRAM/ ELDERCARE CHORES	We have not assisted any participants with respite; we've refered 4 elders to other programs for assistance with eldercare chores. These programs provide the opportunity to plan, develop, and implement family caregiver support programs for the benefit of non-paid family members (not living in the home) caring for their elders and grandparents caring for their grandchildren. <i>Must be in AoA service area.</i>
LAWN CARE	The lawn care program is currently taking applications. We will are limited to 10 elders, it will be partnered through the Caddo Nation Pathways Program. Eligibility will be determined as Pathways is under the OHCA and Medicaid information will need to be submitted. *Staff is available to assist with Medicaid application if you are not a current Medicaid recipient.
WELLNESS CHECK	We have made 4 wellness checks, provided supplies for 3 of those participants, 6 transports for people this quarter; currently we are monitoring 1 elder in long term care facilities. Our program continues to work with the CHR and Social Services program on various tasks. If we receive a call regarding an elder, then our team goes out and asses them as needed and refers them to the appropriate people.
GENERAL ELDER ASSISTANCE	We have aided 7 participants this quarter with lending closet items and have given away PPE to 3 families. I have aided 4 elders in completing paperwork/applications and have typed up simple things for 2 elders. Elders come in to the office for this type of assistance; 2 elders have come in and worked on their items themselves in the Elder's activity room for computer services.

The expenses made were general monthly bills and employee wages.
The caregiver support program includes the Lawn Care/Chores Program, Respite Program, Lending Closet and
Health Program. Please call the AoA Building for further information on any of our programs. *We will be
adding additional services that will fall under the Caddo Nation Pathways Program.

The regulation defines a Change in Key Personnel as the replacement or change in status (such as an absence for any continuous period of 3 months or more, or reduction of time devoted to the project by 25 percent or more from the level in the approved application) of the Principal Investigator/Project Director (PI/PD).

- 5. Overlapping Projects: Recipients with overlapping projects must be specifically cautious that approved costs on any budget, including match or cost share (if applicable), are not also included on any other federally financed program in either the current or a prior period.
- 6. The award recipient is legally and financially responsible for all aspects of this award including funds provided to subrecipients, in accordance with 45 CFR § 75.351 Subrecipient and Contractor Determinations and 45 CFR § 75.352, Requirements for Pass-Through Entities.
- 7. Closeout Requirements: A final FFR and a final PPR are due within 120 days after the expiration of the project period of this NoA. Per 2 CFR 200.344, all subrecipients must submit all financial, performance, and other reports to the pass-through entity no later than 90 calendar days after the period of performance. The Federal awarding agency or pass-through entity may approve extensions when requested and justified by the subrecipients, as applicable.
