Job Summary:

The Child Care Subsidy Monitor approves and monitors the Caddo Nation Child Care subsidy providers and serves as a member of the Child Care Team in cooperation with all staff members, being professionally in job performance, complying with the confidentiality policy and personnel policies and procedures. Must be aware of health and safety policies, criminal background check procedures, quality education standards and identifying child abuse and neglect. Have training and experience as an advocate for young children and their families to include mental health, parent involvement, and disability services. Assists in writing monitoring and enforcement policies and procedures. Accepts applications and considers approval or denial of providers for Caddo Nation Child Care Subsidy programming. Monitors program annually for compliance with licensing requirements and criteria. Investigates complaints. Coordinates with appropriate programs to refer providers and families for emergency assistance in case of crisis or emergency situations.

Qualifications:

At least 3 years of working at a state licensed child care facility or licensing monitor capacity. Knowledge of the principles, practices, and objectives of the Child Care Development Fund Program (CCDF) and understanding of child development health and safety policies and practices. Knowledge of modern office practices and procedures and Business English, spelling and math. Typing skill and experience with Excel, Word, and Publisher.

Basis of Rating: An evaluation of education and experience will be conducted on qualified applicants. Please submit a brief summary describing how you meet the qualifications as listed above.
