We are open daily for congregare lunch at the Fritz Hendrix Memorial Building Monday – Thursday 11:00 a.m. to 1:00 p.m. and on Fridays, we serve brunch from 9:30 a.m. – 11:00 a.m. The Gracemont Congregate is located at the Assembly of God dining hall in Gracemont, OK. They are open Monday – Thursday 11:00 a.m. to 1 p.m. We encourage our Elders to come by and pick up a menu and/or check it out on our Caddo Nation AoA FB page.

January we opened our Gracemont Congregate and welcomed Ms. Janet Lee to our team. The congregare has remained steady in numbers. AoA celebrated Heart Health when we partnered with the CHR program in February. In March the Caddo Nation of Oklahoma AoA partnered with CHR & Social Services and held an “Elder Fun Day” in Gracemont Oklahoma. A fun time was held by all. Ms. Alana Tahlate joined AoA for recent activities of crafting Valentine’s Day Greeting Cards with phrases in the Caddo Nation Language as well as creating the family tree with old family photos. Both events were great and informative and Ms. Alana had a wonderful turn out. We try to host 2 events monthly, one general activity and one with Ms. Anana Tahlate. Our AoA activities room and health room are open daily. We have a computer with internet access for elders to use as needed. We encourage elders to come in and sit, have a visit, tell us some of your stories, speak some Caddo so that we may become more familiar. Come share a good meal and enjoy some leisurely time in our living area.

We have just recently completed our FY through ACL on March 31, 2024. Our program operates off of grants awarded through ACL. Those are Title VI – Part A, Title VI – Part C, NSIP and MIPPA. The Gracemont Congregate and our program is supplemented by a grant awarded by the Caddo Nation that will allow to buy better quality food and provide a better delivery system so that staff can reach out to those most vulnerable clients in our rural areas affected by COVID 19. We saw a need and are grateful to be able to satisfy the necessities to keep our Elders fed.

We, the Caddo Nation of Oklahoma Health Services Programs (AoA, CHR, Tribal Nurse & Social Services) have submitted our final budget and application to OKHCA regarding the Pathways grant; in our latest meeting with them we were told that we should receive notification within 30 days. We are all excited at how this will allow us to further help and benefit our programs in reaching out and assisting our elder community and will work for our Caddo members within the state of Oklahoma as well as other federally recognized tribal members in our service area. It is funded by the Oklahoma Health Care Authority. In addition to seeking funding opportunities, we are still working with AARP to try and provide Seniors to receive on the job training and placement within the Caddo Nation departments. They will be part time positions, M – F, 4 hours a day at minimum wage. We have submitted to AARP and are awaiting placement.

GENERAL NOTES	Congregate is open, we are having more elders dine, and we are averaging 4 – 8 daily. We welcome anyone enrolled Native American 55 and over to come and dine with us.

TITLE VI Part C – CAREGIVER

LENDING CLOSET	The following items are in stock and are available: wheelchairs, walkers, motorized scooter, elevated raised toilet, shower chair, bed side commode, inflatable ring, walking canes, crutches, briefs, binders, back support, hand brace, and wound care supplies. The lending closet items are available for elder use through our Caregiver program. You may sign any of these items out if needed. *Currently out of coccyx cushions, wheelchair cushions and bariatric supplies: wheelchairs & walkers. Must be in AoA service area.
RESPIRE PROGRAM/ ELDERCARE CHORES	We assisted 3 participants with respite and 8 with eldercare chores this service this quarter. These programs provide the opportunity to plan, develop, and implement family caregiver support programs for the benefit of non-paid family members (not living in the home) caring for their elders and grandparents caring for their grandchildren. Must be in AoA service area.
LAWN CARE	The lawn care program is closed and complete for the year. Recently we partnered with EPA on a project and it came out well.
WELLNESS CHECK	We have made 9 wellness checks, provided supplies for 5 of those participants, 4 transports for people this quarter; currently we are monitoring 1 elder in long term care facilities. Our program continues to work with the CHR and Social Services program on various tasks. If we receive a call regarding an elder, then our team goes out and asses them as needed and refers them to the appropriate people.
GENERAL ELDER ASSISTANCE	We have aided 16 participants this quarter with lending closet items and have given away PPE to 2 families. I have aided 9 elders in completing paperwork/applications and have typed up simple things for 2 elder. Elders come in to the office for this type of assistance; they will work on their items themselves in the Elder’s activity room or they will have me to help them complete their task. We’ve had interest in one elder coming in to use the services.

EXPENSES	The expenses made were general monthly bills and employee wages.
GENERAL NOTES	The caregiver support program includes the Lawn Care/Chores Program, Respite Program, Lending Closet and Health Program. Please call the AoA Building for further information on any of our programs.

CADDO NATION EMERGENCY MANAGEMENT

The Caddo Nation Emergency Management is committed to the sustainable future and preparedness, protective, mitigation, response and recovery of the membership and their communities prior to, during, and after impact by an incident or disaster. Our work with FEMA Region VI, Bureau of Indian Affairs (BIA), Oklahoma Department of Emergency Management Homeland Security (ODEMHS), and participation in the Southwest Region Emergency Preparedness Team and other agencies that are vital in helping to improve the safety of life and property and the environment of our tribal members. There are two (2) full time staff and a host of volunteer team members ready to respond to any tribal member or community impacted.

The Caddo Nation Emergency management continues to research and submit for numerous grants through Federal, Tribal, and State. The Caddo Nation Emergency Management has submitted a Building Resilience Infrastructure Community Grant and second Assistance Fire Grant, for Fire Prevention and Safety. The staff attended the FEMA Region 6 Tribal Summit in Denton, Tx, there were 22 tribes from 5 states, we discussed the needed changes in federal response funding and programs for Indian nations and country. Staff also attended the 2024 annual Oklahoma Emergency Management Association conference at Choctaw Nation.

The Caddo Nation Emergency Management is currently in meeting with Bureau of Indian Affairs (BIA) to revive the Caddo Nation Fire Response Team, the nation currently has four (4) wildland brush apparatus that have been mechanically serviced and have been approved in meeting the BIA Criteria, currently have advertising to fill the position of a full time Fire Management Coordinator, this was included the awarded Assistance Fire Grant that we received for \$525,000. The plans for the construction of fire station have been submitted to our construction team Arrowwood, with hopes to hold grand opening in Sept 2024.

January 2024- The security department for the month of January 2024 took a total of (2) incident reports those reports consisted of (1) improper use of tribal vehicle. (2) property damage. The department mileage for the month of January was (5954) miles driven while on patrol “noting” there are currently (3) vehicles assigned to the security department. The miles reflected above are the total between (3) vehicles.

February 2024- The security department for the month of February 2024 took (2) incident reports the reports consisted of (1) property damage to trailer, (2) suspicious person. The departments mileage for the month of February was (5237) miles driven while on patrol “noting” there are (3) vehicles assigned to the department. There was (1) more vehicle assigned to the department toward the end of the month totaling (4).

March 2024- The security department for the month of march 2024 took (3) incident reports the reports consisted of (1) banned customer, (2) damage to tribal owned vehicle, (3) disruptive customer. The departments mileage for the month of march was (8846) miles driven while on patrol “noting” that there are now (4) vehicles assigned to the dept.

The caddo nation security department continues to protect and secure all assets owned by the caddo nation. All patrols are daily thru (3) shifts this includes the tribal complex, the town of gracemont which consists of the housing authority and the newly acquired store. Patrols also go to the town of Anadarko these patrols along with building checks include mckee’s indian store and the newly acquired odot building which houses the tribes social service program and will soon house the chr offices. The other building that is checked during this is shamrock financial which the tribe owns the building not the business. Included on the patrol and building check is the current chr offices and regency oaks elder apartments. Patrols are also done to the town of hinton which will soon house the new child care facility.

Caddo Nation Education Programs

The Higher Education Program provides scholarships to qualifying tribal member college students. Scholarship amounts vary according to unmet need (as determined by the Federal Student Aid Program), and range between \$500.00 and \$3,000.00 per term. Scholarships are funded on a first come, first served basis for **completed** applications.

The Education Programs fiscal year begins on January 1st of each year. In the Higher Education Program, for CY 2024, we have had:

The Caddo Nation Adult Education Program provides assistance to qualifying tribal members who are seeking short-term training (one year or less), literacy instruction, cultural enrichment, or basic skills. The amounts of assistance vary according to the costs associated with the type of training/courses that the applicant will be taking. The maximum amount of funding for the training/course(s) is \$4,500.00 per academic year (Aug. 01 through July 31). Applications are funded on a first come, first served basis for **completed** applications. Eligible tribal members must reside within the jurisdiction of the Anadarko Agency (Caddo, Kiowa, Comanche, Cotton, or Tillman Counties in the state of Oklahoma). The numbers of applicants for the Adult Ed. Program tends to be very low because of the jurisdictional boundaries, which is not negotiable in our contract.

The Caddo Nation Job Placement & Training Program provides Job Placement (Direct Employment Assistance) and Job Training (Adult Vocational Training) to interested, and eligible enrolled Caddo Nation members. It provides vocational training assistance and/or assistance for starting new employment. The JP&T Program provides short-term and long-term training assistance, and/or other forms of assistance that would enable participants to train, retrain, and upgrade underemployed and unemployed workers in skill areas for which there is a demand in the labor market. The JP&T Program provides bi-weekly stipends for AVT students to assist with household expenses while in training. The amounts of assistance vary according to number of dependents and need.

Applications are funded on a first come, first served basis for **completed** applications (all requested documentation has been turned in, faxes/copies are not accepted). Eligible tribal members must reside within the jurisdiction of the Anadarko Agency (Caddo, Kiowa, Comanche, Cotton, or Tillman Counties in the state of Oklahoma). The numbers of applicants for the JP&T Program tends to be very low because of the jurisdictional boundaries, which is not negotiable in our contract.

Additional funding has been appropriated to the Education Department by the Caddo Nation Tribal Council. This funding allows us to assist more students who may otherwise miss out on funding opportunities, such as those who live outside the jurisdiction of the Anadarko Agency. The additional funds available for the Higher Education, Adult Education, and Job Placement and Training Programs are administered by the current guidelines of the P.L. 93-638 programs.

The Higher Education Program provides scholarships to qualifying tribal member college students. Scholarship amounts vary according to unmet need (as determined by the Federal Student Aid Program), and range between \$500.00 and \$3,000.00 per term. Scholarships are funded on a first come, first served basis for **completed** applications.

The Education Programs fiscal year begins on January 1st of each year. In the Higher Education Program, for CY 2024, we have had:

The Caddo Nation Adult Education Program provides assistance to qualifying tribal members who are seeking short-term training (one year or less), literacy instruction, cultural enrichment, or basic skills. The amounts of assistance vary according to the costs associated with the type of training/courses that the applicant will be taking. The maximum amount of funding for the training/course(s) is \$4,500.00 per academic year (Aug. 01 through July 31). Applications are funded on a first come, first served basis for **completed** applications. Eligible tribal members must reside within the jurisdiction of the Anadarko Agency (Caddo, Kiowa, Comanche, Cotton, or Tillman Counties in the state of Oklahoma). The numbers of applicants for the Adult Ed. Program tends to be very low because of the jurisdictional boundaries, which is not negotiable in our contract.

The Caddo Nation Job Placement & Training Program provides Job Placement (Direct Employment Assistance) and Job Training (Adult Vocational Training) to interested, and eligible enrolled Caddo Nation members. It provides vocational training assistance and/or assistance for starting new employment. The JP&T Program provides short-term and long-term training assistance, and/or other forms of assistance that would enable participants to train, retrain, and upgrade underemployed and unemployed workers in skill areas for which there is a demand in the labor market. The JP&T Program provides bi-weekly stipends for AVT students to assist with household expenses while in training. The amounts of assistance vary according to number of dependents and need.

Applications are funded on a first come, first served basis for **completed** applications (all requested documentation has been turned in, faxes/copies are not accepted). Eligible tribal members must reside within the jurisdiction of the Anadarko Agency (Caddo, Kiowa, Comanche, Cotton, or Tillman Counties in the state of Oklahoma). The numbers of applicants for the JP&T Program tends to be very low because of the jurisdictional boundaries, which is not negotiable in our contract.

Additional funding has been appropriated to the Education Department by the Caddo Nation Tribal Council. This funding allows us to assist more students who may otherwise miss out on funding opportunities, such as those who live outside the jurisdiction of the Anadarko Agency. The additional funds available for the Higher Education, Adult Education, and Job Placement and Training Programs are administered by the current guidelines of the P.L. 93-638 programs.

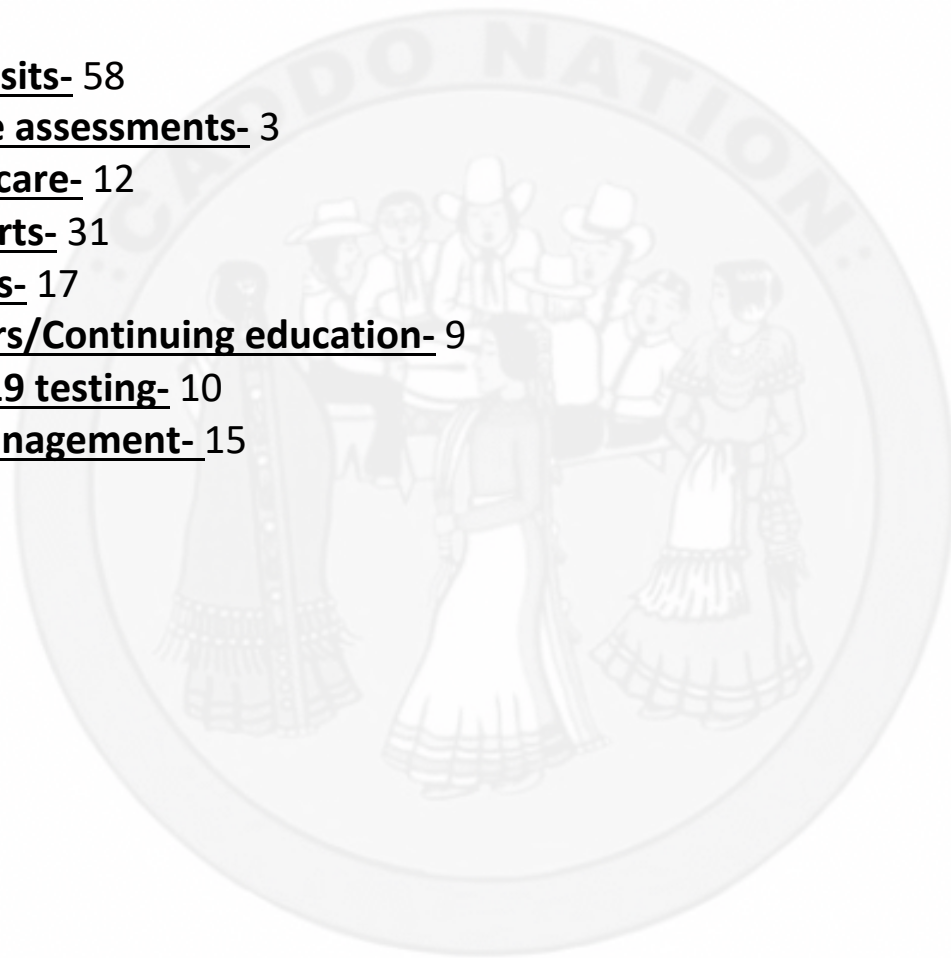

The Caddo Nation Social Services- Indian Child Welfare Program is responsible for monitoring children who are placed in guardianships (permanent/temporary), have an active state child welfare investigation, Family Centered Service Plan, or is in an out of home placement in foster care. These children can be in the State of Oklahoma or any other part of the United States. We also are involved with adults due to their age or disability that are unable to care for themselves or do not have an appropriate care giver. The Social Services Indian Child Welfare program is responsible for the intake and process of Crisis and Li-heap applications, and to oversee IIM accounts when needed. The Social Service department has been approved to aide families with weatherization units if they are home owners

Crisis and Li-heap Applications

The Caddo Nation this quarter has received and processed approximately 26 applications for li-heap or Crisis funds were approved for assistance 3 HVAC applications were approved

Child Welfare State Custody

There are a total of 18 enrolled Caddo and 3 eligible for enrollment with the Caddo Nation, with a total of 12 families. Listed below are those children's case plan goal, and status of custody. Currently

- Eight children in Permanent State Custody
 - One Child adopted
 - Two children are placed in identified adoptive homes.
 - Two children are placed in a Planned Alternative Placement; One child will age out of the system, two are in residential care.
- Twelve children and Five families with a Case plan goal of reunification
 - Five children are placed in the home with bio parent.
 - Four children placed in out of home care having supervised visitation with at least one of their parents.
 - Three children in a court supervision case

Child Welfare State Investigations/Tribal Verification

- Caddo Nation received 40 notifications of Tribal verification of Child investigations with possible eligible or enrolled child members.

The Caddo Nation SS ICW have participated in has participated in in person and virtual court hearings in Oklahoma, Custer, Okmulgee, Caddo, Comanche Counties in the state of Oklahoma. ICW has participated in virtual court in the states of Utah, Colorado, Kentucky, Texas, Iowa, and Arkansas.

The Caddo Nation SS ICW program sees children in Oklahoma State custody in person at a minimum of every 45 days. The ICW program completed the worker visits in the areas of OKC, Shawnee, Lawton, Sapulpa, and Purcell. The ICW program speaks with placement providers, permanency workers, service providers, and the court. Children who are out of state the Caddo Nation ICW monitors the cases by completing virtual home visits, and speaking with placement providers, permanency workers, service providers, and the courts.

Guardianship

There are 26 Caddo Nation children placed in guardianships through the Southern Plains Court of Indian Offences, 1 child in the Seminole Court, and 3 in State Guardianships. The Caddo Nation are required to complete worker visits for children and families in guardianships with the BIA who have had recent court hearings, and to work with the children and families to help preserve the family unit if requested by the guardian or bio parent. These children that are in out of home care are in homes all over the state of Oklahoma. The Caddo Nation has 1 adult in a permanent co guardianship ,

Social Services

The Caddo Nation is involved with helping families ensure the elderly and disabled are receiving the care that is needed for their health and well-being. The Caddo Nation SS works cooperatively with the Caddo Nation Nurse and CNA, Administration on Aging, Caddo Housing, CHR programs, and other outside resources to ensure the needs of the individual are met.

Caddo Nation SSICW Participates in meetings and trainings with the Southern Plains Child Protection Team, Oklahoma Indian Child welfare Association, the National Indian Child Welfare Association, QIC-EY.

The Caddo Nation has a parent child visitation center available for families at the Anadarko Office at 211 West Main. The Caddo Nation Social Services has applied for the Pathways Reimbursement and will be notified within the next 90 days if approved.

The Caddo Nation's Community Health Program is funded by Indian Health Services on a yearly basis to assist Caddo Tribal Members with their health needs. The CHR Program's purpose is to assist eligible Native American individuals and families within our service area to gain access to comprehensive health care services.

All CHR staff members are trained in CPR, First Aid and EMS First Responder.

The CHR Program is often a vital link to health care services for our Native people in rural areas. Our work includes making and rescheduling appointments for clients, pick and delivery of medications, home visits, case screening and management, monitoring patients and health education.

The Caddo Nation Special Diabetes Program assists all Diabetic Tribal members with diabetic assistance. We have a Podiatry Clinic twice (2) a month. We provide diabetic (wellness shoes) once per year. We also provide diabetic supplies, medical assistance.

Since its foundation Caddo Nation Environmental Protection (CNEP) has received numerous grants through the Environmental Protection Agency (EPA). These grants are the General Assistance Program (GAP), Clean Water Act 106 program (CWA), and Clean Air Act 103 Program (CAA). CNEP also has obtained funding from the Bureau of Indian Affairs (BIA), to build capacity towards climate resiliency, provide education on natural resources, and combat invasive species in the Caddo Nation Jurisdiction. With this funding CNEP will begin taking steps to better protect our Tribal Jurisdiction against the ever-changing climate. In the upcoming quarters CNEP will be applying for several grants through the BIA, and EPA. These additional grants will allow CNEP to expand and provide better services to the Caddo Nation.

Beginning in the January CNEP has begun meeting with the Comanche Nation EPA to discuss the upcoming Wilderness Explorers Environmental Camp that is being held at the Wichita Mountains Wildlife Life Refuge in June 2024. This camp is being designed to provide insight into careers in the Natural Resources field. The target audience for this camp will be 10 to 14-year-old children. Be on the lookout for more information about this camp. Also, during this month CNEP attended a Prescribed Burn workshop in Bixby, Ok at the Euchee Butterfly Farm. During this workshop CNEP learned about proper techniques for prescribed burning, and the added benefits it brings to our lands. CNEP is planning on starting a prescribed burn association and will be in partnership with the United States Fish and Wildlife Service to gain equipment and additional expertise in locating invasive species located in the Caddo Nations jurisdiction, and tribally owned lands.

In February CNEP hosted the Cherokee Nation Environmental Programs for a day of knowledge sharing. The Cherokee Nation Inter-Tribal Environmental Council (ITEC) will be assisting CNEP on performing Phase I environmental assessments on a few of the tribally owned lands located in the Caddo Nation jurisdiction. The purpose of a Phase I environmental assessment identifies recognized environmental conditions (RECs) and helps to ensure that leadership considers the environmental impacts when deciding whether or not to proceed with a project. CNEP will continue to work to protect mother earth, by advocating for environmental protection, and resource protection. In March CNEP staff attended the Oklahoma Emergency Managers Association Conference in Durant, Ok. During this conference CNEP was able to network with other agency's from across the state of Oklahoma to build our capacity. CNEP also works closely with Caddo Nation Emergency Management (EM). We look forward to continually working with EM to ensure the Caddo Nation, and our communities are safe, and well taken of if an emergency is arises.

CNEP would also like to welcome two new employees to the Caddo Nation Environmental Protection program. Cody Roberts is the new Office Assistant for CNEP. Previously Cody worked for the City of Anadarko as the water technician at the Anadarko Water Plant. With his knowledge of water quality, and its issues along with additional knowledge of agricultural practices, and horticultural he will be a valuable asset for the program moving forward. The next new hire is Kolby Williams. Kolby is the new Conservation Field Technician. Kolby has knowledge of agriculture practices, and has a ranch background. Kolby will be assisting the Environmental Specialist, and Natural Resources Specialist in locating and removing invasive species to help restore native grasses to the Caddo Nation. We are lucky to have Cody, and Kolby and we look forward to their continued growth and development to better serve our tribal members, and our communities.
