We are open daily for congregate lunch at the Fritz Hendrix Memorial Building Monday – Thursday 11:00 a.m. to 1:00 p.m. and on Fridays, we serve brunch from 9:30 a.m. – 11:00 a.m. The Gracemont Congregate is located at the Assembly of God dining hall in Gracemont, OK. They are open Monday – Thursday 11:00 a.m. to 1 p.m. We encourage our Elders to come by and pick up a menu and/or check it out on our Caddo Nation AoA FB page.

Menu: Our menu items are selected by suggestions from our current participants at both Congregates and our deliveries. Suggestions are taken throughout the month and the menu is ready by the last Monday prior to the 1st of the month. Each day is planned according to the food pyramid for elderly adults and liberalized diets for the general elder population. (Condiments are available and some are high in sodium and contain sugar.) We will be continuing with comfort foods to keep everyone nice and full for the remaining winter months.

Our meals are made “from scratch” and this takes a lot of time and preparation, but we believe the outcome is worth it; I applaud my staff for getting the meals out in a timely manner. The compliments I receive on the taste and appearance speak for themselves. We try new menu suggestions as well as toss in some good comfort foods.

Funding: Our program continues to operate off of grants awarded through ACL; our FY 2025 began today April 1, 2025. ACL grants are Title VI – Part A, Title VI – Part C, NSIP and MIPPA. The Gracemont Congragate is supplemented by a grant awarded by Pathways which is through the Oklahoma Health Care Authority.

AARP SCSEP: Caddo Nation of Oklahoma had partnered with AARP to become a host agency who will train low income or unemployed elders, 55 and older, new skills that will assist them with making their way back in to the work setting through a training program. We here at AoA will assist elders in filling out the application for SCSEP and they can work here at the Caddo Nation of Oklahoma, if there are any available positions. In the occurance that there is not any available positions, we can assist with trying to find placemen in other host agencies in the area. Please apply if interested, they are part time positions at minimum wage

	walking canes, crutches, briefs, binders, back support, hand brace, and wound care supplies. The lending closet items are available for elder use through our Caregiver program. You may sign any of these items out if needed. *Currently out of coccyx cushions, wheelchair cushions and bariatric supplies: wheelchairs & walkers. Must be in AoA service area.
RESPIRE PROGRAM/ ELDERCARE CHORES	No respite care members right now. No referrals for elder care have been written. These programs provide the opportunity to plan, develop, and implement family caregiver support programs for the benefit of non-paid family members (not living in the home) caring for their elders and grandparents caring for their grandchildren. Must be in AoA service area.
LAWN CARE	We will be limited to 10 elders; we will then refer applications to the Pathways Director. Eligibility will be determined as Pathways is under the OHCA and Medicaid information will need to be submitted. *Staff is available to assist with Medicaid application if you are not a current Medicaid recipient.
WELLNESS CHECK	We have made 18 wellness checks, provided supplies for 8 of those participants, 9 transports for people this quarter; currently we are monitoring 1 elder in long term care facilities as well as monitored one elder for Social Services during our delivery to them. Our program continues to work with the CHR and Social Services program on various tasks. If we receive a call regarding an elder, then our team goes out and assesses them as needed and refers them to the appropriate people.
GENERAL ELDER ASSISTANCE	We have aided 8 participants this quarter with lending closet items and have given away PPE to 2 participants. I have aided 9 elders in completing paperwork/applications and have assisted 5 with. Elders come in to the office for this type of assistance;
EXPENSES	The expenses made were general monthly bills and employee wages.
GENERAL NOTES	The caregiver support program includes the Lawn Care/Chores Program, Respite Program, Lending Closet and Health Program. Please call the AoA Building for further information on any of our programs. *We will be adding additional services that will fall under the Caddo Nation Pathways Program. <i>We work closely with the CHR Program, Social Services and Tribal Nursing to meet the needs of all our Participants.</i>

The Caddo Nation's Community Health Program is funded by Indian Health Services on a yearly basis to assist Caddo Tribal Members with their health needs. The CHR Program's purpose is to assist eligible Native American individuals and families within our service area to gain access to comprehensive health care services.

All CHR staff members are trained in CPR, First Aid and EMS First Responder.

The CHR Program is often a vital link to health care services for our Native people in rural areas. Our work includes making and rescheduling appointments for clients, pick and delivery of medications, home visits, case screening and management, monitoring patients and health education.

The Caddo Nation Special Diabetes Program assists all Diabetic Tribal members with diabetic assistance. We have a Podiatry Clinic twice (2) a month. We provide diabetic (wellness shoes) once per year. We also provide diabetic supplies, medical assistance.

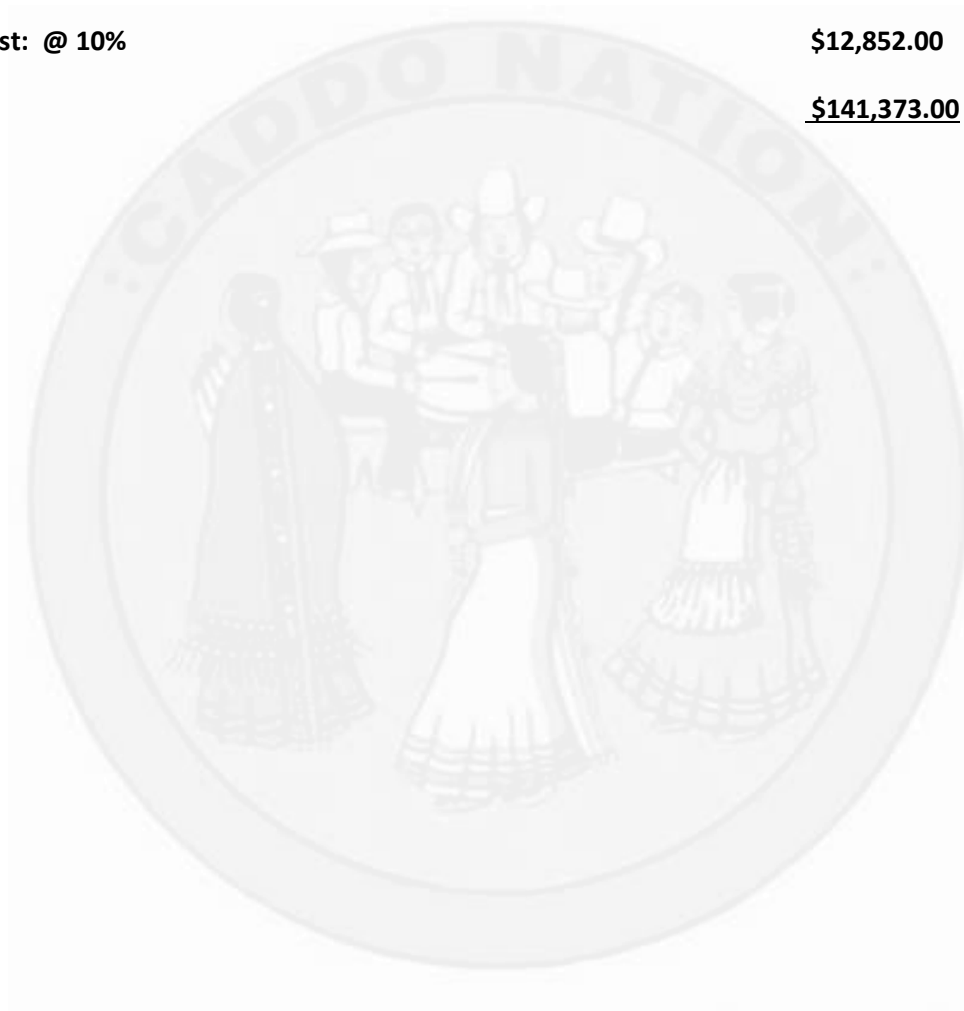

Caddo Nation Education Programs

The Higher Education Program provides scholarships to qualifying tribal member college students. Scholarship amounts vary according to unmet need (as determined by the Federal Student Aid Program), and range between \$500.00 and \$3,000.00 per term. Scholarships are funded on a first come, first served basis for **completed** applications.

The Education Programs fiscal year begins on January 1st of each year. In the Higher Education Program, for CY 2025, we have had:

The Caddo Nation Adult Education Program provides assistance to qualifying tribal members who are seeking short-term training (one year or less), literacy instruction, cultural enrichment, or basic skills. The amounts of assistance vary according to the costs associated with the type of training/courses that the applicant will be taking. The maximum amount of funding for the training/course(s) is \$4,500.00 per academic year (Aug. 01 through July 31). Applications are funded on a first come, first served basis for **completed** applications. Eligible tribal members must reside within the jurisdiction of the Anadarko Agency (Caddo, Kiowa, Comanche, Cotton, or Tillman Counties in the state of Oklahoma). The numbers of applicants for the Adult Ed. Program tend to be very low because of the jurisdictional boundaries, which is not negotiable in our contract.

The Caddo Nation Job Placement & Training Program provides Job Placement (Direct Employment Assistance) and Job Training (Adult Vocational Training) to interested, and eligible enrolled Caddo Nation members. It provides vocational training assistance and/or assistance for starting new employment. The JP&T Program provides short-term and long-term training assistance, and/or other forms of assistance that would enable participants to train, retrain, and upgrade underemployed and unemployed workers in skill areas for which there is a demand in the labor market. The JP&T Program provides bi-weekly stipends for AVT students to assist with household expenses while in training. The amounts of assistance vary according to number of dependents and need.

Applications are funded on a first come, first served basis for **completed** applications (all requested documentation has been turned in, faxes/copies are not accepted). Eligible tribal members must reside within the jurisdiction of the Anadarko Agency (Caddo, Kiowa, Comanche, Cotton, or Tillman Counties in the state of Oklahoma). The numbers of applicants for the JP&T Program tend to be very low because of the jurisdictional boundaries, which is not negotiable in our contract.

Since its establishment, the Caddo Nation Environmental Protection (CNEP) program has secured several grants through the Environmental Protection Agency (EPA), including the General Assistance Program (GAP), Clean Water Act Section 106 (CWA), and Clean Air Act Section 103 (CAA). Additionally, CNEP has received funding from the Bureau of Indian Affairs (BIA) to support climate resiliency initiatives, natural resource education, and invasive species management within the Caddo Nation's jurisdiction. These funds enable CNEP to take proactive steps toward protecting our Tribal lands against the growing impacts of climate change. In the coming quarters, CNEP plans to apply for additional grants through both the EPA and BIA to expand its programs and enhance services for the Caddo Nation.

In July, CNEP participated in the EPA Region 6 Tribal Caucus and the Regional Tribal Operations Committee (RTOC) quarterly meetings. The 3rd quarter's meetings were in Albuquerque, NM, from July 7th – July 10th; the next quarter's meetings are scheduled for November 18th- 20th in Tulsa, OK. Caddo Nation Environmental proudly represents our region on the RTOC board, as we have been one of the tribes elected. These meetings are a valuable source of knowledge for CNEP, as heads of EPA are in attendance to inform tribes of what funding is available.

In July, the Natural Resource Specialist Cameron Roberts got the privilege to present at the Inter-Tribal Environmental Council (ITEC) over detailing the Rainwater Harvesting system and what funding pools are available for those kinds of projects. He also provided contact information for those involved. The system will provide an emergency water source for the tribe and local municipalities in case of any wildfire events that happen within our jurisdiction. ITEC is an annual event that brings together Tribal environmental professionals, EPA officials, and other stakeholders to exchange insights on Environmental management in Tribal communities. Environmental quality remains a top priority for CNEP, and we continue to work diligently to protect the health and well-being of our Tribal members. September 16th, CNEP staff attended the 4th quarter TECO (Tribal Environmental Coalition of Oklahoma) meeting in Okmulgee, OK, at the College of the Muscogee Nation. During this event, CNEP staff were informed of new grant opportunities, including the FY26 Water SMART and Native American Affairs Water Program Grant.

During the fourth quarter (July – September 2025), the Caddo Nation Environmental Protection Program (CNEP) provided Roll-Off Dumpster Services to four Tribal members. This service assists community members with the proper disposal of large volumes of waste, helping to maintain cleaner homes and properties across the Caddo Nation jurisdiction.

The Caddo Nation Environmental Program is looking into the FY26 Solid Waste Infrastructure for Recycling (SWIFR) grant to build a recycling center or transfer station to help provide more cleanups and remediation to our tribal lands.

To ensure equitable access to this limited-capacity service, the following policy is in place:

“If you have received service within the same EPA calendar year (October – September), you will be placed on a waitlist until the next funding period.”

This approach allows more Tribal members the opportunity to benefit from the program. Roll-off services are offered on a first-come, first-served basis, with availability three times per quarter. Service is scheduled according to the following calendar:

- ***1st Quarter: October – December***
- ***2nd Quarter: January – March***
- ***3rd Quarter: April – June***
- ***4th Quarter: July – September***

CNEP also offers in-home mold inspection services to Tribal members. All CNEP staff are certified mold inspectors and provide the following:

- ***On-site inspections and environmental assessments***
- ***Air or surface mold sampling (as needed)***
- ***Education on mold prevention and safe remediation practices***

Our services are aimed at promoting healthier indoor/outdoor environments by identifying and addressing potential hazardous and mold-related health risks. For further information on any services provided or information on the CNEP programs, please contact us.

The Caddo Nation Human Resources Department is responsible for:

- Helping employees with the onboarding process
- Addressing employee questions and concerns
- Maintaining employee policies and procedures
- Communicating and implementing tribal administration and departmental changes
- Conducting disciplinary actions
- Processing terminated and retiring employees
- Maintaining employee benefits
- Processing employee payroll along with finance department

Since the last membership meeting, we have 102 employees; there are 93 full-time and 9 part-time employees within 26 departments and stores.

We've hired 9 new employees in this quarter. We've had 5 voluntary terminations and 3 involuntary terminations.

Melanie Quiver and Lita Smith attended the National Native American Human Resources Association (NNAHRA) conference which was held on September 28th – October 1st 2025. This conference gave us the opportunity to obtain credit hours to

McKee's has had an increase in sales over the last year! Our sales last year from 01/2024 through 09/30/2024 were \$255,539.57 compared to this year 01/2025 through 09/30/2025 which are \$281,833.20 for an increase of \$26,293.63. Then compared quarterly to last year July through September 2024 which were \$94,555.57 to this year July through September 2025 for sales of 108,590.73 showing an increase of \$14,035.16 for the quarter!

Our average order amount is \$69.92, and our current top selling item is 8mm fire polish beads followed closely by 13 cut beads.

Mission Statement: The Caddo Nation Victim's Services mission is to provide compassionate, culturally informed support and resources to individuals and families within our Tribal community who have experienced violence, trauma, or abuse. We are committed to honoring our heritage and traditions while offering confidential services, advocacy, and empowerment. Our goal is to ensure safety, healing, and justice for all survivors, fostering a supportive environment that respects and upholds the dignity of each person.

Services Offered: The Caddo Nation Victim Services Program offers the following services: Crisis Intervention; Intake and Assessment; Limited transportation assistance to assist clients to get to court, medical appointments, shelter placement, and other trips to meet the essential needs of the victim at the discretion of the Program Administrator; Assistance with completing and filing protection orders; safety planning Cultural and Spiritual Advocacy; Community connection resources; Building support networks; Assistance in locating an emergency shelter; Court advocacy; Assistance in locating medical services; Emergency transportation; SANE accompaniment; and Counseling referrals.

Third Quarter Services Provided: The Program Administrator has provided the following services within this reporting period: Program Trainings; Victims Services Meetings; Court Advocacy and Accompaniment; Transportation Assistance; Intake and Referral Services; Referrals for services; and Transitional Housing Assistance.

Vision and Future Plans: We are continuing community outreach efforts to inform tribal members that this program is available and here to support our members in anyway we are able to. We are continuing to locate trainings so that our staff are fully equipped to provide culturally competent and trauma informed services to survivors of violent crimes. The Program Administrator is diligently working with other organizations and community resources to expand the services offered within the program. Caddo Nation Language Preservation Program Quarterly Report

July – September 2025

Caddo Nation Language Preservation Program Summary

This quarter the Caddo Nation mourned the loss of the Caddo Nation's last advanced language speaker, Edmond "Sonny" Johnson (August 31, 1929 – July 6th, 2025).

The language program has pivoted to more community Caddo language classes. Caddo language classes are now available on Zoom to all Caddo Nation tribal members and descendants every Wednesday at 6 PM central time. The curriculum is based on the type of language work that learners would like to focus on in their language journey (preservation, reclamation, or revitalization).

The first Wednesday of every month – Homeroom class

- Low commitment, no projects, come-and-go beginner's class.

The second Wednesday of every month – PRESERVE focus group

- The Caddo language preservation focus group is for people who are interested in working on documenting or archiving Caddo language, history, stories, songs, or culture.

The third Wednesday of every month – RECLAIM focus group

- The Caddo language reclamation focus group is for people who are interested in normalizing the visibility, presence, and usage of our language.

The fourth Wednesday of every month – REVITALIZE focus group

- The Caddo language revitalization focus group is for people who want to protect our language's future by becoming a speaker.

All Zoom classes and the materials associated with them are recorded and stored in a shareable folder. The focus groups have group chats available to practice and stay in touch with fellow class members between monthly classes. Registration for Caddo language classes and access to the language program's resources is available through the contact information below.

On September 2nd, the Caddo language program director, Alaina Tahlate, was selected for a two-year long Indigenous language digital archive (ILDA) apprenticeship offered by the National Breath of Life Institute. The apprenticeship will produce a searchable Caddo language database and Caddo language dictionary app that is owned and maintained by the Caddo Nation language program.

Cross-departmental Activities

The language program has continued to integrate with other Caddo Nation programs through events and projects:

- Indian Child Welfare / Social Services – coordinating quarterly distribution of Caddo language and cultural resources with support from Caddo tribal member Kira Hayen and the Oklahoma Visual Arts Coalition's THRIVE grant.
- Hasinai Scouts (Caddo Nation Child Care) program's community garden harvest September 9th in Binger, OK. with support from the Endangered Languages Project's Ready to Revitalize language grant.
- Inspirational Recovery Event in partnership with the tribal opioid response program August 4th, incorporating Caddo language and cultural teachings into sobriety.

Help Preserve Caddo Heritage

There is an open call for all Caddo people interested in depositing old audio recordings and videos of Caddo language, history, stories, and culture for the Caddo Nation language program's digital archive. Digital backup of the old or new resources will be stored securely in the language program archive. The depositors get to keep their original tapes and control who gets access to their digital files. Tahlate is available to travel to record elders. Contact the language program with the information below.

The Caddo Nation Social Services- Indian Child Welfare Program is responsible for monitoring children who are placed in guardianships (permanent/temporary), have an active state child welfare investigation, Family Centered Service Plan, or is in an out of home placement in foster care. These children can be in the State of Oklahoma or any other part of the United States. We also are involved with adults due to their age or disability that are unable to care for themselves or do not have an appropriate care giver. The Social Services Indian Child Welfare program is responsible for the intake and process of Crisis and Li-heap applications, and to oversee IIM accounts when needed. The Social Service department has been approved to aide families with weatherization units if they are homeowners

Crisis and Li-heap Applications 34 applications for li-heap or Crisis funds were approved for assistance 0 HVAC applications were approved

Child Welfare State Custody

There is a total of 35 Children who are members or eligible for membership with the Caddo Nation. These children have multiple case plans from reunification to adoption.

Child Welfare State Investigations/Tribal Verification

Caddo Nation ICW received 51 notifications of Tribal verification of Child Welfare investigations of possible eligible or enrolled Caddo Nation children. (Not all children are eligible for enrollment with the Caddo Nation, enrollment verification is verified through the Caddo Nation Enrollment office.)

The Caddo Nation SS ICW have participated in has participated in in person and virtual court hearings in Oklahoma, Caddo, Comanche, Grady. Cleveland, Kay, and Garfield Counties in the state of Oklahoma. ICW has participated in virtual court in the states of, Colorado, Kentucky, Texas, Iowa, California, Oregon, and Arkansas.

The Caddo Nation SS ICW program sees children in Oklahoma State custody in person at a minimum of every 45 days. The ICW program completed the worker visits in the areas of OKC, Shawnee, Lawton, Sapulpa, and Purcell. The ICW program speaks with placement providers, permanency workers, service providers, and the court. Children who are out of state the Caddo Nation ICW monitors the cases by completing virtual home visits, and speaking with placement providers, permanency workers, service providers, and the courts.

Guardianship

There are 35 Caddo Nation children placed in guardianships through the Southern Plains Court of Indian Offences, 1 child in the Seminole Court, and 2 in State Guardianships. The Caddo Nation has 1 adult in a permanent co guardianship,

The Caddo Nation are required to complete worker visits for children and families in guardianships with the BIA who have had recent court hearings, and to work with the children

and families to help preserve the family unit if requested by the guardian or bio parent. These children that are in out of home care are in homes all over the state of Oklahoma.

The Caddo Nation SS works cooperatively with the Caddo Nation Nurse and CNA, Administration on Aging, Caddo Housing, CHR programs, and other outside resources to ensure the needs of the individual are met.

Trainings and Meetings

Caddo Nation SSICW Participates in meetings and trainings with the Southern Plains Child Protection Team, Oklahoma Indian Child welfare Association, the National Indian Child Welfare Association, and QIC-EY.

The Caddo Nation has a parent child visitation center available for families at the Anadarko Office at 211 West Main. The visitation room has the ability to have recorded sessions.
