The Caddo Nation's Community Health Program is funded by Indian Health Services on a yearly basis to assist Caddo Tribal Members with their health needs. The CHR Program's purpose is to assist eligible Native American individuals and families within our service area to gain access to comprehensive health care services.

All CHR staff members are trained in CPR, First Aid and EMS First Responder.

The CHR Program is often a vital link to health care services for our Native people in rural areas. Our work includes making and rescheduling appointments for clients, pick and delivery of medications, home visits, case screening and management, monitoring patients and health education.

The Caddo Nation Special Diabetes Program assists all Diabetic Tribal members with diabetic assistance. We have a Podiatry Clinic twice (2) a month. We provide diabetic (wellness shoes) once per year. We also provide diabetic supplies, medical assistance.

## Caddo Nation Education Programs

Submitted by Carolyne Botone

The Higher Education Program provides scholarships to qualifying tribal member college students. Scholarship amounts vary according to unmet need (as determined by the Federal Student Aid Program), and range between \$500.00 and \$3,000.00 per term. Scholarships are funded on a first come, first served basis for *completed* applications.

The Education Programs fiscal year begins on January 1<sup>st</sup> of each year. In the Higher Education Program, for CY 2025, we have had:

The Caddo Nation Adult Education Program provides assistance to qualifying tribal members who are seeking short-term training (one year or less), literacy instruction, cultural enrichment, or basic skills. The amounts of assistance vary according to the costs associated with the type of training/courses that the applicant will be taking. The maximum amount of funding for the training/course(s) is \$4,500.00 per academic year (Aug. 01 through July 31). Applications are funded on a first come, first served basis for *completed* applications. Eligible tribal members must reside within the jurisdiction of the Anadarko Agency (Caddo, Kiowa, Comanche, Cotton, or Tillman Counties in the state of Oklahoma). The numbers of applicants for the Adult Ed. Program tend to be very low because of the jurisdictional boundaries, which is not negotiable in our contract.

The Caddo Nation Job Placement & Training Program provides Job Placement (Direct Employment Assistance) and Job Training (Adult Vocational Training) to interested, and eligible enrolled Caddo Nation members. It provides vocational training assistance and/or assistance for starting new employment. The JP&T Program provides short-term and long-term training assistance, and/or other forms of assistance that would enable participants to train, retrain, and upgrade underemployed and unemployed workers in skill areas for which there is a demand in the labor market. The JP&T Program provides bi-weekly stipends for AVT students to assist with household expenses while in training. The amounts of assistance vary according to number of dependents and need.

Applications are funded on a first come, first served basis for *completed* applications (all requested documentation has been turned in, faxes/copies are not accepted). Eligible tribal members must reside within the jurisdiction of the Anadarko Agency (Caddo, Kiowa, Comanche, Cotton, or Tillman Counties in the state of Oklahoma). The numbers of applicants for the JP&T Program tend to be very low because of the jurisdictional boundaries, which is not negotiable in our contract.

#### CADDOD NATION EMERGENCY MANAGEMENT

The Caddo Nation Emergency Management is committed to the sustainable future and preparedness, protective, mitigation, response and recovery of the membership and their communities prior to, during, and after impact by an incident or disaster. Our work with FEMA Region VI, Bureau of Indian Affairs (BIA), Oklahoma Department of Emergency Management Homeland Security (ODEMHS), and participation in the Southwest Region Emergency Preparedness Team and other agencies that are vital in helping to improve the safety of life and property and the environment of our tribal members. There are two (2) full time staff and a host of volunteer team members ready to respond to any tribal member or community impacted.

The Caddo Nation Emergency management continues to research and submit for numerous grants through Federal, Tribal, and State. The Caddo Nation Emergency Management will be submitting a BRIC, Cybersecurity, SAFER, Fire Prevention and Safety, and Tribal Homeland Security grant for the enhancement needs of the program, and Tribal FEMA Grant for Emergency Operation Center enhancements. We are currently researching some available grants through U.S. Forestry.

The Caddo Nation Emergency Management staff are members of the Southwest Emergency Management Preparedness team Incident Support Team, Oklahoma Homeland Security All Hazard Incident Management Team and the Cherokee Nation Supplemental Response Team for all 547 tribes. Staff deployed the Zumro inflatable tent for 3 events in Anadarko (4<sup>th</sup> of July, Kites and Flights event, and the Native American Expo. The emergency management program also conducted a bottled water project for emergency responders, providing cases of bottled water to all the fire departments in Cotton County, Caddo County, Wichita and Cheyenne Arapahoe tribes, also provided bottled water to Anadarko First Baptist to go with holiday food baskets and also the homeless shelter in Anadarko.

The Caddo Nation Emergency Management also has obtained a mobile shower trailer from the HIS Trans Am project, this will be an asset if ever needed to relocate our members to a temporary shelter after an incident, or can now be provided at the annual dance events for the campers and dance performers.

The staff continues to attend any training that will be an enhancement to the program, will be attending in 2026 the Oklahoma Emergency Management Association conference in February, Center of Domestic Preparedness Tribal Week in April, Inter Tribal



### Caddo Nation Language Preservation Program Summary

The language program pivoted to more community Caddo language classes at the end of 2025 following the loss of the Caddo Nation's last advanced language speaker, Edmond "Sonny" Johnson (August 31, 1929 – July 6<sup>th</sup>, 2025). Caddo language classes are now available on Zoom to all Caddo Nation tribal members and descendants every Wednesday at 6 PM CST / 7 PM EST / 5 PM MST / 4 PM PST. Please defer to the Caddo Nation's official web presence for all upcoming announcements of language events.

### 2026 Class Schedule

The curriculum is based on the type of language work that learners would like to focus on in their language journey (preservation, reclamation, or revitalization). All Zoom classes and the materials associated with them are recorded and stored in a shareable folder. The focus groups have a group chat available to practice and stay in touch with fellow class members between weekly classes. Registration for Caddo language classes and access to the language program's resources is available through the contact information at the end of this membership report. 

The Caregivers have been working diligently to assist elders in the home with light house cleaning, laundry, and meal prepping.

Transportations were to necessary medical appointments and treatments, surgeries, follow-ups, and to obtain necessities like groceries, medications, and hygiene supplies.

Home visits consisted of RN, CNA, and Caregivers providing multi-levels of support. (Vital checks, Skin assessments, Bathing, Medication planning, Health education, Cleaning, Laundry, Communication, etc.)

We periodically made nursing home visits to check in on clients to ensure quality care was being provided and to advocate for the client.

Referrals made by RN and CNA for clients to specialists (Cardiologist, Nephrologist, Urologist, Endocrinologist).

Wound care provided by RN with Dr's orders to clients experiencing skin breakdown and pressure sores.

**Mission Statement:** The Caddo Nation Victim's Services mission is to provide compassionate, culturally informed support and resources to individuals and families within our Tribal community who have experienced violence, trauma, or abuse. We are committed to honoring our heritage and traditions while offering confidential services, advocacy, and empowerment. Our goal is to ensure safety, healing, and justice for all survivors, fostering a supportive environment that respects and upholds the dignity of each person.

**Services Offered:** The Caddo Nation Victim Services Program offers the following services: Crisis Intervention; Intake and Assessment; Limited transportation assistance to assist clients to get to court, medical appointments, shelter placement, and other trips to meet the essential needs of the victim at the discretion of the Program Administrator; Assistance with completing and filing protection orders; safety planning Cultural and Spiritual Advocacy; Community connection resources; Building support networks; Assistance in locating an emergency shelter; Court advocacy; Assistance in locating medical services; Emergency transportation; SANE accompaniment; and Counseling referrals.

**Third Quarter Services Provided:** The Program Administrator has provided the following services within this reporting period: Program Trainings; Victims Services Meetings; Court Advocacy and Accompaniment; Transportation Assistance; Intake and Referral Services; and Referrals for services.

**Vision and Future Plans:** We are continuing community outreach efforts to inform tribal members that this program is available and here to support our members in anyway we are able to. Staff have completed a certification course in Victim Advocacy. Staff will continue participating in community events, trainings, etc. The Program Administrator is diligently working with other organizations and community resources to expand the services offered within the program. We are continuing efforts to locate other funding sources and growing the program further. The program is moving forward and working with other tribal programs and resources to create a holistic approach for tribal members.

Bringing the total staff employed with the security department to (6) employees. The department continues to protect and secure all assets owned by the caddo nation. All patrols are daily thru (3) shifts this includes the tribal complex, the town of gracemont which consists of the housing authority and the caddo travel plaza and a church which sit right next to the travel plaza. Patrols also go to the town of Anadarko these patrols along with the building checks include mckee's indian store,georges department store,the newly acquired redskin theater,the chr/social service offices. The other building included in the patrol is shamrock financial which the tribe owns the building not the business. Also regency oaks elder apartments and the activity building. The security department continue to patrol to the town of hinton for the child care center which is still currently under construction. Also located north east of the town of hinton on Methodist road a newly acquired property with buildings for future tribal operations.

OCTOBER 2025 - The SORNA Department for the month of October, The SORNA Department did not have any offenders come in for registration. The SORNA Department continued training of SORNA online to better help operations of the SORNA Department.

NOVEMBER 2025-The SORNA Department for the month of November, The SORNA Department did not have any offenders come in for registration. The SORNA Department continued training of SORNA online to better help operations of the SORNA Department.

DECEMBER 2025 -The SORNA Department for the month of December, the SORNA Department had one offender come in to register for their annual registration. With the offender coming to register they filled out the necessary paperwork for the registration. After they filled out the paperwork, the Registry Coordinator would notify them of their next registration appointment. Then the Registry Coordinator took the paperwork for the registration, and entered and updated the offenders profile to keep up to date on the TTSORS website.

The SORNA Department currently has 2 employees under the SORNA Grant.

Nyles Parton is the SORNA Grant Supervisor, which oversees the Grant and the work completed by the SORNA Registry Coordinator. Baylen Bullcoming is the SORNA Registry Coordinator, which enters the sex offenders' information and registration into TTSORS every time they come in to register. This includes criminal history, physical descriptions, driver's license employment history, employer address, and etc. The 2 SORNA employees are taking online training and classes for the SORNA Grant. The Registry Coordinator is in charge of keeping the sex offenders records up to date, if anything changes with the sex offenders. The SORNA Department has 2 sex offenders. 1 offender is currently incarcerated, and the other sex offender comes in regularly for registration. Depending on the sex offenders offense, the sex offender will have to register annually for 15 years, every 6 months for 25 years, and or every 3 months for life.

The Caddo Nation Social Services- Indian Child Welfare Program is responsible for monitoring children who are placed in guardianships (permanent/temporary), have an active state Child Welfare investigation, Family Centered Service Plan, or is in an out of home placement in foster care. These children can be in the State of Oklahoma or any other part of the United States. We also are involved with adults due to their age or disability that are unable to care for themselves or do not have an appropriate care giver, and to oversee IIM accounts when needed. The SS department also provides and locates resources for families who are in need.

### Child Welfare State Custody

There is a total of 39 Children who are members or eligible for membership with the Caddo Nation. These children have multiple case plans from reunification to adoption. Child Welfare State Investigations/Tribal Verification

Caddo Nation ICW received 35 notifications of Tribal verification of Child Welfare investigations of possible eligible or enrolled Caddo Nation children. (Not all children are eligible for enrollment with the Caddo Nation, (enrollment verification is verified through the Caddo Nation Enrollment office.)

The Caddo Nation SS ICW have participated in has participated in in person and virtual court hearings in Oklahoma, Caddo, Canadian, Comanche, Grady, Cleveland, Kay, and Garfield Counties in the state of Oklahoma. ICW has participated in virtual court in the states of, Colorado, Kentucky, Texas, Iowa, California, Oregon, and Arkansas.

The Caddo Nation SS ICW program sees children in Oklahoma State custody in person at a minimum of every 45 days. The ICW program completed the worker visits in the areas of OKC, Shawnee, Lawton, Sapulpa, Woodward, Cache, Edmond, Norman, Verden, and Purcell. The ICW program speaks with placement providers, parents and children permanency workers, service providers, and the court. Children who are out of state, the Caddo Nation ICW monitors the cases by completing virtual home visits, and speaking with placement providers, permanency workers, service providers, and the courts.

### Guardianship

There are 31 Caddo Nation children placed in guardianships through the Southern Plains Court., 1 in Seminole court, and 2 in state court. The Caddo Nation is required to complete worker visits, court hearings and work with families to help preserve the family unit if requested by the bio parent and guardian. Children are in guardianship across the state of Oklahoma. The Caddo Nation has not received any notices of state guardianships in any other states other than Oklahoma.

### Social Services

The Caddo Nation works closely with the Caddo Nation Nursing Program, AOA, ICW, TOR, OVC, and CHR Programs

### Training and Meetings

The Caddo Nation Pathways Program attended training in Washington State regarding the Pathways Program. The Caddo Nation met with other Tribal Pathway programs and sat on a panel to provide

information on what the Caddo Nation Pathways Programs achievements and goals were.

The Caddo Nation meets with the Southern Plains Child Protective Program and QIC-EY team monthly either in person at different tribal sites or virtually.

Between November 2025 and January 2026 the tag office had 327 renewals and 136 new tags issued.



### Departmental Highlights

- Working on a new office move (remodel trailer to house Transportation director, fleet coordinator, K9 officer, and HVAC technician)
- Attended the National Transit conference in Austin, TX to add a transit program to the Caddo Nation Transportation Department.
- Attended the National Transportation Conference in Chandler, AZ. Networked with other tribes on the plan when shifting to self-governance.
- The Safe Streets for All grant, administered and executed by Rondo Kopepasah, has been modified extending the period of time for completion. This grant will provide a Transportation Action Safety Plan. Current status of the grant, getting a road assessment completed by an outside vendor. One has been confirmed will to take on the project of 638 complete road miles.
- Rondo Kopepasah working with LTAP OSU, free course offered and specialized for all aspects of the Transportation field; upon completion of these courses a certification of Road Scholar will be presented. Classes completed 6 of 7
- Replaced speed bumps at halfmoon addition for the damage.
- Preparing a budget for the Transportation department to move to self governance.
- Emily Scheffler, Safety/Fleet Coordinator, has done a great job establishing the fleet program for the Caddo Nation by bring vehicles up to date on tags, registration, vehicle service, vehicle recalls, completing reports to finance, and finding cost efficient options for vehicle tracking.
