Course Overview

Being competitive means meeting customers' needs by offering them the right product at the right time at the right price... and at the lowest possible cost to your company so that it makes a fair profit. Enterprises - which often spend more than 60% of their revenue covering the cost of their supply chain operations - can greatly enhance their competitiveness and customer delivery performance through improved supply chain management. Supply chain management (SCM) is the management of a network of interconnected businesses involved in the provision of product and service packages required by the end customers in a supply chain. SCM spans all movement and storage of raw materials, work-in process inventory, and finished goods from point of origin to point of consumption.

Organisations are currently experiencing increased competition, rapid changes in technologies, and increased emphasis on quality, total cost, long-term contracts, supplier-base rationalization, inventory reduction, outsourcing, and reductions in staff, warehousing, distribution centre and logistics.

Creating competitive advantage is what organizational strategy is all about. To compete in today's environment, organisations need to be competitive in terms of cost, quality, delivery performance, lead-time to market and flexibility.

Certified personnel can contribute to an organization's success in several ways. Certified person think strategically, broaden their perspective in their specialized field and look at themselves as a provider to the internal and external customers of an organization.

ASSESSMENT

Completion of the certification program requires completion of an examination on multiple choice question (MCQ) and/or short questions and an industrial project. The assessment is prepared by a Board of Examiners consisting of a range of Certified Practitioner and Educator Members from reputable Universities.
