The CLP

The CLP is a professional certification in logistics that enables employees in this industry to develop themselves more effectively, and assists in defining the logistics profession.

The certification programme will become a life partner for those attaining accreditation, as continuing professional development is crucial to maintaining CLP status. For the first time, persons working in logistics will be recognised, just as other professions provide recognition by their counterparts in the accounting, finance, medical, legal and engineering professions.

Individuals who meet all the criteria are awarded the certification and pin designating them as a CLP – a certification that is recognised as standing for logistics management excellence throughout the industry.

ASSESSMENT

Completion of the certification program requires completion of an examination on multiple choice question (MCQ) and/or short questions and an industrial project. The assessment is prepared by a Board of Examiners consisting of a range of Certified Practitioner and Educator Members from reputable Universities.



The Certification Program is administered by PASAS Qualification Review Board (ORB) responsible for reviewing the eligibility of applicants, the conduct of the examination itself, and notifying candidates of the results. It is also accredited by International Accreditation Organisation (IAO)
