Privacy Policy and Procedures

Scope

This Privacy Policy applies to personal information processed by PhoningHomes.com and its host site GoDaddy.com, and our credit card processor, PayPal.com

Personal Information We Collect

When you use our Services, we may collect the following categories of personal information:

Information You Provide to Us

Account Information. When you create an account, you are creating an account with PayPal and you understand their privacies and their terms of use. We will collect your name, email address, phone number and any other names and e-mails you provide are for the strict communication on and about a Phoning Homes's call recipient. We DO NOT collect your credit or debit card information or address. Please note that we use a third-party service provider (PayPal) to collect and process payment card information on phone call services. Phoning Homes does not directly collect or store any payment card information provided to Pay Pal.

Information Contained in Documents. Any information you provide will be saved in our client file system including any e-mail communication. You may have access to this at any time.

Communications with Us. We may collect personal information from you such as email address, phone number, or mailing address when you request information about our Services, sign up for our newsletter, request customer or technical support, or otherwise communicate with us.

Customer Service and Support. If you call or otherwise interact with Phoning Homes's customer service and support, we may collect the information you provide to our representatives.

Surveys. We may contact you to participate in surveys. If you decide to participate, you may be asked to provide certain information which may include personal information.

Sharing Content with Friends or Colleagues. Our Services may offer various tools and functionalities. For example, we may allow you to provide information about your friends through our referral services. Our referral services may allow you to forward or share certain content with a friend or colleague, such as an email inviting your friend to use our Services.
