#### POLICIES AND GUIDELINES (subject to change)

While we always try to be flexible and accommodate our families' needs, Pacific Blue has found it necessary to enact the following guidelines to ensure a successful environment for our students and our program. If you have specific needs not addressed in these policies, please talk to us individually.

TUITION	Initial after reading

- Payment is due one week before the first lesson of each month in order to secure your spot. No partial payments please. We cannot prorate your slot if you plan on missing any lessons in the month.
- Everyone must save a credit card/debit card on file through Square during their first month of enrollment. This can be done when paying your first invoice.
- •A security deposit of 100 dollars per family is due at the time of sign up to secure your appointment day/time. This deposit will be credited back to your final months tuition upon receipt of required 2 weeks notice in writing.
- Invoices will be emailed out the 3rd Friday of every month. Payment is due the last full week of every month in order to secure your time slot for the new upcoming month.
- Cash payments can be put in an envelope (Provided) with your swimmer's name and the month and placed in the drop box in the swim bathroom.

## PRICING \_\_\_\_\_ Initial after reading

- MONTHLY PRICES: We offer a monthly fee schedule. Lessons are 30 minutes each, occurring once a week. Each month will be prorated for the actual amount of lessons in the month.
- Price Per Swimmer: Private Lessons: \$65/per lesson
- Classes are ongoing; you may start at any time. If you start in the middle of the month, the remainder will be prorated. Each child will remain enrolled until we receive a written cancellation notice via email 2 weeks before the next month. Your account will be billed on the FINAL MONDAY of each month as long as you are enrolled.

#### MAKE-UP POLICY \_\_\_\_\_\_ Initial after reading

- Due to our instructor to swimmer ratio, it is not always possible to accommodate make-up lessons. Make-up classes are based on availability and are **NOT GUARANTEED**.
- No call/no show or last minute cancellations are not eligible for make-up classes.
- In order to qualify for a possible make-up, a minimum 24hr notice must be given by email. Your name will then be added to our make-up list.
- Make-ups must take place in the same month in which you have missed. Make-ups cannot be carried over into the next month.
- If available, only one make-up is allowed per swimmer in any given month.
- Once a make-up lesson has been confirmed, it cannot be rescheduled.

#### WITHDRAWING AND REFUND POLICY \_\_\_\_\_\_ Initial after reading

- Pacific Blue Swim Lessons does not issue refunds for those families who have already started the month.
- CANCELLATIONS: If lessons are canceled due to facility closure, you will receive a credit on your next monthly charge or we will reschedule you for a make-up.
- WITHDRAWING: We ask that a 2-week emailed notice be given before the intended final month for those who wish to withdraw from swim lessons. Upon receipt of this notice to discontinue, your final month's invoice will be credited with your 100 dollar deposit that was paid at time of registration. If proper notice is not given, the deposit will be forfeited.
- Due to limited slot availability there will be no monetary refunds, transfers or credits issued by Pacific Blue Swim

### BEHAVIOR POLICY \_\_\_\_\_\_ Initial after reading

- For the safety of all, we ask that all members of your party remain inside the fenced in area under supervision of a responsible adult. Instructors are not responsible for other children/siblings that are not engaged in swim lessons. Please supervise your children.
- Any physically violent behavior will be dealt with using the 3 strike rule. First infraction will receive a warning, second
  will result in the lesson ending early, a third incident will result in permanent termination of lessons and a refund of any
  money due.
