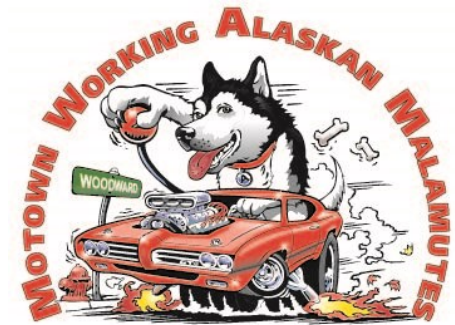

#### AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons or trophies, (we) agree to hold the AKC, the event giving club, their members, directors, governors, officers, agent, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge. Judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of injuries, including death at any time resulting therefrom sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. I (WE) AGREE THAT ANY CAUSE OF ACTIONS, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT GIVING CLUB (UNLESS OTHERWISE STATED IN ITS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, IN THE AKC CHARTER AND BYLAWS, RULES REGULATION, PUBLISHED POLICIES AND GUIDELINES.

#### Notes to Exhibitors

A separate entry blank must be completed for each dog entered. **ENTRY FORMS MUST BE SIGNED!**

Bitches in season will not be permitted to run.

Entry fees will not be refunded to a scheduled entrant who is absent, disqualified, excused, or barred from competition by action of the Event Committee.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs, and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. Owners or their Agents are solely responsible for the presence of their dog(s) at the Test area. Judges are not required to wait for dogs.

Exhibitor should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

No entry fees will be refunded if the event cannot open or be complete by reasons of riots, civil disturbances, fire, act of God, public emergency, act of a public enemy, extreme weather conditions, or any other cause beyond the control of the event committee. (Unless the Governor changes COVID guidelines.)

Dogs must be on a **flat buckle** collar. **NO** choke collars and **NO** harnesses. **If you have a preference for the time of your test(s), please note it on your entry form. We will try our best to meet your needs.**
