- Support physical distancing in all daily activities and instruction, maintaining six feet between individuals to the maximum extent possible.
- Minimize time standing in lines and take steps to ensure that six feet of distance between students is maintained, including marking spacing on floor, one-way traffic flow in constrained spaces, etc.
- Schedule modifications to limit the number of students in the building (e.g., rotating groups by days or location, staggered schedules to avoid hallway crowding and gathering).
- Plan for students who will need additional support in learning how to maintain physical distancing requirements. Provide instruction; don't employ punitive discipline.
- Staff should maintain physical distancing during all staff meetings and conferences, or consider remote web-based meetings.

Classroom Set Up:

- Remove extra furniture to make more room
- Remove fabric-covered furniture and classroom rugs
- Assign seating to maximize physical distancing and minimize physical interaction

To support social distancing guidelines in all daily activities and instruction we will:

- Traffic-flow- A one-way flow of traffic will be established and marked with all common areas of the school with the expectation students and staff will be trained and follow the designated arrows for which direction to walk, 6' spacing for appropriate distancing whenever possible
- Schedules- Students will stay in their classroom with their cohort group for most of the day. If a cohort group needs to transition to another part of the building or outside, a 5 minute passing time for their schedules and transitions.

	 Student instruction on distancing protocols- All staff will be trained on the appropriate health and safety ODE guidelines on social distancing. Teachers will be required to teach, practice, review and reteach the ODE guidelines in their classrooms on a regular basis. This will include appropriate protocols during arrival, dismissal, hallway transitions common areas, and recess. PE and Recess will be provided daily for each classroom. Playground protocol will be taught for following physical distancing. Activities and games will be promoted in which they can maximize physical distancing. Music class will be planned with non-wind instruments that are not shared.

	 Staff will maintain physical distancing during all staff meetings, professional development and conferences, or use remote web-based meetings.

1d. COHORTING

OHA/ODE Requirements

- Where feasible, establish stable cohorts: groups should be no larger than can be accommodated by the space available to provide 35 square feet per person, including staff.
 - The smaller the cohort, the less risk of spreading disease. As cohort groups increase in size, the risk of spreading disease increases.
- Students cannot be part of any single cohort, or part of multiple cohorts that exceed a total of 100 people within the educational week. Schools should plan to limit cohort sizes to allow for efficient contact-tracing and minimal risk for exposure.
- ⊠ Each school must have a system for daily logs to ensure contract tracing among the cohort (see section 1a of the *Ready Schools, Safe Learners* guidance).
- Minimize interaction between students in different stable cohorts (e.g., access to restrooms, activities, common areas). Provide access to All Gender/Gender Neutral restrooms.
- Cleaning and disinfecting surfaces (e.g., desks, door handles, etc.)
 must be maintained between multiple student uses, even in the same
 cohort.
- Design cohorts such that all students (including those protected under ADA and IDEA) maintain access to general education, grade-level academic content standards, and peers.
- Staff who interact with multiple stable cohorts must wash/sanitize their hands between interactions with different stable cohorts.

Hybrid/Onsite Plan

Preschool-PreK: Students will be assigned to a classroom with no more than 10 students which meets the ODE 35 sq. Feet distancing guidelines and will remain as a cohort throughout the day.

McMinnville Adventist Christian school will have 4 cohorts: Kindergarten, 1/2, 3-5, and 6-8. Teachers will move to classrooms for Elective subjects. Students will, for the most part, stay in their assigned classroom

- Kindergarten Cohort: Students will be assigned to a classroom with no more than 10 students which meets the ODE 35 sq. feet distancing guidelines and will remain as a cohort throughout the day.
- 1/2nd Cohort: Students will be assigned to a classroom with no more than 20 students which meets the ODE 35 sq. feet distancing guidelines and will remain as a cohort throughout the day.
- 3-5th Cohort: Students will be assigned to a classroom with no more than 18 students which meets the ODE 35 sq. feet distancing guidelines and will remain as a cohort throughout the day.
- 6-8th Cohort: Students will be assigned to a classroom with no more than 20 students which meets the ODE 35 sq. feet distancing guidelines and will remain as a cohort throughout the day.

A daily log to ensure contract tracing which will be kept for a minimum of four weeks for each cohort.

Stable Cohorts- For students to minimize interaction between cohort groups the following safety guidelines will be put into practice:

- Bathrooms will be cleaned between cohort scheduled uses.
- All activities except for recess, PE and Music will be held in the students' classroom.
- Students will eat lunch in their respective classrooms.
- Students will be dropped off and sent to their cohort classrooms via the outside exit entry door.
- A master recess schedule will be created to minimize interaction between different cohort groups.
- Playground equipment will be cleaned between each cohort group.

Cleaning & Wiping Surfaces-The following CDC guidelines will consistently be following:

	 All door handles, desks, counters, & materials will be cleaned and sanitized when different cohorts use the area and after transitions. All door handles, desks, counters, supplies & materials will be cleaned and sanitized frequently within the same cohort.
	Students with Special Needs - Following the ODE guidelines, students with special needs will maintain access to general education. Sanitizing in transitions- Staff who interact with different cohorts must wash their hands between interacting with each cohort. Each classroom will have the appropriate sanitizing supplies needed.

1e. PUBLIC HEALTH COMMUNICATION

OHA/ODE Requirements

- Develop protocols for communicating with students, families and staff who have come into close contact with a confirmed case.
 - The definition of exposure is being within 6 feet of a COVID-19 case for 15 minutes (or longer).
- Develop protocols for communicating immediately with staff, families, and the community when a new case(s) of COVID-19 is diagnosed in students or staff members, including a description of how the school or district is responding.
- Provide all information in languages and formats accessible to the school community.

> Communication for students and families for infection or confirmed cases will be published on the McMinnville Adventist Christian School Website as written in the McMinnville Adventist Christian School Communicable Disease Management Plan. Written communication will also be provided to families as needed. Health and safety updates will be sent via our ParentSquare Communication App.

1f. ENTRY AND SCREENING

OHA/ODE Requirements

- ☑ Direct students and staff to stay home if they, or anyone in their homes or community living spaces, have COVID-19 symptoms, or if anyone in their home or community living spaces has COVID-19. COVID-19 symptoms are as follows:
 - Primary symptoms of concern: cough, fever (temperature greater than 100.4°F) or chills, shortness of breath, or difficulty breathing.
 - Note that muscle pain, headache, sore throat, new loss of taste or smell, diarrhea, nausea, vomiting, nasal congestion, and runny nose are also symptoms often associated with COVID-19. More information about COVID-19 symptoms is available from CDC.
 - In addition to COVID-19 symptoms, students should be excluded from school for signs of other infectious diseases, per existing school policy and protocols. See pages 9-12 of OHA/ODE Communicable Disease Guidance.
 - Emergency signs that require immediate medical attention:
 - Trouble breathing
 - o Persistent pain or pressure in the chest
 - o New confusion or inability to awaken
 - Bluish lips or face (lighter skin); greyish lips or face (darker skin)
 - Other severe symptoms

Hybrid/Onsite Plan

Stay Home:

- Reminders to parents to report actual symptoms when calling students in as sick as a part of communicable disease surveillance.
- Direct students and staff to stay home if they, or anyone in their homes or community living spaces, have COVID-19 symptoms, or if anyone in their home or community living spaces has COVID-19.

Entry Screening Procedures

- Parents will fill in a daily questionnaire screening sheet that each student will present prior to entry.
- Each student will wash their hands or use hand sanitizer before entering their classroom.
- Students who exhibit symptoms will be sent to the office or "isolation area" for further screening. The school isolation plan will be followed as needed and "Planning for COVID-19 Scenarios in Schools" will be followed.
- Plan for school implementation of isolation and send home protocols
 - Students will be isolated with an adult to monitor student's health.

OHA/ODE Requirements

- Screen all students and staff for symptoms on entry to bus/school every day. This can be done visually and/or with confirmation from a parent/caregiver/guardian. Staff members can self-screen and attest to their own health.
 - Anyone displaying or reporting the primary symptoms of concern must be isolated (see section 1i of the *Ready Schools*, *Safe Learners* guidance) and sent home as soon as possible.
 See table "*Planning for COVID-19 Scenarios in Schools*."
 - Additional guidance for nurses and health staff.
- Staff or students with a chronic or baseline cough that has worsened or is not well-controlled with medication should be excluded from school. Do not exclude staff or students who have other symptoms that are chronic or baseline symptoms (e.g., asthma, allergies, etc.) from school.
- Mand hygiene on entry to school every day: wash with soap and water for 20 seconds or use an alcohol-based hand sanitizer with 60-95% alcohol.

Hybrid/Onsite Plan

- Parents will be notified to come get student
- Planning for COVID-19 Scenarios in Schools will be followed for allowing students to return to inperson.
- Student exclusion based on district protocols and Planning for COVID-19 Scenarios in Schools will be followed for making decisions to exclude students

Screening Staff:

- Staff are required to report when they may have been exposed to COVID-19
- Staff are required to report when they have symptoms related to COVID-19
- Staff members are not responsible for screening other staff member for symptoms.
- Staff members can self-screen and attest to their own health

"Planning for COVID-19 Scenarios in Schools" will be followed for making decisions to exclude students.

1g. VISITORS/VOLUNTEERS

OHA/ODE Requirements

- Restrict non-essential visitors/volunteers.
 - Examples of essential visitors include: DHS Child Protective Services, Law Enforcement, etc.
 - Examples of non-essential visitors/volunteers include: Parent Teacher Association (PTA), classroom volunteers, etc.
- Screen all visitors/volunteers for symptoms upon every entry. Restrict from school property any visitor known to have been exposed to COVID-19. See table "Planning for COVID-19 Scenarios in Schools."
- Visitors/volunteers must wash or sanitize their hands upon entry and exit.
- Visitors/volunteers must maintain six-foot distancing, wear face coverings, and adhere to all other provisions of this guidance.

Hybrid/Onsite Plan

- Non-essential visitors/volunteers will be unable to work in schools, or complete on-campus activities or tasks
- Volunteers/Visitors essential to the running of the school will be allowed on-campus and must follow the ODE Requirements.
- Essential visitors/volunteers will be screened visually and will answer the question sheet provided.
- Essential visitors/volunteers will wash their hands or utilize the hand-sanitizer upon entry and exit, also before entering any common areas or classrooms.
- Any visitor/volunteer known to have been exposed to COVID-19 will be restricted from entering school property.
- Visitors 5 years and older will wear a mask and follow the 6 foot social distancing.

1h. FACE COVERINGS, FACE SHIELDS, AND CLEAR PLASTIC BARRIERS

OHA/ODE Requirements

- □ Face coverings or face shields for all staff, contractors, other service providers, or visitors or volunteers following CDC guidelines for Face Coverings. Individuals may remove their face coverings while working alone in private offices.
- ☑ If a student removes a face covering, or demonstrates a need to remove the face covering for a short-period of time:
 - Provide space away from peers while the face covering is removed. In the classroom setting, an example could be a designated chair where a student can sit and take a 15 minute "sensory break;"
 - O Students should not be left alone or unsupervised;
 - Designated area or chair should be appropriately distanced from other students and of a material that is easily wiped down for disinfection after each use;
 - Provide additional instructional supports to effectively wear a face covering;
 - Provide students adequate support to re-engage in safely wearing a face covering;
 - Students cannot be discriminated against or disciplined for an inability to safely wear a face covering during the school day.

Hybrid/Onsite Plan

Staff:

- All staff, visitors, or volunteers will follow CDC guidelines for Face Coverings and will wear face coverings or face shields when they are within six feet of students or each other.
- If ADA accommodations are needed for a staff member, limited exposure to the students will be implemented as much as possible
- Staff may remove their mask while working alone in private offices

Students:

- All students will be required to wear a face covering or face shield unless they are protected under the ADA or IDEA or present a doctor's note.
- For students not currently served under an IEP/Service Plan
 or 504, McMinnville Adventist Christian School will
 consider whether or not student inability to consistently wear
 a face covering or face shield as required is due to a
 disability. Ongoing inability to meet this requirement may be
 evidence of the need for an evaluation to determine eligibility
 for support under IDEA or Section 504.

Protections under the ADA or IDEA

 - Review the 504/IEP to ensure access to instruction in a manner comparable to what was originally established in the student's plan including on-site instruction with accommodations or adjustments.
 - 2. Placement determinations cannot be made due solely to the inability to wear a face covering.
 - Plans should include updates to accommodations and modifications to support students.
 - Students protected under ADA/IDEA, who abstain from wearing a face covering, or students whose families determine the student will not wear a face covering, the school or district
 - Review the 504/IEP to ensure access to instruction in a manner comparable to what was originally established in the student's plan.
 - The team must determine that the disability is not prohibiting the student from meeting the requirement.
 - o If the team determines that the disability is prohibiting the student from meeting the requirement, follow the requirements for students eligible for, or receiving services under, a 504/IEP who cannot wear a face covering due to the nature of the disability,
 - If a student's 504/IEP plan included supports/goals/instruction for behavior or social emotional learning, the school team must evaluate the student's plan prior to providing instruction through Comprehensive Distance Learning.
 - Hold a 504/IEP meeting to determine equitable access to educational opportunities which may include limited inperson instruction, on-site instruction with accommodations, or Comprehensive Distance Learning.
- For students not currently served under an IEP or 504, districts must consider whether or not student inability to consistently wear a face covering or face shield as required is due to a disability. Ongoing inability to meet this requirement may be evidence of the

1i. ISOLATION AND QUARANTINE

- Students and staff who report or develop symptoms must be isolated in a designated isolation area in the school, with adequate space and staff supervision and symptom monitoring by a school nurse, other school-based health care provider or school staff until they are able to go home. Anyone providing supervision and symptom monitoring must wear appropriate face covering or face shields.
 - School nurse and health staff in close contact with symptomatic individuals (less than 6 feet) should wear a medical-grade face mask. Other Personal Protective Equipment (PPE) may be needed depending on symptoms and care provided. Consult a nurse or health care professional regarding appropriate use of PPE. Any PPE used during care of a symptomatic individual should be properly removed and disposed of prior to exiting the care space.
 - After removing PPE, hands should be immediately cleaned with soap and water for at least 20 seconds. If soap and water are not available, hands can be cleaned with an alcohol-based hand sanitizer that contains 60-95% alcohol.
 - If able to do so safely, a symptomatic individual should wear a face covering.
 - To reduce fear, anxiety, or shame related to isolation, provide a clear explanation of procedures, including use of PPE and handwashing.
- ⊠ Establish procedures for safely transporting anyone who is sick to their home or to a health care facility.
- Staff and students who are ill must stay home from school and must be sent home if they become ill at school, particularly if they have COVID-19 symptoms. Refer to table in "Planning for COVID-19 Scenarios in Schools."
- Involve school nurses, School Based Health Centers, or staff with related experience (Occupational or Physical Therapists) in development of protocols and assessment of symptoms (where staffing exists).

- All students who become ill at school will remain at school within the school designated isolation area supervised by staff until parents can pick them up. Student will be provided a facial covering and maintain physical distancing, but never will be left alone unattended.
- If two students present COVID-19 symptoms, 6 feet distance will need to be maintained in the isolation area.
- While exercising caution to maintain (ensure) safety is appropriate when working with children exhibiting symptoms, it is also critical that staff maintain sufficient composure and disposition so as not to unduly worry a student or family.
- Staff will maintain student confidentiality as appropriate.
- Daily logs must be maintained containing the following:
 - Name of students sent home for illness, cause of illness, time of onset, as per designated communicable disease surveillance logs; and
 - Name of students visiting the office for illness symptoms, even if not sent home, as per routine health logs
- Staff and students with known or suspected COVID-19 cannot remain at school and should return only after their symptoms resolve and they are physically ready to return to school as directed in the Communicable Disease Management Plan.
- The Safety Officer at McMinnville Adventist Christian School will follow the *Planning for COVID-19 Scenarios in Schools* and consult with medical personnel.



2. Facilities and School Operations

Some activities and areas will have a higher risk for spread (e.g., band, choir, science labs, locker rooms). McMinnville Adventist Christian School follows the required safety drills for the state of Oregon. These drills will happen as scheduled with additional protocol for maintaining 6-ft distancing to the greatest extent possible.

- Safety drills at McMinnville Adventist Christian School take typically less than 10 minutes.
