<ul style="list-style-type: none"> <input type="checkbox"/> Establish a minimum of 35 square feet per person when determining room capacity. Calculate only with usable classroom space, understanding that desks and room set-up will require use of all space in the calculation. This also applies for professional development and staff gatherings. If implementing Learning Outside guidance, establish an outside learning space for learning that maintains minimum 35 square feet per person. <ul style="list-style-type: none"> • Within this design, educators should have their own minimum of 35 square feet and the design of the learning environment must allow for some ability for the educator to move through the room efficiently and carefully without breaking 6 feet of physical distance to the maximum extent feasible. <input type="checkbox"/> Support physical distancing in all daily activities and instruction, maintaining six feet between individuals to the maximum extent possible. <input type="checkbox"/> Minimize time standing in lines and take steps to ensure that six feet of distance between students is maintained, including marking spacing on floor, one-way traffic flow in constrained spaces, etc. <input type="checkbox"/> Schedule modifications to limit the number of students in the building or outside learning space (e.g., rotating groups by days or location, staggered schedules to avoid hallway crowding and gathering). <input type="checkbox"/> Plan for students who will need additional support in learning how to maintain physical distancing requirements. See attached.</p> <p>Classroom Set Up:</p> <ul style="list-style-type: none"> • Remove extra furniture to make more room • Remove fabric-covered furniture and classroom rugs • Assign seating to maximize physical distancing and minimize physical interaction <p>To support social distancing guidelines in all daily activities and instruction we will:</p> <ul style="list-style-type: none"> • Traffic-flow- A one-way flow of traffic will be established and marked with all common areas of the school with the expectation students and staff will be trained and follow the designated arrows for which direction to walk, 6' spacing for appropriate distancing whenever possible • Schedules- Students will stay in their classroom with their cohort group for most of the day. If a cohort group needs to transition to another part of the building or outside, a 5 minute passing time for their schedules and transitions. • Student instruction on distancing protocols- All staff will be trained on the appropriate health and safety ODE guidelines on social distancing. Teachers will be required to teach, practice, review and reteach the ODE guidelines in their classrooms on a regular basis. This will include appropriate protocols during arrival, dismissal, hallway transitions common areas, and recess. • PE and Recess will be provided daily for each classroom. Playground protocol will be taught for following physical distancing. Activities and games will be promoted in which they can maximize physical distancing. • Music class will be planned with non-wind instruments that are not shared. <p>Staff:</p> <ul style="list-style-type: none"> • Staff will maintain physical distancing during all staff meetings, professional development and conferences, or use remote web-based meetings.

1d. COHORTING

<ul style="list-style-type: none"> <input type="checkbox"/> Where feasible, establish stable cohorts: groups shall be no larger than can be accommodated by the space available to provide 35 square feet per person, including staff. <ul style="list-style-type: none"> • The smaller the cohort, the less risk of spreading disease. As cohort groups increase in size, the risk of spreading disease increases. <input type="checkbox"/> Students cannot be part of any single cohort, or part of multiple cohorts that exceed a total of 100 people within the educational week⁴, unless the school is offering Learning Outside, then they must follow guidelines for cohorting in Learning Outside guidance. Schools must plan to limit cohort sizes to allow for efficient contact-tracing and minimal risk for exposure. Cohorts may change week-to-week, but must be stable within the educational week. <input type="checkbox"/> Each school must have a system for daily logs to ensure contact tracing among the cohort (see section 1a of the Ready Schools, Safe Learners guidance). <input type="checkbox"/> Minimize interaction between students in different stable cohorts (e.g., access to restrooms, activities, common areas). Provide access to All Gender/Gender Neutral restrooms. <input type="checkbox"/> Cleaning and sanitizing surfaces (e.g., desks, dry erase boards, door handles, etc.) must be maintained between multiple student uses, even in the same cohort. <input type="checkbox"/> Design cohorts such that all students (including those protected under ADA and IDEA) maintain access to general education, grade-level academic content standards⁵, and peers. <input type="checkbox"/> Minimize the number of staff that interact with each cohort to the extent possible, staff who interact with multiple stable cohorts must wash/sanitize their hands between interactions with different stable cohorts. <input type="checkbox"/> Elementary staff who interact with multiple cohorts (music, PE, library, paraprofessionals who provide supervision at recesses, etc.) should have schedules altered to reduce the number of cohorts/students they interact within a week. Consider having these staff engage via technology, altering duties so that they are not in close contact with students in multiple cohorts, or adjust schedules to reduce contacts. 	<p>Preschool-PreK: Students will be assigned to a classroom with no more than 10 students which meets the ODE 35 sq. Feet distancing guidelines and will remain as a cohort throughout the day.</p> <p>McMinnville Adventist Christian school will have 4 cohorts: Kindergarten, 1/ 2, 3-5, and 6-8. Teachers will move to classrooms for Elective subjects. Students will, for the most part, stay in their assigned classroom.</p> <ul style="list-style-type: none"> • Kindergarten Cohort: Students will be assigned to a classroom with no more than 10 students which meets the ODE 35 sq. feet distancing guidelines and will remain as a cohort throughout the day. • 1/2nd Cohort: Students will be assigned to a classroom with no more than 20 students which meets the ODE 35 sq. feet distancing guidelines and will remain as a cohort throughout the day. • 3-5th Cohort: Students will be assigned to a classroom with no more than 18 students which meets the ODE 35 sq. feet distancing guidelines and will remain as a cohort throughout the day. • 6-8th Cohort: Students will be assigned to a classroom with no more than 20 students which meets the ODE 35 sq. feet distancing guidelines and will remain as a cohort throughout the day. <p>A daily log to ensure contact tracing which will be kept for a minimum of four weeks for each cohort.</p> <p>Stable Cohorts- For students to minimize interaction between cohort groups the following safety guidelines will be put into practice:</p> <ul style="list-style-type: none"> • Bathrooms will be cleaned between cohort scheduled uses. • All activities except for recess, PE and Music will be held in the students' classroom. • Students will eat lunch in their respective classrooms. • Students will be dropped off and sent to their cohort classrooms via the outside exit entry door. • A master recess schedule will be created to minimize interaction between different cohort groups. • Playground equipment will be cleaned between each cohort group. <p>Cleaning & Wiping Surfaces-The following CDC guidelines will consistently be following:</p> <ul style="list-style-type: none"> • All door handles, desks, counters, & materials will be cleaned and sanitized when different cohorts use the area and after transitions. • All door handles, desks, counters, supplies & materials will be cleaned and sanitized frequently within the same cohort. • <p>Students with Special Needs - Following the ODE guidelines, students with special needs will maintain access to general education.</p>

⁴ The cohort limit is focused on the students experience and their limit of 100 people includes every person they come into contact with, including staff. There is not a limitation for staff in cohort size while care should be given to design and attention to the additional requirements.

⁵ Academic content standards refer to all of Oregon state academic standards and the Oregon CTE skill sets.

1e. PUBLIC HEALTH COMMUNICATION AND TRAINING

1f. ENTRY AND SCREENING

OHA/ODE Requirements	Hybrid/Onsite Plan
<input type="checkbox"/> Direct students and staff to stay home if they have COVID-19 symptoms. COVID-19 symptoms are as follows: <ul style="list-style-type: none"> • Primary symptoms of concern: cough, fever (temperature of 100.4°F or higher) or chills, shortness of breath, difficulty breathing, or new loss of taste or smell. • Note that muscle pain, headache, sore throat, diarrhea, nausea, vomiting, new nasal congestion, and runny nose are also symptoms often associated with COVID-19. More information about COVID-19 symptoms is available from CDC. • In addition to COVID-19 symptoms, students must be excluded from school for signs of other infectious diseases, per existing school policy and protocols.
