



WAIVER, RELEASE, HOLD HARMLESS, AND AGREEMENT NOT TO SUE

I, _____ (FULL NAME), fully understand that this Agreement is governed by the laws of the State of California and is intended to be as broad and inclusive as is permitted by California law, and that in the event any portion of this Agreement is determined to be invalid or unenforceable for any reason, the balance of this Agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.

I fully acknowledge that a horse, pony or mule may, without warning or any apparent cause, buck, stumble, trip, roll, fall, rear, bite, kick, run, make unpredictable movements, spook, jump obstacles, step on a person’s feet push or shove a person; saddles or bridles may loosen or break – all of which may cause the rider to fall or be jolted resulting in serious injury or death. I further acknowledge that horseback riding and other equestrian activities are inherently dangerous activities and involve risks that may cause serious injury and in some cases, death, because of the unpredictable nature and irrational behavior of horses, regardless of their training and past performance. I voluntarily assume the risk and danger of injury or death inherent in the handling or riding of the horse, and use of saddles, bridles, equipment and equestrian gear.

I fully understand that my participation in riding a horse, including but not limited to training or selecting horses; maintenance, care, fit or adjusting of saddles or bridges; instruction on riding skills; leading and supervising riders; handling or riding a horse; and/or use of any facilities, saddles, bridles, equipment or gear whether personal property or provided (hereinafter "equestrian activity") exposes me to the risk of personal injury, death, communicable diseases, illnesses, viruses, or property damage. I hereby acknowledge that I am voluntarily participating in equestrian activity and agree to assume any such risks.

I hereby release, discharge and agree not to sue Pilmore Equestrian, LLC (Pilmore) the City of Lakewood (the “City”), Southern California Edison Company, and their officers, employees, and agents for any injury, death or damage to or loss of personal property arising out of, or in connection with, my participation in the equestrian activity from whatever cause, including the active or passive negligence of the Pilmore, and Southern California Edison Company, City or any other participants in the equestrian activity. The parties to this Agreement understand that this Agreement is not intended to release any party from any act or omission of “gross negligence,” as that term is used in applicable case law and/or statutory provisions.

In consideration for being permitted to participate in the equestrian activity, I hereby agree, for myself, my heirs, administrators, executors and assigns, that I shall indemnify and hold harmless Pilmore, Southern California Edison Company, the City and their officers, employees, and agents from any and all claims, demands actions or suits arising out of or in connection with my participation in the equestrian activity.

I understand and agree that equestrian activity may be recorded for viewing and/or listening by others during equestrian activity and at a future date. I consent to Pilmore’s use of audio and video recordings and photographs of me and/or my child(ren) for any purpose, including but not limited to news, advertising and promotional purposes, without compensation to me and/or my child(ren). I hereby release and hold harmless the Pilmore, Southern California Edison Company, City and their officers, employees, and agents from any claims relating to the use of me and/or my child(ren)'s likeness and image.

I HAVE CAREFULLY READ THIS WAIVER, RELEASE, HOLD HARMLESS AND AGREEMENT NOT TO SUE AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT IT IS A FULL RELEASE OF ALL LIABILITY AND SIGN IT OF MY OWN FREE WILL.
