Commonly Asked Questions

01. **DEPOSIT:**

After your consultation(\$30), Karina will send you an invoice for \$120. You have 48 hours to complete the deposit and contract form that will go with it. If you need more time, feel free to let us know!

02. **WHEN DO WE BOOK TRIALS?:**

2-3 months prior to the wedding. To gain inspiration, practice your dream look, and make any desired edits. For \$150 +travel fee, after this the bride's total is fully covered.

03. **FULL BRIDAL**

CANCELLATION:

A full refund is offered for those who cancel 5+ months prior to their wedding date.

04. **ON LOCATION REQUIREMENTS:**

Low-backrest chairs, spacious tables, outlets, natural lighting, a big mirror, and a workspace with reasonable conditions. Note: Hotels and some venues might not have requirements.

05. **LATE STARTS:**

We will accommodate for later starts, note it results in a later end time. We recommend everyone arriving together, or in two groups.

06. **IF SOMEONE DROPS OUT:**

If someone ops out of our services, we allow replacement members. If there is no replacement, the original total stays the same



07. **Timeline**

Your timeline can vary as the day goes by. We will help create a general list of who goes first, but we encourage our brides to allow the morning to flow naturally.

08. **OUTSTANDING BALANCE:**

Your balance will be sent 30 days prior to your wedding day. This is the party's remaining total. Due no later than 1 week before your wedding.

09. **CAN YOU WORK WITH MY HAIR TYPE?**

As a curly hair certified stylist, I'm blessed to be able to work with all textures and styles! I take pride in having the needed knowledge to work with any hair type that sits in my chair. Thick, thin, aged, young, curly, short or long braids, extensions - there isn't any hair I can't work with! It is important that your bridal party knows this so they can feel confident walking in the morning of.

Timeline

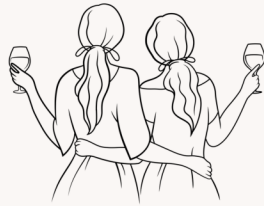
The morning of a wedding should be relaxing and stress-free. Although we do not provide a minute-by-minute timeline, we do have our recommended order below. We will create a list of a general order but encourage your team to arrive and be ready to get the day started! We will send you a time quote on how long our services will take from start to finish and an order once you have filled out our required contract. Whether you want us to start at 6 AM or 10 AM, we are the most flexible part of your wedding day. If you have a photographer coming for getting ready photos, it's best they come 1 hour and 15 minutes before you have to get into your dress. This is usually when I recommend you sit in the hair chair! No stress about keeping an eye on the clock; we will take care of that for you!

The Bride(s) will go second to last AFTER makeup is finished.
