O. Box 315, Moscow, PA, 18444 by June 30, 2019. This is the final date for receipt of vendor applications or for cancellation refunds.**

***If you own a business in the Borough of Moscow or reside in the Borough of Moscow, the full vendor rate is waived. However the \$15 non-refundable registration fee is required to reserve a space and to help defray general Fair expenses. To reserve a space, please submit your application and registration fee as soon as possible but no later than June 30, 2019.**
